<u>PLEASE NOTE</u>: A puppy must be entered in the appropriate Puppy Class to be eligible for the special rate on the entry fee. Dogs entered in Non-Regular Classes MUST also be entered in a Regular Class or for Exhibition Only. Any dogs wishing to compete in any of the Non-Regular classes offered at this Specialty MUST be entered in a Regular Class or for Exhibition Only.

Class descriptions noted on following page

DOG SHOW CLASS INFORMATION

<u>JUNIOR PUPPY CLASS</u> - This class shall be for any dog 6 months of age and under 9 months of age on the day of this Specialty

<u>SENIOR PUPPY CLASS</u> - This class shall be for any dog 9 months of age and under 12 months of age on the day of this Specialty

<u>12 to 18 Months Class</u> – This class shall be for dogs at least 12 mos. of age on the day of this Specialty and under 18 mos. on the day of this Specialty

<u>CANADIAN BRED CLASS</u> - This class shall be for any dog born in Canada. (Champions of any country excluded)

<u>BRED BY EXHIBITOR CLASS</u> - This class shall be for any dog owned and handled in the ring owner/breeder. The handler <u>MUST</u> be the owner/co-owner <u>AND</u> breeder/co-breeder of the dog. The owner/breeder must handle the dog at the class level, but need not handle the dog for further awards

OPEN CLASS - This class shall be for all dogs

<u>VETERANS CLASS</u> – Shall be for all dogs 7 years of age and over on the day of the Specialty. The winners of the Veteran Male and Female classes DO NOT compete for Championship points but go directly on to the Best of Breed competition. <u>NOTE</u>: SPAYED OR NEUTERED DOGS ARE ELIGIBLE FOR COMPETITION IN THIS CLASS

<u>SPECIALS ONLY CLASS</u> - This class shall be for Champions of record at the time of closing of entries for this Specialty. <u>Note</u>: A <u>Listed dog <u>MAY</u> be moved to the Specials Only Class after the closing of entries, provided the CKC Individual or Event Registration Number was received prior to the first day of the show. The request to move a class dog to the Specials Only Class <u>MUST</u> be received by the Show Secretary ONE HOUR PRIOR TO THE OPENING OF THE FIRST SHOW. Listing Fees <u>WILL NOT</u> be refunded</u>

NON-REGULAR CLASSES

EXHIBITION ONLY - All dogs entered in this class shall be listed in the catalogue with the same particulars as dogs entered in regular competition. Dogs entered in this class may not compete in any Regular class but may enter and compete in Non-Regular classes and/or Parades

ADDITIONAL NON-REGULAR/UNOFFICIAL SPECIALTY CLASSES

The following unofficial/non-regular classes will be offered at this Specialty:

<u>BRACE CLASS</u> - Shall be for two dogs (not necessarily of the same sex)
(Note: effective January 1, 2006 – identical ownership NO LONGER applies)

<u>SIRE & GET</u> - Shall comprise the Sire and two or more of his Get (Note: Get <u>MUST</u> be entered in a Regular class)

<u>DAM & PROGENY</u> - Shall have all the same requirements as the Sire & Get Class (Note: Progeny **MUST** be entered in a Regular class

<u>PARADE OF VETERANS</u> – This class shall be for those dogs that are 7 years of age and over

OBEDIENCE CLASSIFICATIONS

NO DOG MAY BE ENTERED IN BOTH NOVICE "A" & "B" AT SAME TRIAL NO DOG MAY BE ENTERED IN BOTH OPEN "A" & "B" AT SAME TRIAL

NOVICE "A" - This class is open to all dogs, providing the dog has not earned the title of "CD" in ANY COUNTRY. One dog ONLY may be entered in this class by any one exhibitor. The exhibitor MUST BE THE OWNER or A MEMBER OF HIS/HER IMMEDIATE FAMILY and MUST SHOW THE DOG IN ALL EXERCISES. No licensed handler, trainer or any person who has previously exhibited a dog through its "UD" title in Canada or Elsewhere shall be allowed to compete in this class, but MUST COMPETE IN NOVICE "B" CLASS NOVICE "B" - This class is open to all dogs, which have not earned the title of "CD", and may be shown by the owner or any other person. The dog may not necessarily be CKC or ERN Reg'd to compete in this class OPEN "A" - This class is open to all dogs which have earned the title of "CD" IN

<u>OPEN "A"</u> - This class is open to all dogs which have earned the title of "CD" IN CANADA, but have not earned the title of "CDX" in any country. **One dog** <u>ONLY</u> may be entered in this class by any one exhibitor. The exhibitor <u>MUST BE</u> THE OWNER or A <u>MEMBER OF HIS/HER IMMEDIATE FAMILY</u> and <u>MUST SHOW THE DOG IN ALL EXERCISES</u>. No licensed handler, trainer or any person who has previously exhibited a dog through its "UD" title in Canada or Elsewhere shall be allowed to compete, but <u>MUST COMPETE IN THE OPEN</u> "B" CLASS. A CKC or ERN Reg'd number must be provided on the entry form at time of closing of entries to be eligible to compete in this class

<u>OPEN "B"</u> - This class is open to all dogs, which have earned the title of "CD" in CANADA, and may be shown by the owner or any other person. This dog **MAY ALSO COMPETE IN THE UTILITY CLASS**. A CKC or ERN Reg'd number must be provided on the entry form at time of closing of entries to be eligible to compete in this class

<u>UTILITY CLASS 'A'</u>- This class is open to any dog of any recognized or listed breed which has earned the title of "CDX" but has not earned the title of U.D. Any person who has trained or exhibited a dog that has earned a M.O.T.Ch title may not handle dogs in this class. This dog must be shown by the owner or a member of their immediate families. A CKC or ERN Reg'd number must be provided on the entry form at time of closing of entries to be eligible to compete in this class. Owners may enter More than one dog in this class. The same person must handle the dog in all exercises. When a dog is wrongfully entered in this class, any score will be cancelled.

<u>UTILITY CLASS 'B'</u> - This class is open to any dog of any recognized or listed breed which has earned the title of "CDX" or U.D. Dogs in this class may be handled by the owner or any other person. A CKC or ERN Reg'd number must be provided on the entry form at time of closing of entries to be eligible to compete in this class. Owners may enter more than one dog in this class. The same person must handle the dog in all exercises. No dog may be entered in both the Utility A and Utility B classes at any one trial. Prior to the start of judging, the judge will decide the order of exercises to be performed. This order will not be disclosed to exhibitors until it is posted at ringside, approx. 30 mins. Prior to the start of the class.

OBEDIENCE CLASSES: Unofficial

Refer to Section 15 of the O.T.R.&R. The rules are paraphrased below. The following classes are offered at these Trials:

<u>VETERAN'S CLASS</u> - is open to dogs that have an obedience title and are 7 years and older. Dogs entered in this class must also be entered in any Regular class or for Exhibition Only.

<u>GRADUATE NOVICE CLASS</u> - This class is open to all dogs that have not gained a qualifying score toward the "CDX" title in Canada BUT that has obtained the title "CD" in Canada prior to the closing of entries.

<u>GRADUATE OPEN CLASS</u> - This class is open to all dogs that have not obtained a qualifying score toward the "UD title in Canada BUT which has obtained the title "CDX" in Canada prior to the closing of entries.

<u>VERSATILITY CLASS</u> - This class is open to all dogs that have attained the title of "CDX" in Canada and at least 1 leg on the Utility title, or that has obtained the "UD" title in Canada prior to the closing of entries.

<u>BRACE CLASS</u> - This class is open to any two dogs of the same breed and of either sex, which have attained not less than a "CD" title in Canada. The same person NEED NOT own both dogs.

TEAM CLASS - This class is open to any four dogs of the same breed and of either sex, which have attained not less than a "CD" title in Canada. The same person NEED NOT own all four dogs.

DOGS ENTERED IN THE VETERANS CLASS MUST ALSO BE ENTERED IN ANY OF THE REGULAR OBEDIENCE CLASSES.

<u>PLEASE NOTE</u>: The word 'trainer' means any person who conducts or has conducted a dog obedience training class or who regularly assists with the training of dogs in said class or who regularly trains dogs belonging to any person outside his/her immediate family

Transition Obedience Classes

PRE-NOVICE – This class shall be for all purebred dogs and those breeds as designated on the list of miscellaneous breeds and of either sex, which have not earned the title of P.C.D. (Pre-Companion Dog) in Canada. Dogs being entered in this class may be handled or exhibited by the owner or any other person. A person may enter more than one dog in this class and must have an additional handler for each dog when they are judged together on the Group exercise. A dog may be entered in the Pre-Novice that has not earned the title of C.D. in Canada or a comparable title in any other country. The Pre-Novice class is an elective class and earning a title is not a requirement to advance to the Novice Classes.

NOVICE "C" – This class is open to any dog of either sex that has gained the title Companion Dog, Companion Dog Excellent, Utility Dog or any other advanced Obedience title in Canada prior to the closing date of the trial in which it is to be entered. Exhibitors may enter more than one dog in this class but must have a separate handler for each dog in the Long Sit and the Long Down Exercises when they are judged in the same group. The Novice 'C' exercises will be performed and judged as described in the official Novice Class except that exhibitors may compete in the Novice 'C' Class indefinitely. Scores earned by dogs entered in the Novice 'C' Class are not eligible for High In Trial. The P.C.D. and C.D.I. and Novice 'C' are elective classes which are offered for those people who feel the dog requires ring experience and acclimation to the trial situation or would like to earn additional titles. Dogs may be entered in the Novice – Intermediate (C.D.I.) and/or Novice 'C' class in addition to any of the Official Classes or Unofficial Classes.

NOVICE INTERMEDIATE CLASS – This class shall be for all purebred dogs and those breeds as designated on the list of miscellaneous breeds and of either sex, which have earned the title of (C.D.) Companion Dog, Companion Dog Excellent, Utility Dog or any other advanced Obedience title in Canada. A dog eligible for entry in the Open A or B Class at any obedience trial held under these rules is also eligible for entry in the Novice 'C' and Novice Intermediate Class at the same trial. The Novice Intermediate class (C.D.I.) is an elective class and earning a title is not a requirement to advance to a Companion Dog Excellent title. Scores earned by dogs competing in this class are not eligible for High In Trial. Dogs are eligible to compete in this class indefinitely. Dogs in this class may be handled or exhibited by the owner or any other person. A person may enter more than one dog in this class.

JUNIOR HANDLING - JUDGE-----Ms Claire Boudreau

The Terrier need not be owned by the junior but it must be entered in the Specialty. Registration will be at the BCATC table with the Judging Schedule indicating times.

CLASSES: All offered. Fee \$2.

Prizes: Rosettes and Prizes will be awarded for Best Overall and First in each class, with flat ribbons offered for all remaining placements including PeeWees.

Due to the anticipated large entry, the club is reserving a portion of the building for pre-assigned grooming spaces. Those exhibitors who are LISTED as EITHER THE OWNER OR THE HANDLER/AGENT on 6 or more dogs, or who are co-ordinating a group of individuals setting up together, may request that an area be reserved for them. Once the allotted area has been filled, all further requests will be returned as will any requests received after the close of entries. Requests will be acknowledged via email after the closing date and prior to the beginning of the show.

Please note: Exercise pens <u>may</u> be restricted to 1 pen per 3 <u>entered</u> dogs, depending on the size of the entry.

In addition to the pre-assigned areas, there will also be regular first come, first served grooming space in which equipment/dogs may be left for the duration of the shows. Ex-pens are permitted in this area.

There will also be an area that will be set aside for Day of Show grooming - this will be first come, first served and all equipment MUST BE REMOVED after Best in Show each night. There will be NO exercise pens allowed in this area.

Any equipment left after Best In Show will be removed by the club or one of it's delegates.

Grooming areas will be monitored by the club and delegated individuals - and exhibitors who do not keep their areas clean, or abuse the space allotted may be asked to leave the show.

- 3. THE SHOW COMMITTEE WILL USE DUE CARE AND DILIGENCE FOR THE WELFARE OF DOGS AND EXHIBITORS, BUT WILL NOT BE RESPONSIBLE FOR, OR ASSUME ANY LIABILITY IN THE EVENT OF ACCIDENT OR MISFORTUNE TO EITHER DOGS, EXHIBITORS, SPECTATORS OR VENDORS.
- 4. DOGS MUST BE ON THE GROUNDS 1-HOUR PRIOR TO THE JUDGING OF THEIR BREED.
- 5. THE OWNER OF A DOG ENTERED IN THESE SHOWS IS ENTIRELY RESPONSIBLE FOR ANY ERROR IN ENTERING HIS/HER DOG REGARDLESS OF HOW OR BY WHOM ENTRY IS MADE
- 6. EXHIBITORS AND HANDLERS WILL BE RESPONSIBLE FOR THEIR DOGS AND EQUIPMENT LEFT AT THE SHOW GROUNDS.
- 7. DOGS TO BE EXERCISED IN DESIGNATED AREAS ONLY, NOT IN VICINITY OF RINGS
- 8. ALL RECREATIONAL UNITS WILL HAVE BUCKETS UNDERNEATH FOR THEIR SINK DRAINS. ANYONE FOUND DISCHARGING WATER ON THE GROUNDS WILL BE REMOVED BY ORDER OF THE HEALTH DEPARTMENT, AND MAY BE SUBJECT TO A FINE.
- 9. IF, BECAUSE OF CIVIL DISTURBANCE OR OTHER ACTS BEYOND THE CONTROL OF THE CLUB, IT IS IMPOSSIBLE TO OPEN OR COMPLETE THE SHOW, NO REFUND OF ENTRY.

 10. DOGS MUST BE ON LEASH AT ALL TIMES ON THE SHOW GROUNDS OR WITHIN THE SHOW BUILDING WITH THE EXCEPTION OF THE OBEDIENCE RINGS.

ALL EXHIBITORS, HANDLERS AND PATRONS ARE EXPECTED TO KNOW AND ABIDE BY THE CKC DOG SHOW RULES

CHAMPIONS AND CHAMPIONSHIP POINTS

SECTION #1. A dog awarded WINNERS at a Championship show held under these Dog Show Rules shall be credited with a number of championship points (ranging from 0 to 5), and the determination of the number of championship points to be credited to a dog awarded WINNERS shall be as provided hereunder.

SECTION #2. The schedule to be employed in the determination of the number of points to be allocated a dog awarded WINNERS shall be as follows;

DOGS COMPETING*	1	2	3 to 5	6 to 9	10 to 12	13 or more
POINTS AWARDED	0	1	2	3	4	5

*includes the dog awarded Winners

To determine the number of points earned by a dog awarded Winners, total all dogs in competition which were defeated, directly or indirectly, for the highest of the following official breed awards: Winners, Best of Winners, Best of Breed or Best Opposite Sex and then consult the schedule set forth above.

A class dog awarded Best in Show at an all-breed Championship show will be credited with 5 points inclusive of any points earned at the breed or group level. In counting the number of eligible dogs in competition, a dog that is disqualified or that is dismissed, excused or ordered from the ring by the judge, SHALL NOT be included in the calculation for championship points (Absentees are not to be included). In order for a dog to be recognized as a Canadian Champion it must: (1) earn at least ten championship points under at least three different judges; (2) a two point win awarded either at the breed or group level; and (3) be individually registered in the records of the CKC or have a CKC Event Registration Number (ERN)

AGREEMENT

I (we) acknowledge that I (we), all exhibitors, handlers and patrons, know and abide by the "CKC Dog Show Rules", and that I am (we are) familiar with their content. I (we) agree that the Club holding this show has the right to refuse this entry for cause, which the Club shall deem to be sufficient. In consideration of the acceptance of this entry and of the holding of the Show and of the opportunity to have the dog judged and to win prize money, ribbons or trophies. I (we) agree to hold the Auld Lang Syne Dog Association or the Renaissance Dog Association, their members, directors, governors, officers, agents, superintendents or show secretary and the owner or lessor of the premises and any employees of the aforementioned parties, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of a dog while in or upon the show premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim, and I (we) further agree to hold the aforementioned parties harmless from any claim for loss of a dog by disappearance, theft, death or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, theft. damage or injury be caused or alleged to be caused by the negligence of the Club or any of the parties aforementioned, or by the negligence of any other person, or any other cause or causes.

I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this show, howsoever such injuries, death or damage to property may be caused and whether or not the same may have been caused and whether or not the same may have alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other person.
