A LISTING FEE must accompany the entry when a dog is eligible for, but does not possess a CKC individual Registration number or an Event Registration Number (ERN) or Performance Event Number (PEN) or for Foreign born Miniature Dachshunds under one year of age. Exhibitors, through submission of entry, acknowledge that they are knowledgeable of and will comply with the CKC Agility Rules and Regulations. At the option of the handler, a dog may wear either a well-fitting plain buckle collar, a quick-release collar, or no collar. Fancy collars, choke collars, pinch collars, or other training collars are prohibited. Collars which are too tight or so large that they hang down unreasonable in front of the dog are not permitted. There shall be nothing hanging from the collar Food and toys are not permitted in the course area and handlers are not permitted to use whistles or other training devices in the ring or within 10 feet of the course.

Entry Requirements:

Listing fee

Every dog entered in a CKC approved Agility Trial must be purebred and must be registered with the CKC, or have an **Event Registration** #, a **Performance Event Number** #, **Miscellaneous Certification** # or be eligible for Registration with the CKC, or have a CKC miscellaneous Class Certification Number.

The dog must be at least 18 months of age, may be spayed or neutered. The dog may not be lame or compete if it has tape or bandages.

A dog can only be entered once in any one class at a trial.

All dogs that are foreign born and foreign owned and enter Canada for the sole purpose of entering CKC events do NOT require a CKC registration number but will require an Event Registration Number (ERN).

Performance Event Numbers:

Cheques or Money order payment only. Sorry, WCOBC can **NOT** accept credit card entries. **NO entry will be accepted without payment in full**. Tendering of a N.S.F. cheque in payment of entry fees is considered non-payment of entry fees and is an offense punishable by disciplinary action and cancellation of awards. **All N.S.F. cheques will be assessed a \$25.00 service charge**.

CLASSES: NOTE: NEW CLASS

There are 3 classes, Regular and Selected, and Veteran.

Each of these has a Standard Class and jumpers with Weaves (JWW) at the following levels: Regular - Novice A and B, Intermediate, Excellent A and B. Selected - Novice, Intermediate, Excellent A and B

Selected Class information:

The selected class will be the same as in the regular class but will have adjusted height and course times will have 10% more time added.

The owner may choose to enter the Selected Class in lieu of entering the Regular Class at any trial. The dog must be entered only in Selected Class or Regular Classes at the same set of trials. (a dog may move back and forth between the Selected Classes and the Regular Classes, but not at the same set of trials offered by a club on the same day or on consecutive days.)

NOTE: Regardless of the previous level your dog competed in, if they move to SELECTED they must enter into NOVICE.

Veteran Class Information

At the option of the handler, a dog 7 years or older may be entered in the Veterans Class. The dog cannot revert back to Regular or Selected classes. The dog will retain titles and qualifying scores towards titles accumulated. All veterans will complete as if running n the selected class at one or two jump heights lower than regular with 10% additional time as allocated in the Selected class...

The above classes are divided by Height.

Agility Novice A: For persons and dogs that have never acquired an agility title in any country or organization.

Agility Novice B: For agility instructors and judges, and for dogs that have acquired the Agility Novice Title, but have not earned a qualifying score in Agility Intermediate; and for persons who have previously exhibited a dog to an agility title in any agility organization.

Agility Intermediate: Is open to dogs that have acquired the Agility Novice title, and to those dogs which have acquired the Agility Intermediate title but have not yet acquired a qualifying score towards the Agility Excellent Title.

Agility Excellent A: For dogs that have acquired the Agility Intermediate title, but have not yet earned the Agility Excellent title.

Agility Excellent B: For dogs that have acquired the Agility Excellent title or the Agility Master Excellent title.

Events Offered

Standard – and Jumpers with weaves –

For clarification on the requirements of these events please refer to your rule book

Equipment and course familiarization:

- Upon <u>previous arrangement</u>, There will be equipment familiarization on Saturday morning for Novice dogs only and on Sunday morning for Novice dogs entered in trials 3 and 4 only.
- A warm up area with a single practice jump will be provided for dogs entered in the trials.
- Handlers in all classes are permitted to walk the course, without a dog, prior to the start of the class

Height Divisions – owners are responsible for entering the correct height divisions. The judge may require any dog to be measured.

Selected and Veteran course times:

10% will be added to the standard times.

All courses have clearly designated start and finish lines with all obstacles/jumps clearly and sequentially numbered. The course layout for each class will be posted in an easily accessible area at least ½ hour before the start of the class.

NOTE: SAME DAY MOVE UPS WILL BE ALLOWED

Moving Up: A dog that has received 3 qualifying scores from at least 2 different judges, may be transferred to the next level provided that request is received at least <u>one hour prior</u> to the commencement of the trial.

Moving Dogs Up: See event secretary for official form.

Close of Entries – Sept 20 2010. Please do not send an entry that requires our trial secretary to travel to the post office to sign for receipt as this does not ensure that your entry will be received on time. No entries will be accepted by the Show Secretary after closing time and date. There are no refunds on overpayment.

Confirmations will be emailed after closing date.

Show Catalogues and a timetable will be emailed to all exhibitors after closing date.

List of Awards and Prizes:

- Ribbons will be provided for 1st 4th in each class and jump height.
- Qualifying ribbons will be awarded for all dogs receiving a qualifying score in each agility trial.

A Qualifying score is 85 points or more out of a possible 100 points, with no non-qualifying deductions except Excellent B where a perfect run is required.

- This is a qualifying trial for whippets gathering credits toward the 2010 Versatility Whippet of the Year award.

NOTE: There is a New Rule book dated January 2010. It is the responsibility of the exhibitor to be familiar with the rules pertaining to the event in which they are competing. Agility Rules and Regulations Books are available for \$6.00 plus GST from the CKC.

Trial precincts:

The precincts of the trial are all areas reserved for the sole use of the WCOBC. Only Dogs entered in official classes are permitted within the precincts of the trial.

Agility Rules and Regulations: (Chapter 4- Section 1.3 t)

It shall be the duty and obligation of the trial giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities of any kind. The Agility Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred

Foreign Exhibitors

Entry Payment: Please note that fees are due and payable in Canadian dollars.

Due to consistently fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted; however, they are to be payable in Canadian Funds. If you send a cheque in US funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please do not mark cheque, "payable in Canadian Funds" or "at par". They will not be cleared by the banks. To simplify the process, we urge that you purchase banks drafts for money orders payable in Canadian funds. Your understanding and cooperation is appreciated. Thank you.

Withdrawal of entries:

Anyone wishing to withdraw an entry prior to the closing date MUST receive confirmation from the trial secretary that their withdrawal has been accepted.

General Information:

1. Bitches in Season are not permitted to compete. Entry fees will be refunded when a bitch comes into season after their entry has been submitted to the Trial Secretary, when a Veterinarian's certificate, certifying the bitch was in season within the 10 day period preceding the trial.

- 2. Judging schedules, directions to site and receipts will be sent by email or by the post office to exhibitors after the closing date.
- 4. Before each trial the judges will provide a course design which will be posted before judging begins

The owner of a dog entered in this show is entirely responsible for any errors in the entering of the dog, regardless of how, or by whom the entry was made.
