Entry Fees (Cdn or U.S.): **TD** or **UTD** test: \$75.00; **TDX** or **UTDX** test: \$85.00

A Listing Fee of \$9.60 Cdn or U.S. must accompany the entry of a dog for which a CKC individual registration number, or Event Registration Number (ERN), is not shown on the entry form. The registration number must be applied for within 30 days of the first day of entry in a CKC event.

- A dog eligible for a PEN number must have their PEN number prior to entering the test, and may not enter as a Listed dog.
- U.S. Exhibitors: We accept U.S. cheques or U.S. bank Money orders in U.S. funds. Please do not mark U.S. cheques "Payable in Canadian Funds" as the bank will not accept them.
- An NSF cheque will be subject to a \$25.00 service charge. The Entry fee plus NSF service charge must be paid in cash prior to competing.
- Faxed, emailed, drop-box or hand-delivered entries will NOT be accepted.

All-Breed Field & Urban Tracking Tests: June 6 & 7th, 2015: General Information

NOTE: **SATURDAY** is our primary day for Field tracks, and SUNDAY the primary day for Urban tracks. We may be able to schedule additional Urban tracks on Saturday, and/or Field on Sunday, if locations & judge capacity allow, so you are welcome to enter the additional day in case we have room! Exhibitors may enter Field and Urban tests in the same test (test day) providing the dog meets the prerequisites for the test levels entered. ** If you have any questions please contact Karen (Chair), and I'll be happy to help! **

ELIGIBILITY:

- Certification is not required to enter a Canadian TD test
- A CKC TD title is a prerequisite for entering either a CKC UTD test or TDX test.
- A Listing Fee as established by the CKC must accompany the entry of a dog for which a CKC individual registration number or Event Registration Number (ERN) is not shown on the entry form.
- Canadian entrants who are not CKC Members: An annual Non-Member Participation Fee for awards and titles
 will be charged for dogs wholly owned by a non-CKC member. This fee is not applicable to CKC members or
 dogs co-owned by CKC members. Non-CKC member participants must either purchase a CKC membership or
 pay the Non-Member Participation Fee (currently \$59.40 + HST) within 30 days of notification, or awards and
 titles will be cancelled by the CKC.

CONFIRMATION, ALTERNATE LIST, and REFUNDS:

- Entries will close once the trial limit has been reached, even if the closing date has not arrived.

 Additional entries will be assigned a position on an 'Alternate List' in the order received. The Test

 Secretary will notify all entrants of their acceptance into the trial or their position on the Alternate List.
- If an entered dog is withdrawn after the closing date, a refund will be given if the vacancy is accepted by an Alternate. Alternates will be contacted in Catalogue order and may accept or decline. Remaining Alternates as of test day are encouraged to attend the draw in case there is a withdrawal or no-show of a confirmed entrant.

BITCHES IN SEASON:

• Bitches in season will be permitted to compete, but will be assigned the last track. Please advise the Test Secretary immediately upon arrival at the meeting place, or earlier if possible.

MEETING PLACE & DRAW FOR TRACK ORDER:

The Draws will be held at Tim Horton's at the corner of Oliver Road and Golf Links Rd.

Sun, June 7th: 8:30 am Draw for all Tests to be run Sunday**

Any primary entrant(s) who is absent at the assigned draw time will forfeit his/her position if there are alternates present. Please be sure to arrive on time for your draw.

- * **SATURDAY DRAW:** If the Field schedule necessitates a revision to the Saturday Urban draw time, all Saturday Urban entrants will be advised at least 24 hrs in advance (in accordance with rule 6.11.1). In any case, the Saturday Urban draw time will not be earlier than 12:00 noon. Note that Saturday Urban tracks will be very limited in number due to site availability and judge resources.
- ** SUNDAY DRAW: If there are any field tracks on Sunday they will be run before the Urban tracks.

AWARDS & LUNCHEON:

- Each passing team will be awarded a Rosette and Medallion from TBK&TC, after completion of the days tests. Bring your camera for a photo with the judge!
- Please join us after the test on Sunday, for a get-together and meal at the Valhalla Inn restaurant.

<u>DISCIPLINE</u>: <u>RULE 14.7</u> The test-giving club has the duty and obligation to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities of any kind. The Club shall promptly report to the CKC any infringement of this regulation.
