While this isn't an event where dogs are participating, some people don't have the option of leaving their dogs home. If you need to bring your dogs with you there are a few options. QUIET dogs can be crated in cars with appropriate shading. (shade clothes and tents) As well, there is a covered (shaded) porch area that is suitable for ex-pens and QUIET dogs. Or, your VERY QUIET dogs can be crated in the hall. PLEASE NOTE: If this is what you are planning to do, you MUST be there early to set up to avoid disturbing the seminar. PLEASE ALSO NOTE this option is for dogs that are used to spending time in cars, ex-pens or crates. *Isla will not be working with your dog as her presentation is a lecture only.* Building will be open for set up at 8:15.

Lunch: There are restaurants 5 mins away in the town of Ladner. Or you can pack your own. We will provide snacks and coffee/tea/water.

Parking:

Car pooling, if possible, is encouraged! There is a small gravel lot beside the hall. We will have a parking guide to help direct you so that we can get as many cars in the lot as possible. Others may park on the street. But please remember this is a residential neighbourhood and to be respectful to the community. There is no charge for parking.
