Clothing: Camo or dark clothing. White jackets for blinds in WCX for blinds.

Pigeons or ducks on land and ducks in water will be used in all tests. Standard CKC Rossettes will be awarded to all passing dogs.

Headquarters: The Headquarters will be at the "Causeway" enter Christie Lake Conservation Area and go down the road to the stop sign. Turn right and keep on that road to the test area.

Food: Supper will be available for purchase at the test site area between land and water tests.

Gate Fee: Exhibitors will have to pay \$9.00 on entering the park.
