I (we) certify and represent that the dog entered is not a hazard to persons or other dogs. This entry is submitted for acceptance on the foregoing representation and General Agreement/Disclaimer. I (we) agree to conduct myself (ourselves) in accordance with such Official Rules and Regulations (including all provisions applying to discipline) and to abide by any decisions made in accordance with them.
3. In consideration of the acceptance of this entry, the holding of the class and/or the opportunity to have this dog participate, I/We agree as follows:
4. i) while at or in proximity to this class, to freely assume all risk of loss(including death) or damage or injury, collectively called "Loss", to myself, this dog or any dog under my control, and to members of my family and my guests, and to our property;

I/We expressly assume all responsibility and liability for all such claims; and
7. iv) that all indemnities herein shall be full and complete indemnities, including legal costs on a solicitor and client basis.
8. I/We, the undersigned, agree that Chinook Dog Centre has the right to refuse this entry for any reasons which the organizing committee deems sufficient. I/We further agree to volunteer to provide assistance to the class in the form specified by the organizing committee.
