The Test is held under the pointing breeds Field Trial and Field Dog Test Rules and Regulations, effective January 1, 2017, of the Canadian Kennel Club, Suite 400-200 Robson Drive, Etobicoke, Ontario, M9W 5Z9

“RULES OF ELIGIBILITY for the Wing to Ring VIPDC Specialty Show for Pointing breeds held in conjunction with the Nanaimo Kennel Club Shows June 16th, 2018 A dog must be entered in and participate in at least one of VIPDC’s two Field Dog Tests (event #181509/ #181510) June 14th and 15th, 2018 in order to be eligible to enter the VIPDC Conformation Specialty Show (event #181132) June 16th, 2018. Dogs must complete the full allotted time on the field, or be endorsed by the Wing to Ring judge if the full allotted time is not complete. These Tests are open to dogs not entered in the Specialty Show. Priority will be given to dogs entered in the Specialty Show.

GENERAL INFORMATION

- All stakes are walking stakes. Horses are neither required by handlers nor allowed. Blank pistols, .22 cal minimum will be fired over all dogs with bird work. No live ammunition will be allowed in any stake. Pistols must have solid barrels
- Total entries will be limited to the number of dogs that can be run in the available daylight hours
- The Club reserves the right to rearrange the running order of the stakes should conditions warrant.
- Collaring a dog away after game contact will be allowed.
- Bitches in season will be permitted to run, at the end of the day. **Entrants must notify event secretary prior to start of said stake, or run will be forfeited.**
- Backing Tests: If a dog has placed in one of the senior stakes of the Test and needs only a backing test to complete the requirements for a Championship, the owner may request a backing test. This test will be allowed at the discretion of the Field Test Chairman and will depend on the availability of birds. The test will cost \$20.00
- Tracking Collars: Approved electronic collars may be used. Any questions regarding their use should be referred to the Field Test Chairman
- All participants must be familiar with the CKC Rules and also the rules and provisions of this Premium List. CKC Field Test rulebooks are available from the CKC or on-line at the CKC website for CKC members.
- **It shall be the duty and obligation of the Test-giving Club to see that a judge, club official, volunteer or competitor at a Field Test is not subject to indignities. The Field Test Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on the receipt of a report indicating that this has occurred.**
- The Vancouver Island Pointing Dog Club is committed to providing an environment free of discrimination and harassment, where all individuals are treated with respect. Members and participants are expected to be respectful at all times. Harassment, discrimination, physical and verbal assault by anyone will not be tolerated, condoned, or ignored within our membership or at any event sponsored or hosted by the Vancouver Island Pointing Dog Club. Any such claims will be reviewed by the Board. If a claim of harassment or discrimination is determined, disciplinary measures will be applied, up to and including termination of membership, or suspension from participation in future events for a length of time as determined by the Board.

PRIZES: Standard CKC rosettes will be awarded to the placing dogs in all Field tests, as appropriate.

LISTING FEE: A listing fee of \$10.50 as established by the Canadian Kennel Club must accompany the entry of a dog for which a Canadian Kennel Club individual registration number or Event Registration Number (ERN), Performance Event Number (PEN) is not shown on the entry form. This listing fee is per dog per each event entered during the Field Test and is in addition to the entry fee(s).

All entries are accepted on the condition that the Vancouver Island Pointing Dog Club, its officers, directors, membership and landowners assume no responsibility for participants or spectators in the event of injury or damage to persons, animals, or properties in conjunction with or during the running of the Field Test. All minors shall be under the direct care and supervision of the parent or guardian.

BORDER CROSSING: A rabies certificate is required to bring a dog into or out of Canada and the rabies certificate must be dated at least 30 days prior to crossing the border.

EFFECTIVE JANUARY 1, 2011 Non-member participation fee

a) An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. The fee will match the ERN fee.

b) In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled.

c) These fees apply only to dogs wholly owned by non-CKC members and are not applicable to CKC members."

There will be no exercising or training of any dogs on the Test grounds before, during or after the Test without the explicit permission from the Field Test Chairman.

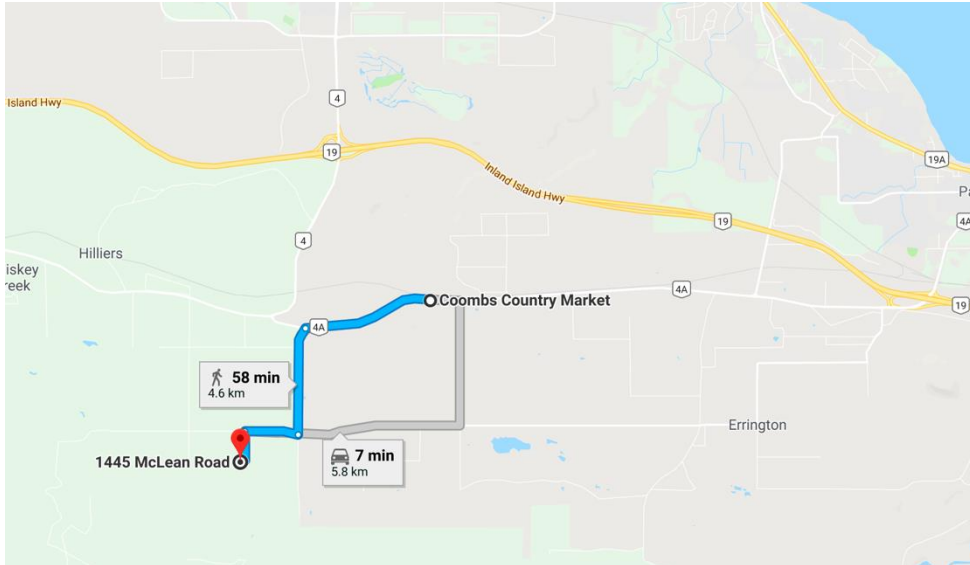
