DOGS: Dogs must be under control at all times. This is a fully public venue so please keep barking to a minimum, pick up after your dogs promptly and note that your dog **MUST** be on leash when not crated or in the search areas. Any handler displaying inhumane or aggressive treatment to any dog, the public or other handlers (physically or verbally) will be asked to leave the premises without refund.

All dogs must be on a flat collar or harness in the search area. Leashes must be cloth or leather of any length in the search area.

Competitors, through the submission of their entries, acknowledge that they know the Rules and Regulations. **SEE MASTER RULE**

DIRECTIONS:

West from Toronto to Paris – Take Hwy 403 (Hamilton/Brantford - Go thru Hamilton/Brantford -- Exit: Hwy #24 Paris/ Simcoe (Rest Acres Rd). turn to the right on ramp towards Paris , at set of lights (Hwy #2) turn left (Cemetery directly in front of you), follow until you see sign for Bishopsgate Rd. on left (turn left) 4th driveway on left Pet-D-Gree sign out front (#670 Bishopsgate Rd. Paris, On).

To enter this trial :please complete the attached entry form, making sure that you include the SDDA registration number appointed to your dog(s), and mail it to:

Separate entry forms MUST be completed for EACH dog entered, however, payment may be combined.

Note: Handler/Dog Teams may enter one or all components.

All three (3) components (Container, Interior, Vehicle) must be successfully completed (qualifying scores earned) to earn the SD-S title: it is not necessary to complete all three on the same day, however.

The honorific SP (Special) will be added to the title of any dog who does complete the three components on the same day, at the same trial.
