- The trial's organizing committee reserves the right to refuse any entry and is in full charge of the trial. This trial is being held under the Canadian Association of Rally Obedience (CARO) Rules and Regulations. Exhibitors, acknowledge that they are knowledgeable of these Regulations.
- No provision will be made for inclement weather.
- Move-ups are permitted.
- This test is open to all dogs being at least 6 months of age, including purebred and non-purebred, except bitches in season, injury or illness that may affect the dog's physical or mental performance or dogs exhibiting signs of aggression towards people or other dogs.
- Before they compete, all dogs must be registered with CARO and have a valid CARO Dog Identification Card. Dogs without a CARO ID number will not receive credit for any legs earned.
- There will be no refunds for entries withdrawn after the closing date, except for injured dogs or bitches that come into season with a Veterinarian's note prior to the Trial.
- No Refunds once the Trial has commenced.
- The rings are 72' X 50 fully enclosed by portable fencing with an Entry and Exit opening. Footing is compacted dirt.
- All dogs with a qualifying score will be awarded a qualifying rosette. As well, first to third place ribbons will be awarded in each division. Titling Rosettes are available for all Novice, Advanced, Excellent, Versatility, Versatility Excellent. It is up to the competitor to notify Paus-n-Train if they have earned a Championship Title(s) and arrangements will be made for the competitor to receive the Rosette at a future date.

#### Bring your own lunch or closest food vendors are 7 minutes away.

Venue offers 50' X 50' off leash play area beside the little barn with 1 km hiking trail through wooded area on property. Crating space available inside "the little barn" with rubber matted floors.

ALL DOGS MUST BE ON LEASH AT ALL TIMES UNLESS COMPETING IN THE RING. DOGS MUST BE UNDER CONTROL AT ALL TIMES, EACH PERSON IS RESPONSIBLE TO ENSURE THEIR DOG IS BEHAVING CORRECTLY, if not your dog will be asked to leave the venue. You must clean up after your dog, if found not to, future entries will be refused. Please Note: No chokes, prongs or electric shock collars are permitted on Paus-n-Train property.

I (we) certify and represent that the dog entered is not a hazard to persons or other dogs. This entry is submitted for acceptance on the foregoing representation and General Agreement/Disclaimer. I (we) agree to conduct myself (ourselves) in accordance with such Official Rules and Regulations (including all provisions applying to discipline) and to abide by any decisions made in accordance with them. I (we) agree that the club holding this event (Paus-n-Train Agility & Obedience) has the right to refuse this entry for any reason which the organizing committee deems sufficient.
