RACE HOUND ELIGIBILITY

- **OPEN** to: Afghan Hounds, Azawakhs, Basenjis, Greyhounds and Whippets.
- Unless exempted (see page 7) all Hounds must be **CERTIFIED** prior to their first official Race Meet.
- Hounds must be one year of age or older on the day of the official race.
- All hounds must be individually registered with the CKC, AKC, FCI or any other National registry or possess a CKC PEN number.
- All hounds must be registered with AGSA. Every dog not registered must submit a one time payment of \$2.00 along with a photocopy of it's Kennel Club registration papers or PEN number and certification form with your entry.

ENTRY FEES

- **EARLY ENTRIES CLOSE THURSDAY AUGUST 17, 2017 at 6:00 pm - FIRM**
- **Entry fee: \$20.00** per dog.
- **LATE ENTRY \$30.00 per dog closes August 19, at 6:00 pm - FIRM**
- **Singles, Duos, Puppies are \$10.00 and they run after the 1st and 2nd program** and they need to be pre-entered and paid for by Aug 17, (**Limited to 6 entries**)

INSPECTION AND ROLL CALL

- **Roll Call is at 10:30 am (FIRM)**
- **You can arrive as early as 9:30 am**
- **Dogs not present at ROLL CALL will be scratched and entry fee not refunded.**

THE SITE

- The race is held 10 min. from Okotoks, AB
- The Field is park-like grass with no rocks or holes.
- **PLEASE**, drive **slowly** in and out of the driveway (**15km/h**)
- Port-A-Potty on Site.
- The lure is always drag line.

ADDITIONAL INFORMATION

- **All Hounds must wear muzzles and proper race Blankets.**
- Whippet size race blankets will be available on site.
- Participants **must provide** their own **muzzles**.
- 3 programs means that hounds will run three times unless scratched, dismissed, or disqualified.
- Races will be a maximum of 4 dogs.
- Whippets, Greyhounds and Basenjis are **BOX** started, other Breeds may be hand slipped
- Bring your own shade and water.
- There is no concession, please come prepared with food and refreshment.
- No Camping on site, day time set up only.
- All dogs on site must be under control. No loose dogs.
- **Please**, pick up after your dogs and yourselves \$10.00 fine for not picking up.
- Containers with black bags are for recyclables and white bags for garbage.
- Females in season and lame hounds will have their entry fee refunded provided notice is given prior to or during Roll Call. A veterinarian certificate may be requested.
- Entries will be refunded or kept for the next race meet (your decision) if we have to cancel the meet due to weather or other unforeseen circumstances.
- A brief handlers meeting **will** be held at Roll Call.
- Anyone exhibiting unsportsmanlike conduct will be asked to leave the race site.

1. Follow Directions. I agree to observe and obey the AGSA Rule Book and all posted rules and warnings, and further agree to follow the oral instructions given by the Officials and Volunteers of AGSA.

2. Assumptions of The Risks And Release. I recognize that there are certain inherent risks for both myself, my family and my Hound(s) with straight racing. I assume full responsibility for personal injury to myself, my family members and my Hounds and release AGSA for any injury, loss, or damage out of our use or presence upon the facilities whether caused by the fault of myself, my family, my Hound(s) or other third parties, their family, or Hound(s) even if caused by alleged negligence. A Hound is exempt from certification if it meets any of the following criteria:
(You must include proof with your entry except previous certified CARA dogs)

- Hounds previously certified at AGSA prior to 2016
- ORC – Race Champion (NOTRA) or higher title
- GazeHound Race Champion (LGRA)
- SR – Straight Racer (NAWRA)
- TRP – (CWA) or higher

* DIRECTIONS TO RACE SITE *

Come into Okotoks, go past STAPLES and turn right which is Big Rock Trail. Drive up that curvy road to the stop sign on top of the Hill. Proceed across Hwy # 7 to the next stop sign which is 434th Ave. and turn right. Then, at the next road turn left which is 24th Street West. Drive for about a mile the acreage is on the left, you will see a chain link fence around the property and a white 3 rail fence up front with a white entrance gate.
