

DIRECTIONS TO TRIAL SITE:

Westbound on Hwy #1

Take exit #160 that says "Laidlaw, Hunter Creek, Rest Area", go under the freeway to the second stop sign and turn right. You are now running parallel with the freeway heading towards Chilliwack. Go about 4 km, turn left at McKay Rd.

Eastbound on Hwy #1

Take exit #153 that says "Jones Lake, Laidlaw". The exit veers to the right. You are parallel with the freeway, still heading towards Hope. Go about 2 km, turn right on McKay Rd.

Using GPS:

Input address: 58428 McKay Road - tell your GPS to search all cities in BC - if it offers you Fraser Valley - choose that. The Garmin did not find it in Hope, or in Laidlaw - but found it in Fraser Valley, British Columbia!

DOGS MUST ACHIEVE A QUALIFYING SCORE TO BE ELIGIBLE FOR PRIZES

A Suitable Prize and/or Rosette will be awarded to the following

High in Trial (each trial)
Reserve High in Trial (each trial)
High Belgian Shepherd (each day, both trials on Saturday)
High Australian Cattle Dog (each day, both trials on Sunday)
High Shetland Sheepdog (each day, both trials on Monday)
Highest Scoring Dog with a Conformation Championship (Monday donated by Longhaul Kennels)

"The Pepsi Trophy for Stockmanship" will be awarded to the dog/handler team showing good stockmanship throughout each day (not necessarily with a qualifying score. This is a perpetual trophy donated by Anne Gunn.

Section 18.1 of the CKC Herding Rules states:

"The CKC shall not be responsible to any member, person, partnership, club or corporation for any loss, damage or injury arising at or by reason of any herding trial held under any rules adopted by the CKC."

Section 15.7 of the CKC Herding Rules states:

"It shall be the duty and obligation of the trial-giving club to see that a judge, club official, ring steward volunteer or competitor at a Herding Trial held under these regulations, is not subject to indignities of any kind. The Herding Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred."
Rule books are available through the CKC office.

Please Note: There have been many changes to the CKC Herding Rules that took effect January 1, 2015. Please ensure that you review a current Rule Book so that you are aware of requirements for all levels.
