Crating will be in your vehicle, or there will be room to set up shade tents.

Bitches in season may not compete in C-WAGS games, but are welcome to in K9 ABC Games and the CGN test. They will run last and need to be wearing appropriate pants.

Dogs must be on leash at all times except as designated for competition. Do not allow dogs to bark at/harass neighboring livestock or other dogs.. Please only potty your dogs in designated areas.

No refunds for entries in the event a dog and/or handler are dismissed from competition, regardless of reason for such dismissal.

The trial's organizing committee reserves the right to refuse any entry for any reason.
