

It shall be the duty and obligation of the club holding the show to see that this rule is effectively carried out.

#### IMPORTANT NOTICE TO OBEDIENCE EXHIBITORS

There is no limitation on the number of trials at which a dog may be entered as a 'listed dog', except that a dog which has obtained three qualifying scores at obedience trials held under C.K.C. rules, may not continue to compete at licensed obedience trials held under the Club's rules until the dog is registered individually with the C.K.C. Foreign born and owned dogs, please refer to Event Registration Number (ERN) information listed elsewhere.

A dog which has won a comparable degree in any foreign country is not eligible for entry in the Novice A class but may be entered in the Novice B class if it has not earned its C.D. degree in Canada. A dog which has won its C.D. degree in Bermuda or the U.S. or has won a comparable degree in a foreign country, may be entered in the Novice B class if it has not earned its C.D. degree in Canada.

A dog which has won its C.D.X. degree in Bermuda or the U.S. or has won a comparable degree in any foreign country, is not eligible for entry in the Open A class but may be entered in the Open B class.

#### **NOVICE A CLASS:**

One dog only may be entered in this class by any one exhibitor.

#### **OPEN A CLASS:**

One dog only may be entered in this class by any one exhibitor.

#### NOTE

A dog entered in either of these classes must be handled in the ring by the owner or a member of his/her immediate family.

Dogs in obedience must wear a well-fitted plain buckle or slip collar. Slip collars of any appropriate single length of leather, fabric or chain with two rings, one at each end, are acceptable. There shall be nothing hanging from the collar.

## BITCHES IN SEASON

Bitches in season are not permitted to compete. When a bitch comes into season after entries close, a Veterinarian's certificate, certifying that the bitch was in season within ten days preceding the trial, must reach the Trial Secretary on or before the day of the trial, prior to the judging of the class; and the club will refund entry fees.

#### EVENT REGISTRATION NUMBER (ERN)

Effective Jan. 1/92, all dogs that are foreign born and foreign owned and enter Canada for the sole purpose of entering CKC events will no longer require a CKC registration number but will require an Event Registration Number (ERN).

The ERN number MUST be applied for within 30 days of the first day of entering a CKC event. Fee is \$56.70 per dog until December 31, 2010 and \$57.60 per dog after January 1, 2011 plus applicable taxes.

## Conformation Judges' Biographies

#### Dr. Göran Bodegård (Sweden)

Got my first show dog when I was 12 - a deerhound bitch - born 1952; spent summers in England as a kennel hand and learnt the British dog know-how. Bred some deerhound litters but since 1966 bred /cobred nine generations of greyhounds which have become influential world wide. Judging dogs since 1966 and since mid-nineties as an FCI allrounder ( all groups and BIS). I have judged in all parts of the world – for instance FCI World shows, Crufts, Australian Royal Shows, Eurasia (Russia), Tokyo FCI Int., AKC Eukanuba Invitational, Contest of Champions England, St. Barbara, Lower Mainland Ca a s o

Member of the Central committee of the Swedish KC, member of the KC. Entrusted with the project of repairing and guarding health and soundness in the exaggerated purebred dog breeds. Chairman of the standard committee

Paediatrician, child psychiatrist and psychoanalyst – working mostly with severely traumatised refugee children.

#### Mrs. Cheryl Myers-Egerton (Canada)

I was born in 1944, educated in New Brunswick and raised on a dairy cattle farm, our family bred Holstein cattle. My Father was the first dairy farmer in our province to produce cattle by Artificial Insemination.

I have had basenjis since 1967 and Scottish deerhounds since 1988. I have exhibited in Canada and USA and owner handled the first BIS Basenji in Canada in 15 years. I belong to the Basenji Club of America, Basenji Breeders Club of Northern England and Basenji Club of America. My registered kennel name is Conamore. Perm Reg'd. I am a life member of the Canadian Kennel Club and have played a very active role in the dog world. I also have been on Anti Breed Specific Banning Legislation and have addressed our Provincial Government to stop Breed Specific banning and introduce Responsible Dog Ownership.

I also have been placed on the A1 list from the Basenji Breeders of Northern England and the Kennel Club. My first purebred dog was in 1965 was a Samoyed, but have always been involved with animals. Breeder of top ranking Basenjis since 1968 and winner of Basenji Club of America National Specialty, Baltimore, MD in 1989. I had some of the top ranking Canadian Dogs in the 60's, 70's and 80's.

In 1999 I was elected to the Canadian Kennel Club Board of Directors. I served as Chair of Legislation Committee, and Chair of Lure Coursing and Beagle Councils. I also served as a working member on the Events Officiating Committee for Judges Education and did several presentations for Advanced Judges Conferences. I also served on Breeder Relations and was part of the committee to develop Breeder Education Programs.

I also was instrumental in re-organizing the Basenji Club of Canada, which now has a strong membership and holds national specialties every year throughout Canada. I also am an active member of the Atlantic Regional Conformation Judges Groups which consists of judges in New Brunswick, Nova Scotia, Prince Edward Island and Newfoundland.

Graduated from New Brunswick Institute of Technology and have taken Business Education and Education Degree Courses at the University of New Brunswick. I worked at an Administrator Office with the Board of School Trustees for 18 years and after retirement was a substitute teacher for Elementary School. Presently I am a Home Heath Support Worker for Service for Seniors of New Brunswick. Currently I am a member of Fredericton Kennel Club and New Brunswick Kennel Club.

#### Mrs. Gloria Geringer (United States)

My life in purebred dogs began in 1963 with parti color American Cocker Spaniels with my first dog coming from the Maribeau Kennels near my home in Detroit Michigan. I finished many championships under that prefix before breeding under the prefix of Lancer Kennels. Besides Cockers, in the 70's I began breeding and showing Pointers to American and Canadian championships. I then spent many years as an AKC licensed handler before applying to judge in 1988. Section 15.1.2 The schedule to be employed in the determination of the number of points to be allocated a dog awarded WINNERS shall be as follows:

In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge SHALL be included in the calculation for championship points.

To determine the number of championship points earned by a dog awarded Winners, total all the dogs in competition which the dog defeated, directly or indirectly, for the highest of the following official breed awards: Winners, Best of Winners, Best of Breed, or Best of Opposite Sex and then consult the schedule set forth above.

Section 15.1.8 A Dog awarded Winners which also places in the regular Group competition shall be credited with the following additional points, provided that a dog was defeated at the group level, save that no more than five (5) points will be credited to a dog for a single show.

Section 15.1.11 A class dog awarded Best in Show at an all-breed Championship show will be credited with five points inclusive of any points earned at the breed or group level.

Section 15.1.12. In order for a dog to be recognized as a Champion and its owner provided with a Championship Certificate, the dog must have earned at least one 2 point win either at the breed or group level.

MOVING CLASS DOGS TO SPECIALS Chapter 8, Section 8.9 of the Conformation Show Rules and Regulations has been amended to allow a dog which is individually registered in the records of the Canadian Kennel Club, and has completed the requirements for a Championship, after the Closing Date for entries for a show, may be transferred from one of the Regular Classes to "Specials Only", providing the request for a transfer is submitted to the Show Secretary in WRITING at least one hour prior to the opening of the show, by the owner or handler. Every day of a 2 or 3 day show is a separate show. Please note that this rule is effective up to one hour prior to the opening of the show, NOT one hour prior to the judging of the breed.

#### Class Structure (Age Requirements)

#### 1. PEE WEE

4 years of age up to 6 years of age as of December 31st of the year preceding the competition year. Optional and noncompetitive. No placements are to be awarded, participant ribbons, rosettes and token trophies may be presented.

#### 2A. JUNIOR NOVICE

For handlers 7 to 10 years of age as of December 31st of the year preceding the competition year, who have not won six first places in the same class with competition.

#### 2B. JUNIOR OPEN

For handlers 7 to 10 years of age as of December 31st of the year preceding the competition year, who have won six first places with competition in the Junior Novice Class, OR any handler wishing to enter this level. It is understood that once that handler has entered and competed in the Open Class, he/she may not compete in the Novice Class again.

#### 3A. INTERMEDIATE NOVICE CLASS

For handlers 11 to 14 years of age as of December 31st of the year preceding the competition year, who have not won six first places in the same class with competition.

#### **3B. INTERMEDIATE OPEN CLASS**

For handlers 11 to 14 years of age as of December 31st of the year preceding the competition year, who have won six first places in the same class with competition.

#### **4A. SENIOR NOVICE CLASS**

For handlers 15 years of age as of December 31st of the year preceding the competition year and up to 18 years of age, who have not won six first places in the same class with competition. Handlers from the Intermediate levels progress to this class.

#### 4B. SENIOR OPEN CLASS

For handlers 15 years of age as of December 31st of the year preceding the competition year and up to 18 years of age, who have won six first places with competition in the Senior Novice Class and for any handler who has progressed through the Intermediate Open level and feels that he/she has enough experience to compete at this level.

#### 5. BEST OVERALL

All dogs must be entered in one of the Official Classes or Exhibition Only on the day of the competition. Entry to be made at the show.

Best Overall Junior Handler will receive a \$1000.00 Education Bursary, donated by Purina.

Several years later we purchased another Golden from a breeder who competed in Retriever Field Trials. I became involved in this sport, volunteering and training my dog which led to becoming a Field Trial judge.

In the meantime I continued training and competing in Obedience Trials. In 2001 I started judging Obedience Trials. When Rally Obedience started in Canada, I judged one of the first trials in Alberta. Currently, I am working another Golden towards Rally Excellent and Utility titles.

We bred our Goldens under "Kylesobutte" kennel name. Occasionally, I go to Senior's Lodges with my dogs to entertain the residents
