GENERAL RULES GOVERNING THESE SHOWS AND TRIALS

1. THE CLUB RESERVES THE RIGHT TO REMOVE ANY PERSON FROM THE SHOW. THE SHOW SUPERINTENDENT SHALL HAVE FULL CONTROL OF THE SHOWS AND TRIALS WHICH WILL BE GOVERNED BY CKC RULES
2. ANY DOG EXCUSSED BY THE SHOW SUPERINTENDENT OR THE SHOW VETERINARIAN FOR ANY REASON SHALL NOT AFTER BEING EXCUSSED BECAUSE OF BEING IN SEASON SHALL NOT BE ALLOWED TO COMPETE IN ANY CLASS FOR ANY AWARD
3. THE SHOW COMMITTEE WILL USE DUE CARE AND DILIGENCE FOR THE WELFARE OF DOGS AND EXHIBITORS BUT WILL NOT BE RESPONSIBLE FOR OR ASSUME ANY LIABILITY IN THE EVENT OF ACCIDENT OR OTHER MISFORTUNE, TO EITHER DOGS, EXHIBITORS OR PATRONS.
4. EXHIBITORS ARE SOLELY RESPONSIBLE FOR THE CONDUCT OR ACTIONS OF THEIR ANIMALS WHILE THEY ARE ON THE SHOW GROUNDS.
5. DOGS MUST BE ON THE GROUNDS ONE HOUR BEFORE THE JUDGING OF THEIR BREEDS AND MAY BE REMOVED WHEN NOT REQUIRED FOR FURTHER JUDGING.
6. DOGS MUST BE READY FOR JUDGING. THE CLUB WILL NOT BE RESPONSIBLE FOR AND IS NOT OBLIGATED TO PROVIDE ANY SERVICE FOR NOTIFYING OWNERS OR AGENTS OF BREED OR CLASS JUDGING. NO RING SHALL BE HELD UP WAITING FOR EXHIBITORS OR HANDLERS. EXHIBITORS AND HANDLERS WITH MORE THAN ONE DOG SHALL HAVE SUBSTITUTE HANDLERS AVAILABLE SO THAT JUDGING WILL NOT BE DELAYED.
7. EXHIBITORS AND HANDLERS WILL BE RESPONSIBLE FOR THEIR DOGS AND FOR THE EQUIPMENT LEFT AT THE SHOW GROUNDS.
8. FOR THE BENEFIT OF THE HEALTH OF ANIMALS AND THE PLEASURE OF THE EXHIBITORS AND THE SPECTATORS WE INSIST UPON KEEPING OUR GROUNDS AS CLEAN AS POSSIBLE. EXHIBITORS ARE RESPONSIBLE FOR CLEANING UP AFTER THEIR DOGS. PLEASE EXERCISE YOUR DOG BEFORE TAKING INTO THE JUDGING RING. DOGS ARE TO BE EXERCISED IN THE DESIGNATED AREAS ONLY. NOT IN THE VICINITY OF THE RING AREAS.
9. THE WASHROOMS AND SHOWER FACILITIES ARE STRICTLY FOR HUMAN USE BY ORDER OF THE HEALTH DEPARTMENT. OFFENDERS WILL BE REMOVED FROM THE GROUNDS FOR THE DURATION OF THE SHOWS.

INTERMEDIATE NOVICE CLASS: THIS CLASS IS FOR HANDLERS 11 TO 14 YEARS OF AGE AS OF DECEMBER 31ST OF THE YEAR PRECEDING THE COMPETITION YEAR, WHO HAVE NOT WON 6 FIRST PLACES IN THE SAME CLASS WITH COMPETITION.

INTERMEDIATE OPEN CLASS: THIS CLASS IS FOR HANDLERS 11 TO 14 YEARS OF AGE AS OF DECEMBER 31ST OF THE YEAR PRECEDING THE COMPETITION YEAR, WHO HAVE WON 6 FIRST PLACES IN THE SAME CLASS WITH COMPETITION AND FOR ANY HANDLER WHO HAS PROGRESSED THROUGH THE JUNIOR OPEN LEVEL AND FEELS THAT HE HAS ENOUGH EXPERIENCE TO COMPLETE AT THIS LEVEL.

SENIOR NOVICE CLASS: THIS CLASS IS FOR HANDLERS 15 YEAR OF AGE AS OF DECEMBER 31ST OF THE YEAR PRECEDING THE COMPETITION YEAR AND UP TO 18 YEARS OF AGE, WHO HAVE NOT WON 6 FIRST PLACES WITH COMPETITION IN THIS CLASS. HANDLERS FROM THE INTERMEDIATE LEVELS PROGRESS TO THIS CLASS.

SENIOR OPEN CLASS: THIS CLASS IS FOR HANDLERS 15 YEAR OF AGE AS OF DECEMBER 31ST OF THE YEAR PRECEDING THE COMPETITION YEAR AND UP TO 18 YEARS OF AGE, WHO HAVE WON 6 FIRST PLACES WITH COMPETITION IN THE SENIOR NOVICE CLASS AND FOR ANY HANDLER WHO HAS PROGRESSED THROUGH THE INTERMEDIATE OPEN LEVEL AND FEELS THAT HE HAS ENOUGH EXPERIENCE TO COMPETE AT THIS LEVEL.

PLEASE NOTE: CKC RULE - "ONCE ENTERED IN A "LIMITED SHOW" AN ENTRY MAY NOT BE PULLED AT ANY TIME"

1. TENDERING OF POST DATED CHEQUES IS CONSIDERED NON-PAYMENT OF ENTRY FEE.

THE AUTHORITIES OF ANY SHOW MAY:

A. DECLINE TO ACCEPT ENTRIES FOR JUST CAUSE AND/OR

2. NO ENTRY FEES WILL BE REFUNDED IF THE SHOW CANNOT OPEN OR BE COMPLETED BY REASONS OF RIOTS, CIVIL DISTURBANCES, FOR AN ACT OF GOD, PUBLIC EMERGENCY, ACT OF PUBLIC ENEMY, STRIKES OR ANY OTHER CAUSE BEYOND THE CONTROL OF THE CLUB.

ATTENTION FOREIGN EXHIBITORS: PLEASE NOTE THAT FEES ARE DUE AND PAYABLE IN CANADIAN DOLLARS. DUE TO CONSISTENTLY FLUCTUATING CURRENCY RATES, DISCOUNTED CHEQUES WILL NOT BE ACCEPTED, PERSONAL CHEQUES WILL BE ACCEPTED IF YOU ARE USING A PERSONAL AMERICAN CHEQUE, IT MUST BE MADE OUT FOR THE FULL AMOUNT OF THE ENTRY AND NO EXCHANGE WILL BE REFUNDED TO THE EXHIBITOR....DO NOT WRITE PAYABLE IN "CANADIAN FUNDS" OR "AT PAR", THIS IS NOT ACCEPTABLE AND WILL NOT BE CLEARED BY THE BANK. TO SIMPLIFY THE PROCESS, WE URGE YOU TO PURCHASE BANK DRAFTS OR MONEY ORDERS PAYABLE IN CANADIAN FUNDS. THANK YOU.

EXTRACTS FROM CKC DOG SHOW RULES

CHAPTER 6.3.3 – JUDGES

A judge officiating at a show held under these rules shall not be subjected to any indignities of any kind during the progress of the show, and it shall be the duty and obligation of the club holding the show to see this rule is effectively enforced.

CHAPTER 13 – ENTRIES AND ENTRY FEES

Section 2.1

Every dog entered in Championship Shows held under these rules must be registered, have an Event Registration Number, eligible for registration with the CKC or have a CKC Miscellaneous Class Certification number issued by the CKC Chief Registrar. If a dog is not registered individually in the CKC it may be entered at a show, held under these rules, as a "listed" dog, provided

- (a) It is not a Miscellaneous breed
- (b) If born in Canada, is eligible for individual registration
- (c) If foreign born and owned, an Event Registration Number or CKC registration number is obtained from the CKC within 30 days of the first show entered. A listing fee of \$8.48 must accompany the entry of a "listed" dog at a show held under these rules.

Section 7.2:

DISHONORED CHEQUES

Tendering of a dishonored cheque or credit card in payment of entry fees shall be considered non-payment of entry fees and is an offense punishable by disciplinary action and cancellation of awards. Clubs may refuse to accept entries from any exhibitors who have been known to tender dishonored cheques in payment of entry fees unless such entries are accompanied by a money order or certified cheque.

CHAPTER 16 – DISQUALIFICATION

Section 1.4

A dog once disqualified for any reason at a Championship show held under these rules cannot again be shown or entered at a show held under these rules unless and until said dog has been reinstated by the CKC. All awards earned by a dog shown in violation of this section will be canceled by the CKC and the owner of said dog is subject to disciplinary action. Note: for any further information on reinstatement refer to Chapter 16, Section 3 of the CKC Dog Show Rules.

CHAPTER 18 – EXHIBITORS AND THEIR DOGS

A show giving club will be held responsible during the show for the conduct of exhibitors and spectators. Any person acting in an abusive or objectionable manner must be removed from the show on complaint to the Show Superintendent.

PLEASE KEEP THE SHOW GROUNDS CLEAN – PLEASE CLEAN UP AFTER YOUR DOG.

SECTION #1. A dog awarded WINNERS at a Championship show held under these Dog Show Rules shall be credited with a number of championship points (ranging from 0 to 5), and the determination of the number of championship points to be credited to a dog awarded WINNERS shall be as provided hereunder.

SECTION #2. The schedule to be employed in the determination of the number of points to be allocated a dog awarded WINNERS shall be as follows:

DOGS COMPETEING*	1	2	3 to 5	6 to 9	10 to 12	13 or more
POINTS AWARDED	0	1	2	3	4	5

*includes the dog awarded Winners

IF THE DOG AWARDED WINNERS IS ALSO BEST OF WINNERS, BEST OF OPPOSITE SEX OR BEST OF BREED, THE NUMBER OF CHAMPIONSHIP POINTS WILL DEPEND ON THE TOTAL NUMBER OF DOGS DEFEATED DIRECTLY OR INDIRECTLY FOR THE AWARD.

IN ADDITION TO CHAMPIONSHIP POINTS ALLOCATED AT THE BREED LEVEL, A DOG AWARDED WINNERS WHICH ALSO PLACES IN THE REGULAR GROUP COMPETITION SHALL BE CREDITED WITH THE FOLLOWING ADDITIONAL POINTS, PROVIDED THAT THE DOG HAS DEFEATED ANOTHER DOG AT THE GROUP LEVEL, SAVE THAT NOT MORE THAN 5 POINTS WILL BE CREDITED TO A DOG FOR A SINGLE SHOW.

A CLASS DOG WHICH ALSO PLACES BEST IN SHOW AT AN ALL BREED CHAMPIONSHIP SHOW SHALL BE CREDITED WITH 5 CHAMPIONSHIP POINTS INCLUSIVE OF ANY POINTS EARNED AT THE BREED AND GROUP LEVEL IN COUNTING THE NUMBER OF ELIGIBLE DOGS IN COMPETITION, DOGS THAT HAVE BEEN EXCUSED, DISQUALIFIED, DISMISSED FROM THE RING BY THE JUDGE, SHALL BE INCLUDED IN CALCULATION

(ABSENTEES ARE NOT COUNTED) **TO EARN A CANADIAN CHAMPIONSHIP, A DOG MUST EARN AT LEAST TEN CHAMPIONSHIP POINTS UNDER AT LEAST THREE DIFFERENT JUDGES, AND BE INDIVIDUALLY REGISTERED WITH THE CANADIAN KENNEL CLUB, OR HAVE A CKC EVENT REGISTRATION NUMBER (ERN) AND HAVE ONE 2-POINT WIN FROM THE BREED OR GROUP LEVEL.**
