Eligibility: To be eligible to compete in an Rally Obedience trial, the dog must be registered with the CKC, be eligible for registration with the CKC, have an ERN, or have a CKC Miscellaneous Certificate number or a Canine Companion number. A dog may be spayed, neutered or debarked.

Bitches in Season are not permitted to compete. The judge of a Rally obedience trial must remove from competition any bitch in season, or any bitch which appears so attractive to males as to be a disturbing element. When a bitch comes into season after entry of the bitch has been submitted to the Trial Secretary and a Veterinarian's certificate that the bitch was in season within the ten day period preceding the trial, the Trial giving club will refund entry, service charges and listing fees.

Rally Novice A - Dogs entered in this class may not have won a CKC Rally Novice (RN) title or any CKC Obedience title other than P.C.D. No handler who has exhibited a dog through its CKC C.D.X. title shall be eligible to enter this class. The handler of any dog in this class must be the owner, co-owner, or member of their immediate family. A person may enter more than one dog in this class. No dog may be entered in both Rally Novice A and Rally Novice B at any one trial. All exercises are judged on leash and dogs must enter and leave the ring on leash.

Rally Novice B - Any dog may compete in this class until a qualifying score in the Rally Advanced class has been earned. The owner or any person may handle dogs in this class. All exercises are judged on leash and dogs must enter and leave the ring on leash. A person may enter more than one dog in this class.

Rally Intermediate Class

The Rally Intermediate class is an elective class and earning the title is not a requirement to enter Rally Advanced Classes. This class shall be for dogs that have earned the R.N. title. A dog competing the R.I. or any other obedience or rally titles may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class.

Rally Advanced A - This class is for dogs that have won the Rally Novice (RN) title but have not won the Rally Advanced (RA) title or any CKC Novice Obedience title. The handler of any dog in this class must be the owner, co-owner or member of their immediate family. All exercises are judged off leash and dogs must enter and leave ring on leash. A person may enter more than one dog in this class.

Rally Advanced B - This class shall be for dogs that have won the Rally Novice (RN) title. Upon completing the Rally Advanced (RA) title a dog may continue to compete in this class indefinitely. The owner or any person may handle dogs in this class. All exercises are judged off leash and dogs must enter and leave the ring on leash. A person may enter more than one dog in this class.

Rally Excellent A - This class shall be for dogs that have won the Rally Advanced (RA) title, but have not won the Rally Excellent (RE) title or any CKC Novice Obedience title. A dog may not be entered or exhibited in this class after official notification from the CKC that the dog has won the title (RE). No dog may be entered in both Rally Excellent A & B at any one trial. The handler of any dog in this class must be the owner, coowner or member of their immediate family. All exercises are judge off leash and the dog must enter and leave the ring on leash. A person may enter more than one dog in this class.

Rally Excellent B - This class shall be for dogs that have won the Rally Advanced (RA) title. A dog may compete in this class indefinitely. Any person is allowed to handle a dog in this class. All exercises are judged off leash and dogs must enter and leave the ring on leash. A person may enter more than one dog in this class.

Rally Obedience Rules & Regulations

Chapter 20.7: It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities of any kind. The Rally Obedience Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit, on receipt of a report indicating that this has occurred.
