#### Entry

We will accept entries only via regular mail. No courier, emailed, faxed or hand delivered entries will be accepted.

ONLY ONE ENTRY PER ENVELOPE Only one entry per event for each dog will be accepted. Entrants will be notified by email or phone when their entry has been received by the Test Secretary.

Following Rule 2.2.5 – option #2 a random drawing of all entries received by the closing date and time will take place to determine entry in the test or placement on an alternative list. Entrants and Alternatives will be notified of their positions as soon as possible following the draw.

#### **Payments**

#### **Meeting Place and Draw**

Any primary entrant(s) who is/are absent at the assigned time will forfeit their position to the first available Alternate(s) present.

<u>Awards and No-Host luncheon</u> A memento will be awarded to all successful competitors by the judge. A No-Host luncheon will be held after the test.

Manure Please note the possibility exists that manure may be on fields

**Refunds** Withdrawn entries after closing date will only be refunded where there is an "Alternate" available who chooses to fill that assigned entrant's vacancy on test day. Alternates will be contacted in catalogue order and advised of the opening. They may choose to accept the spot and become responsible for the entry fee or decline and bear no financial obligation. Anyone on the "Alternate List" may request a refund at any time prior to test day. Entries will be refunded within 10 days of the test date to those on the alternate list that did not participate in the test.
