Online entries are available; please email entries to the Secretary. Payment for online entries must be paid by PayPal, with a \$1 surcharge per entry to cover PayPal fees, or by e-transfer with no surcharge.

GENERAL INFORMATION

We are offering UKC lure coursing and weight pull at the same location and will be co-coordinating all events - this may result in slight delays between events (depending on entry numbers) to ensure that outdoor Nosework elements will NOT be held when the coursing is going on, as the Nosework areas are within sight of the coursing field. Your patience and understanding are appreciated.

General rules and judging procedures will be explained at the handler's meeting, please be sure to attend.

Nosework areas will be posted, and out of general view. You may watch the proceedings AFTER you have had your turn. Please obey all posted signs.

You may not share or discuss the location of the hide until the element has been fully judged – anyone violating this rule may be subject to disciplinary action and could forfeit their qualifying scores.

Dogs must be at least 6 months old on the day of the trial.

You may have rewards (food, toys) with you in the working areas of the trial.

Exhibitors may only handle one dog in each element. If an exhibitor enters more than one dog, each dog must have it's own handler.

Dogs that have passed their Odor Recognition Test (ORT) from the National Association of Canine Scent Work (NACSW) are not required to earn a Pre-trial Nosework title for the odor/odors they have passed in NACSW. Proof of Odor Recognition Tests from the NACSW must be included with the entry form when entering any trial prior to receiving your first title with United Nosework.

Each Element is divided into A and B classes

A classes are for exhibitors that have not earned the title for the class they are entered, and own the dog they are exhibiting.

B classes are for all others, including judges, trainers, etc.

PT classes are not divided.

You MUST pass the PT for the level that you want to trial in (it can be done on the same day). PT tests are pass/fail, and one qualifying leg earns the title (PT1, PT2, etc. PT is always offered first in a trial. You may earn the PT in multiple levels on the same day.

Each Element (Container, Interior, Exterior, Vehicle) requires two qualifying scores in order to earn the Element title at each level (Novice, Advanced, Superior).

When you have earned all 4 Element titles, you have earned the UN1 (or the level you are working on).

Trials may be either Element trials, or UN1 Trials (all elements in one trial). We are offering Element trials, but are offering all 4 Elements over two weekends.

Beginning Jan1, 2015, Nosework will become a UKC sport. For 2014, UNA titles may be added to your UKC registration papers.
