Requests for changes to entries must be made to the trial manager (Cassie Young) in email or writing by October 10, 2017.

Refund Policy

Entries are eligible for refund upon written request to the trial manager no later than October 10, 2017. After October 10, 2017, entries are only eligible for refund upon written request, accompanied by a statement from your veterinarian, for bitches in heat or dogs withdrawing for medical reasons. Dogs/handlers dismissed from trial for any reason will not receive a refund.

Awards

Ribbons will be awarded for all qualifiers and titles.

Concessions

Bryan's Table is next door and will be open to purchase coffee, lunch and special treats on Saturday and Sunday. There is also a Starbucks and McDonald's a few blocks away.

For the Safety and Comfort of all

Dogs must be on leash at all times unless in the ring. Dogs MUST enter and exit the ring on leash, even if being carried.

- Avoid dog-on-dog meet and greets, even if your dog is "friendly" or the dogs know each other.
- Dogs must be kept in their vehicle in between searches and potty breaks.
- All dog waste must be picked up immediately and discarded in dumpsters. Do not allow dogs to eliminate in the parking lot, or on/near the buildings.
- Each handler is responsible for keeping their dogs quiet and under control at all times.

C-WAGS Notice to Exhibitors

Competitors, through submission of entry, acknowledge that they are knowledgeable of CWAGS rules and regulations including, but not limited to, the following rules regarding entry:

- All exhibitors are expected to treat the judges, trial hosts, your canine partner and all other exhibitors with respect.
- This trial is open to all dogs registered with C-WAGS. Trial Hosts may elect to accept FOR EXHIBITION ONLY entries of non-registered dogs.
- Collars: The dog must wear a flat type collar (buckle, snap or properly fitted martingale) and/or body harness in the ring. Electronic training collars, choke chains and prong collars are not allowed on the premises.
- Safety shall always be of foremost consideration in actions and conduct by handlers at all times. Handlers, through entry at this event, accept full responsibility for themselves and the actions of their dogs.

In addition,

- The organizing committee may refuse any entry for any reason.
- THERE SHALL BE NO REFUND for entries in the event a dog and/or handler are dismissed from competition, regardless of reason for such dismissal.
- Returned cheques do not constitute a valid entry. There will be a \$55.00 service charge for returned cheques. Payment of entry fees and service charges shall be made by cash or money order within 7 days of notice to exhibitor of returned cheque. Any fees not received within 7 days of notice will result in cancellation of event results for all classes for the registration number(s) of delinquent entry/entries. No reinstatement of results is possible.
- Competitors may videotape portions of this event for their *personal use only*. No portion of this event may be videotaped for commercial or other purposes.
