CKC Non-Member Participation Fee......if you don't belong to the CKC you need to know about this!

Policy:

Non-member participation fee

- a) An annual fee for awards and titles will be charged to a Canadian non-member of CKC.
 The fee will match the ERN fee.
- b) In order to protect the awards/titles earned, the non-member will have the option to become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in all awards and titles being cancelled.
- c) All Premium Lists will carry a note stating the fees apply only to dogs wholly owned by non members and is not applicable to CKC members.

Information:

- > A non member resident in Canada is subject to the fee. Dogs co-owned with a CKC member are exempt.
- > There are 2 options for non-members:
 - a) Join the CKC
 - b) Pay the Non-Member Participation Fee
- > Dogs co-owned by two or more individuals; the first person listed in the CKC dog records will be considered the caregiver of the dog and all communication will be sent to this person.
- > The fee is a yearly charge based on the calendar year January 01 to December 31 in which the awards, legs, points, titles, etc were achieved. It is not based on the number of dogs or titles or awards earned, and is assessed against the owner(s).
- Non members will receive a letter from CKC Head Office informing them that they have 30 days to join the Club or pay the Non-Member Participation Fee.
- Payment of the Non-Member Participation Fee or becoming a CKC member will protect all awards, points, titles and legs in the calendar year in which they were earned.
- > Failure to pay the fee within 30 days of the notice will result in all awards, legs, points, titles being cancelled. Once cancelled the awards, legs, points or titles will be given to the next applicable dog.
- Once cancellation takes place, any subsequent awards, titles, legs etc earned will automatically be cancelled without further notice.
- > The Non-Member Participation Fee is applicable starting at the first event in which the dog earns awards, points, titles, legs and is not prorated.

*Please note that the CKC Membership Application and the Non-Member Participation Fee forms are available on the website under CKC Services and then Forms On-line. If submitting a Membership Application, please ensure that you also complete the Non-Member Participation Fee form so that we are aware of the dogs involved.

Special Breeder Award – The Alberta Kennel Club is pleased to offer a special award recognizing the breeder of purebred dogs. A green rosette will be awarded to the breeder of the dog placing First in Group, Best Puppy in Group each day, and the breeder of the winner of Best in Show and the breeder of Best Puppy in Show each day.

The person handling the exhibit in the ring shall be recognized as the agent of the owner of the dog. Delivery of any prize won to the handler of the winning dog shall constitute full delivery of the prize to the rightful owner. All prizes are to be claimed at the show – No prizes will be mailed.

| Veterans Class | For dogs who are 7 yrs of age or over as of the date of the show. These dogs will compete for regular placement and the first place dog will go on to compete for Best of Breed. | Rocky Mountain High | The High in Trial winners from July 29th & 30th will return to the ring for judging after High In Trial on July 30th to select the Rocky Mountain High winner. As in High in Trial ties, the dogs shall be tested by performing the Heel Free exercise individually. | |
| Brace Class | Open to any 2 dogs of any breed and either sex, that has attained not less than a CD title in Canada. It is not necessary that the same person own both dogs, nor that they be of the same breed, except when entered in a breed specialty obedience Trial. Exercises same as Novice. | |
| Veteran's Class | Shall be for dogs that have an obedience title and are seven (7) years old or older on the day of the trial. The exercises shall be performed and judged as in the Novice Class. NOTICE TO FOREIGN EXHIBITORS FROM THE CANADIAN KENNEL CLUB

Effective Jan/1992 all dogs that are foreign-born and foreign-owned and enter Canada for the sole purpose of entering CKC (Canadian Kennel Club) events will no longer require a CKC registration number <u>but will require an **ERN** - **Event Registration Number**</u>. This ERN does not register a dog with CKC for breeding purposes as defined in the Animal Pedigree Act but rather enables a foreign-owned dog to be awarded titles by the Canadian Kennel Club. Each dog must have its own number

To obtain an ERN (Event Registration Number) simply do the following:

- 1. Send a photocopy of the dog's registration certificate reflecting current ow nership with a written request for an ERN number
- 2. Include payment of \$55.85 Canadian Dollars plus 13% Ontario HST
- Accounts may be paid with personal or business cheque, money order, Visa or MasterCard. For Non CKC Members please note that if paying by cheque, the cheque must be certified. Best in Stakes

The group winners will compete for Best-In-Stakes. The Best-In-Stakes winner will receive a rosette plus \$500 donated by **Timberfox Kennels** and a prize from Eukanuba.

Q: Who handles the dogs? Does each dog have an individual handler, or are all three shown by the breeder?

A: Each dog has its own handler. The Breeder of Record for all 3 dogs handles the first dog, and friends/family/ whomever can handle the other 2. This allows everyone to know at a glance who the breeder is. For similar events in the USA and the U.K., all of the handlers dress alike, or wear a similar pin, or something — certainly not required, but adds to the fun.

Q: What does it mean "competition starts at the group level"?

A: There will be no breed judging for this event. All of the breeds of a group will be judged together, and if there are multiple entries of a breed, great! For example, the Sporting Group may have 2 trios of Goldens, 3 trios of Irish, 1 trio of Sussex — should make for a most excellent line-up!

Q: Must the Breeder also own all 3 dogs?

A: No. The first handler must only be a Breeder of Record for all 3 exhibits in the trio.

Q: What will the ring/judging procedure be?

A: The dogs will be shown as a unit. They will be examined as a unit, they will move as a unit. Judges will likely use normal ring patterns (down, back, around); dogs will move down and back, side-by-side, and around in a line. But the trio will always move together.

Q: Are the individual dogs being judged to determine the winners?

A: No. Judges are selecting the best breeding program, not the individual dogs. The dogs are the "evidence" of the program.

Q: Can Champions be shown in the Breeder's Group Stakes?

A: Yes. Champions can comprise any one or all of the Breeder's trio. The requirement is simply that the dogs are over 6 months old and from at least 2 different litters.

^{**}Since the Trio Stakes is not an official or unofficial event that is officially applied for or approved by the CKC and will be held after BIS, the individuals who are judging the Trio stakes will not be held to the same rules as Sweepstake judges according with rule 4.3.3**

Extracts From CKC Dog Show Rules

Chapter 8 Entries and End of Show Section

8.2.5 An error in an age specified class, date of birth or sex may be amended on the entry form up to one hour before the start of the show

Section 8.3.1 Entries: Every dog entered in a Championship show must be one of the following:

- a) registered with the CKC,
- b) have an Event Registration Number,
- c) be eligible for registration with the CKC, or
- d) if it belongs to a listed breed, it must have a Miscellaneous Certification Number (MCN).

Section 8.4.1 Listed Dogs: If a dog is not registered as in 8.3.1 (a) or (b) but is eligible for registration with the CKC, it may be entered at a show as a listed dog provided:

- b) that if born in Canada, it is eligible for individual registration;
- c) that if not born in Canada, is eligible for registration in the records of the CKC.
- d) that if it is a foreign born and owned dog, an Event Registration Number or CKC registration number is obtain from the CKC within 30 days of the first show entered.

Section 8 4.2 Entry of a listed dog at a show must be accompanied by a listing fee as set by the Board in addition to the regular entry fee.

Section 8.5.1 Acceptance of Entries: If indicated in the premium list, an electronically transmitted entry may be accepted provided the entry is accompanied by a credit card charge authorization.

Section 8.5.3 No entry shall be accepted from or on behalf of any person who is officially known to be expelled, deprived of privileges, debarred or suspended by the CKC or any other registering body for pure bred dogs.

Section 8.5.4 After entries close, no further entries may be accepted, cancelled or substituted other than as otherwise stated in this section or as provided for in case of a postal strike.

Section 8.6.1 Refusal of Entries: The authorities of any show may: a) decline to accept entries for just cause, and/or

b) refuse to receive or may remove any dog from the show building on account of disease or viciousness.

c) in the case of non-acceptance, refund the fee with the reason for non-acceptance

Section 8.8.2 Fees: Tendering of a dishonoured cheque or declined credit card in payment of an entry fee shall be considered non-payment of said fee and is an offense punishable by disciplinary action and cancellation of awards.

Section 8.9.1 Moving a Dog to Specials: A dog which is individually registered in the records of the CKC or that has a Miscellaneous Certification Number (MCN) and has completed the requirements for a Championship in accordance with these rules but at the time of the closing of entries for a show has not received confirmation of the title, may be transferred from one of the regular classes to Specials Only providing the transfer is submitted to the Show Secretary in writing by the owner or handler at least one hour prior to the opening of the show.

Section 8.9.2 If it is established that a dog transferred to Specials Only has not completed the Championship requirements, all awards will be canceled and all ribbons and prizes won shall be forfeited. The owner may also be subject to disciplinary action.

Section 8.9.3 When one or more All-Breed and/or Specialty Shows are held on the same day, in the same venue, the moving of class dogs to Specials must be made prior to the scheduled opening of the first show

Chapter 4 Judges Section 4.1.3 A judge officiating at a show held under these rules shall not be subjected to indignities of any kind during the progress of the show. It shall be the duty and obligation of the club holding the show to see that this rule is effectively carried out

Section 4.1.6 No person may approach a judge either directly or otherwise, orally or in writing, to favor his entry. Disciplinary action will be taken against any person who violates this rule or against a judge who fails to report any contravention of this rule to the CKC within 14 days of the act.

Chapter 14 Disqualifying or Excusing Dogs

Section 14.1.4 Once a dog has been disqualified for any reason at a conformation show, it may not be entered or shown at another show until the dog has been reinstated by the CKC. Section 15.1.5 If a Dog awarded Winners is also awarded Best of Winners, then all dogs defeated directly or indirectly in the breed shall be included in the total

Section 15.1.6 If a dog is awarded Winners only, then all the dogs of the same sex in the class competition shall be included in the total.

Section 15.1.7 The number of championship points to be credited to a dog awarded Winners shall be determined by the highest award earned and calculated as per this section.

Clarification: Example of directly or indirectly defeating. If the Winners Bitch is awarded Best of Opposite Sex but not Best of Winners, the Best of Winners Male shall be deemed to have indirectly defeated the Specials Bitches, and is thus entitled to add them to the number of does and bitches defeated.

Section 15.1.8 In addition to championship points allocated at the breed level, a dog awarded Winners which also places in the regular Group competition shall be credited with the following additional points provided that the dog was defeated at the Group level.
