#### NOTICE TO EXHIBITORS

The Show Superintendent will be in full charge of the show which will be governed by CKC rules.

The BCLRC will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume liability in the event of an accident, or other misfortunes, to either dogs, exhibitors or patrons.

If, because of a riot, civil disturbance or other acts beyond the control of management, it is impossible to open or to complete the show, no refund of entry will be made.

There shall be no extensive drilling or corrections of dogs on the show precincts or surrounding grounds. Prong collars not allowed on show precincts.

**SHOW PRECINTS:** The grassy area of the Albion Fairgrounds south of the creek and north of the Lougheed Hwy.

#### CONFORMATION SHOW RULES AND REGULATIONS

These events held under the rules of **The Canadian Kennel Club.** The show will be held outdoors and cover will not be provided in case of inclement weather. The show is unbenched and unexamined.

A judge officiating at a show held under these rules shall not be subjected to indignities of any kind during the progress of the show. It shall be the duty and obligation of the club holding the show to see that this rule is effectively carried out.

No person may approach a judge, directly or otherwise, orally or in writing, to favour his entry. Disciplinary action will be taken against any person who violates this rule or against a judge who fails to report any contravention of this rule to the CKC within 14 days of the act.

No person shall enter or exhibit a dog under a just where that judge has owned, conditioned, sold, handled held under lease or boarded within 6 months prior to the date of the show at which he officiates as a judge. This rule shall apply regardless of whether the judge benefited in any way from any of the aforementioned activities. It is the responsibility of the owner to see that this rule is not violated.

## OBEDIENCE JUDGE'S BIOGRAPHIES Larry Tanner AKC Judge

I was born in Coeur d'Alene Idaho and have lived in Spokane Washington for the past 22 years. I got into dogs in 1982 when I joined Lilac City Dog Training Club in Spokane. My first dog, Cinder, was a black lab. Labradors have been my breed of choice for 27 years and I have bred them under the kennel name Laclare Labradors. I have also shown labs in conformation, field work, rally and agility, but my passion has always been obedience.

At this time I have one black female (Gypsy) who is 12 years old and the grandma of my one yellow male (Tanner), age 4 who is in training for obedience, rally ,conformation and is also a Delta Society pet therapy dog.

I'm a member of the Puget Sound Labrador Retriever Association and treasurer for Lilac City Dog Training Club where I have been an instructor for the past 27 years. I helped to start the puppy class about 18 years ago and that has always been my favorite class to teach. I became an AKC Obedience judge in 1999 and Rally judge when AKC approved that competition.

# **Bruce Fraser CKC Judge**

Bruce began training Miniature Schnauzers for conformation with his 1st Miniature Schnauzer in 1986. Catching the "show bug", next on the horizon was a breeding program, focusing on Black Miniature Schnauzers. Top American lines figured prominently in the pedigree. Many Canadian and American Championships have been attained. In 1995 Bruce began a concentrated obedience training regimen. By 1999 Bruce's first obedience dog "Granite" became Ch. & OtCh. Advocate's Black Gemstone and the Number One Miniature Schnauzer in Canada in obedience in 2000.

Bruce, a lawyer by profession, became a CKC licensed obedience trial judge in 2004. He also devotes considerable time to dog club activities, has been a member of the Miniature Schnauzer Club of Canada and BC All Terrier Club since 1987 and currently serves on the executive of the BCATC, as Obedience Director. Bruce sat on the Canadian Kennel Club Discipline Committee for a three year term. He is currently secretary/treasurer of the Richmond Dog Fanciers, which club focuses on presenting "quality venue" obedience and rally trials. Bruce continues to breed, show, train and trial Miniature Schnauzers.

In 2007 Bruce obtained a conformation permit judging license. He is licensed to judge the Terrier Group and has a permit license to judge Toys. Bruce is also an all class Rally Obedience Judge.
