The tendering of NSF cheque shall be considered non-payment of entry fees and is punishable by returned cheque. Exhibitors whose charges are declined by the Bank Card Authorization Department will be assessed a service charge of \$25.00 for each transaction declined. Telephone entries are not accepted by the Show Secretary. Incomplete entries or entries received without fees, or entries received after the advertised closing date will not be accepted.

Attention foreign exhibitors, please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates discounted cheques will not be accepted. Personal cheques will be accepted, however, they are to be payable in Canadian Funds. If you sent a cheque in US funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please DO NOT make cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian Funds.

## **CONFORMATION JUDGES**

**Carlos Capone** – Carlos is from Campinas, Sao Paulo, Brazil. He has been involved with the breeding of Rottweilers and Pugs. He is an FCI All Breed judge.

**S. Paticia Cummins** – Pat has bred and owned Samoyeds and Pembroke Welsh Corgis under the kennel name Sancha Reg. She has been judging since 2007 in both Canada and the USA.

**Honey Glendining** – Honey has bred English and Irish Setters and well as Newfoundlands under the kennel name Fantail Perm. Reg. She has been judging since 1983 and is licensed in all groups. In addition to Canada, she has judged in Australia, Brazil, China, Columbia, England, Hong Kong, Indonesia, Japan, Korea, Malaysia, Mexico, New Zealand, Philippines, Thailand and the USA.

Margaret Jones – Margaret has bred Irish Setters, Cairn Terriers and Boxers under the kennel name Kian Perm. Reg. She has been judging since 1995 and licensed for all groups. In addition to Canada she has judged in Argentina, Australia, Brazil, China, Columbia, England, Finland, Indonesia, Ireland, Israel, Japan, Korea, Malaysia, Mexico, New Zealand, Philippines, South Africa, Sweden, Thailand and the USA.

**John Rowton** – John has bred Borzoi, Bedlington and Pembroke Welsh Corgi. He has been judging since 1987 and is licensed for all group. In addition to Canada he has judged in Australia, New Zealand, Taiwan, Thailand and the USA.

**Elaine Whitney** – Elaine has bred Poodles, Cavalier King Charles Spaniels, Whippets, Shih Tzu and Dachshunds. She has judged since 1990 and is licensed to judge all groups. In addition to Canada she has judged in Australia, Belgium, Bermuda, China, Columbia, Denmark, Finland, Germany, Hong Kong, Ireland, Mexico, New Zealand, Philippines, Russia, Sweden, Thailand, Venezuela and USA.

**Robert Whitney** – Robert has bred Afghan Hounds, Whippets, Cavalier King Charles Spaniels and Poodles. He has judged since 1990 and is licensed to judge all groups. In addition to Canada he has judged in Australia, Belgium, Bermuda, China, Colombia, Denmark, Finland, Germany, Hong Kong, Ireland, Mexico, New Zealand, Philippines, Russia, Sweden, Thailand, Venezuela and the USA.

#### **OBEDIENCE/RALLY JUDGES**

Chris Cornell – Teaching basic manners to his son's gift from his grandparents, a rambunctious field English Setter puppy named Queen, introduced Chris's family to the world of obedience in 1976. Queen went on to become the first English Setter to earn the Obedience Trial Championship (OTCH) title. Over the years, he trained and raised numerous dogs and organized a therapy dog group in his community. He started judging obedience at AKC shows in 1984.

**Margaret Heningman** – Margaret can't remember a time in her life when dogs didn't play a huge role. During the 60's she started obedience training her own first Lab/Samoyed cross, Tass. Tass was a real handful and taught Margaret a lot about the value of patience and consistency. Her first, OTCH, Marpoint's Charlotte Harlot was also a clown that sealed her love for Obedience and Rally and sparked her interest in judging.

**Carol Toms** – Carol began her dog training at the age of 11. When she moved to Canada in her 20's, she asked where the nearest obedience training school was and as no one had any idea she started her own. Carol has put numerous titles on her own dogs, including obedience, rally obedience, tracking, agility, tricks, scent detection, dressage and freestyle.

## **CONFORMATION CLASSES**

The following Regular CKC Classes (divided by sex) will be offered:

JUNIOR PUPPY CLASS - This class shall be for any dog 6 months of age and under 9 months of age on the day of the show

SENIOR PUPPY CLASS - This class shall be for any dog 9 months of age and under 12 months of age on the day of the show

12 to 18 MONTHS – This class shall be for any dog 12 months of age and under 18 months of age on the day of the show.

CANADIAN BRED CLASS - This class shall be for any dog born in Canada. Champions of an country are excluded.

BRED BY EXHIBITOR CLASS - This class shall be for any dog owned and handled in the ring by owner/breeder. The handler MUST be the owner/co- owner AND breeder/co-breeder of the dog. The owner/breeder must handle the dog at the class level, but need not handle the dog for further awards

OPEN CLASS - This class shall be for all dogs.

SPECIALS ONLY CLASS - This class shall be for any dog that has a recorded CKC Registration or Event Registration Number and has attained the required points for Championship status. Note: A Listed dog may be moved to the Specials Only Class after the closing of entries, provided the CKC Individual or Event Registration Number was received prior to the first day of the show. The request to move a class dog to the Specials Only Class MUST be received by the Show Secretary ONE HOUR PRIOR TO THE OPENING OF THE SHOW ON THE DAY CONCERNED. Listing Fees WILL NOT be refunded

## **NON-REGULAR CLASSES**

EXHIBITION ONLY - All dogs entered in this class shall be listed in the catalogue with the same particulars as dogs entered in regular competition. Dogs entered in this class MAY NOT COMPETE in any Regular class but may enter and compete in Non-Regular classes and/or Parades ONLY

BABY PUPPY – This class is for all dogs 3 months of age and under 6 months of age on the day of the show.

VETERANS CLASS - This class is for dogs 7 years of age and over on the day of the show. Dogs entered in these classes may be spayed or neutered.

#### **UNOFFICIAL CLASS**

BREEDER/OWNER/HANDLER - You must be entered in a Regular Class to be eligible. There is no entry fee but you must enter on the entry form in the box provided. Awards at breed, group and BIS level.

## **SEXUALLY ALTERED CLASSES**

Eligibility for the Altered classes shall be limited to dogs over six months of age, which have been sexually altered by veterinary procedure. Points MAY NOT be carried from the regular competition judging to the Altered class judging. This class will be judged upon the completion of Best of Breed.

Two classes ONLY will be offered: Altered Male and Altered Female

Classes will be placed first through fourth in both sexes, the first place winner from each sex will be declared Winners and the second place winner from each sex will be awarded Reserve. The Altered Winners Male and Altered Winners Female will then compete for Best Altered in Breed.

## **OFFICIAL OBEDIENCE CLASSES:**

No dog may be entered in both Novice "A" and Novice "B", Open "A" and Open "B" at the same trial. In determining class eligibility, if a dog shall have won a particular title before being entered or moved up, the handler shall have been notified by at least 2 different judges that the dog has won 3 qualifying scores for the required title. (However, a dog may continue to be exhibited for 60 days in a class after winning a particular title.)

Dogs fulfilling the requirements for a title may be moved to the next level of competition if the schedule permits. The transfer must be on the appropriate move-up form and submitted to the show secretary at least 15 minutes before the start of the class.

**PRE-NOVICE** - The Pre-Novice class is an elective class and earning the title is not a requirement to enter Novice classes. The Pre-Novice class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has not earned the title of P.C.D. Dogs in this class may be handled by the owner or any other person. A person may enter more than one dog in this class. The same handler must handle each dog in all 5 exercises unless he has 2 or more dogs entered. In such cases, he must have an additional handler for each extra dog when they are judged together in the group exercise. Only dogs that have not earned the title of C.D. may enter the Pre-Novice class.

**NOVICE A** - The Novice A class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has not earned the title of C.D. Only one dog per handler is allowed in this class, and that person must handle the dog in all exercises. The handler of any dog in this class must be the owner, co-owner or a member of their immediate families. No person who has trained or exhibited a dog that earned a C.D.X. title shall be allowed to handle a dog in this class.

**NOVICE B** - The Novice B class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has not earned the title of C.D. Dogs in this class may be handled by the owner or any other person. The owner or any other person may handle a dog in this class. A person may enter more than one dog in this class. The same handler must handle each dog in all 6 exercises unless he has 2 or more dogs entered. In such cases, he must have an additional handler for each extra dog when they are judged together in the group exercises.

**NOVICE C** - The Novice C class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed that has earned the title C.D. or any higher obedience titles. Dogs in this class may be handled by the owner or any other person. A person may enter more than one dog in this class. The same handler must handle each dog in all 6 exercises unless he has 2 or more dogs entered. In such cases, he must have an additional handler for each extra dog when they are judged together in the group exercises. Dogs may compete in Novice C indefinitely. Scores earned by dogs in the Novice C class are not eligible for High In Trial and do not qualify a dog for any title. Dogs may be entered in the Novice C class in addition to any other official or unofficial classes for which they are eligible.

**NOVICE INTERMEDIATE** - The Novice Intermediate class is an elective class and earning this title is not a requirement to enter the Open classes. The Novice Intermediate class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed that has earned a C.D. or any higher obedience trial titles. Dogs in this class may be handled by the owner or any other person. A person may enter more than one dog in this class The same handler must handle the dog in all 6 exercises. Dogs may compete in the Novice Intermediate class indefinitely. Scores earned by dogs competing in this class are not eligible for High in Trial. Dogs may be entered in the Novice Intermediate class in addition to any other official or unofficial classes for which they are eligible.

**OPEN A** - The Open A class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has earned the title of C.D. but has not earned the title of C.D.X. The handler of any dog in this class must be the owner, co-owner or member of their immediate families. Only one dog per handler is allowed in this class, and that person must handle the dog in all exercises. Any person who has trained or exhibited a dog that has earned a U.D. title may not handle a dog in this class.

**OPEN B** - The Open B class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has earned the title of C.D. Dogs which have earned the title of C.D.X. or any higher titles may enter in the Open B class. A dog may also be entered in the Utility Class in the same trial. Dogs in this class may be handled by the owner or any other person. A person may enter or handle more than one dog in this class. The same handler must handle each dog in all 7 exercises unless he has 2 or more dogs entered. In such cases, he must have an additional handler for each extra dog when they are judged together in the group exercises. Prior to the start of judging, the judge will choose which of the six numbered routines is to be performed. This choice will not be disclosed to the exhibitors until it is posted at ring side at least 30 minutes before the start of the class. In future assignments, judges are required to alternate the six routines so that each set will be used approximately the same number of times.

**UTILITY A** - The Utility A class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has earned the title of C.D.X. but has not earned the title of U.D. Any person who has trained or exhibited a dog that has earned a M.O.T.Ch. title may not handle dogs in this class. The handler of any dog in this class must be the owner or member of their immediate families. Owners may enter more than one dog in this class. The same person must handle the dog in all exercises.

**UTILITY B** - The Utility B class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has earned the title of C.D.X. or U.D. Dogs in this class may be handled by the owner or any other person. Owners may enter more than one dog in this class. The same person must handle the dog in all exercises. Prior to the start of judging, the judge will choose which of the six numbered routines will be performed. This choice will not be disclosed to exhibitors until it is posted at ring side at least 30 minutes before the start of the class. In future assignments, judges are required to alternate the six routines so that each will be used approximately the same number of times.

### **UNOFFICIAL OBEDIENCE CLASSES:**

All dogs entered in the Unofficial Classes must be entered in one of the Official Classes or Exhibition Only.

BRACE CLASS – This is open to any 2 dogs that earned the title of C.D. or higher. The 2 dogs need not be owned by the same person but must be the same breed for a breed specialty obedience trial. The owner or any other person may handle a brace and they may enter more than one. The same handler must handle each brace in all 6 exercises unless he has 2 or more braces entered. In such case, he must have an additional handler for each extra brace when they are judged together in the group exercises. The Brace Class is performed and judged in the same manner as the Novice Class. The 2 dogs shall be hitched together with a brace chain or coupling and are judged on the performance of the 2 dogs as though they were one.

**TEAM CLASS** – This is open to any 4 dogs that have earned the title of C.D. or higher. It is not necessary that the same person own all the dogs in the team but must be of the same breed for a breed specialty. 5 dogs may be entered, one to be considered as an alternate. However, the same 4 dogs must compete in all exercises.

**VETERANS CLASS** – For any dog that has earned a title of C.D. or higher and is 7 years old or older on the day of the trial. The exercises shall be performed and judged as in the Novice Class. The owner or any other person may handle a dog in this class. A person may enter more than one dog in this class. The same handler must handle each dog in all 6 exercises unless he has 2 or more dogs entered. In such case, he must have an additional handler for each extra dog when they are judged together in the group exercises.

## **OFFICIAL RALLY CLASSES:**

No dog may be entered in both Advanced "A" and Advanced "B" at the same trial or Excellent "A" and Excellent "B" at the same trial.

**RALLY NOVICE A** - Dogs competing in this class may not have won a CKC Rally Novice (R.N.) title or any CKC Novice Obedience title. No handler who has exhibited a dog through its CKC Companion Dog Excellent (C.D.X.) title or instructed dog training classes shall be eligible to enter this class. The handler of any dog in this class must be the owner, co-owner, or member of their immediate families. A person may enter more than one dog in this class. A dog may continue to compete in this class after the owner has been notified by at least 2 different judges that the dog has won 3 qualifying scores in this class. However a dog may not be entered or exhibited in this class in any rally trial after the owner has received official notification form the CKC that the dog has won the title.

**RALLY NOVICE B** - Any dog may compete in this class until a qualifying score in the Rally Advanced class is earned. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class. All exercises are judged on leash, and all dogs must enter and leave the ring on leash.

**RALLY INTERMEDIATE** - This class shall be for dogs that have earned the R.N. title. A dog completing the R.I. or any other obedience or rally titles may continue to compete in this class indefinitely. The owner or any other person may handle dog in this class. A person may enter more than one dog in this class.

RALLY ADVANCED A - This class shall be for dogs that have won the Rally Novice (R.N.) title but have not won the Rally Advanced (R.A.) title or any CKC Novice Obedience title. No handler who has exhibited a dog through its CKC Companion Dog Excellent (C.D.X.) title or instructed dog training classes shall be eligible to enter this class. The handler of any dog in this class must be the owner, co-owner, or a member of their immediate families. A person may enter more than one dog in this class. A dog may continue to compete in this class after the owner has been notified by at least 2 different judges that the dog has won 3 qualifying scores in this class. However a dog may not be entered or exhibited in this class in any rally trial after the owner has received official notification from the CKC that the dog has won the title.

**RALLY ADVANCED B** - This class shall be for dogs that have won the Rally Novice (R.N.) title. A dog completing the Rally Advanced (R.A.) title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class. All exercises are judged off leash. All dogs must enter and leave the ring on leash.

**RALLY EXCELLENT A** - This class shall be for dogs that have won the Rally Advanced (R.A.) title, but have not won the Rally Excellent (R.E.) title or any CKC Novice Obedience title. No handler who has exhibited a dog through its CKC Companion Dog Excellent (C.D.X.) title or instructed dog training classes shall be eligible to enter this class. The handler of any dog in this case must be the owner, the co-owner, or a member of their immediate families. A person may enter more than one dog in this class, A dog may continue to compete in this class after the owner has been notified by at least 2 different judges that the dog has won 3 qualifying scores in this class. However, a dog may not be entered or exhibited in this class in any rally trial after the owner has received official notification from the CKC that the dog has won the title.

**RALLY EXCELLENT B** - This class shall be for dogs that have won the Rally Advanced (R.A.) title. A dog completing the Rally Excellent (R.E.) title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class, A person may enter more than one dog in this class. All exercises are judged off leash except the Honor Exercise. All dogs must enter and leave the ring on leash.

## **UNOFFICIAL RALLY CLASSES:**

All dogs entered in the unofficial rally classes must also be entered in an official rally class or exhibition only. Clubs may offer Rally Novice, Rally Advanced and/or Rally Excellent.

**RALLY BRACE CLASS** – This class requirement is the same as the obedience brace class, except that they are open to any 2 dogs that have earned a title of R.N. or higher.

RALLY TEAM CLASS – This class requirement is the same as the obedience team class, except that the class is open to any 4 dogs that have earned a title of R.N. or higher. Each team member will run the course individually, with the team time running continuously. The judge will give the first member of the team the "Forward" command from the "Start" sign. Each subsequent dog and handler will start when the previous dog and handler pass the "Finish" sign, without any additional command of "Forward" by the judge. Timing for each team will begin when the judge commands "Forward" to the first handler in the team and will stop when the fourth handler and dog pass the finish line.

For final judging the first place puppy from each of the classes will be brought together for the final judging of Best in Sweepstakes.

## **GENERAL RULES GOVERNING THESE SHOWS**

It is the responsibility of the Exhibitor to be familiar with the rules pertaining to the event in which they are competing. Copies of the Conformation Rule book are available from: The CKC, 400 200 Ronson Dr., Etobicoke, ON M9W 5Z9 or online at www.ckc.ca

- 1. The Club reserves the right to remove any person from the show. The Show Superintendent shall have full control of the above shows and trials, which will be governed by CKC rules.
- 2. Any dog excused by the Show Superintendent or the Show Veterinarian for any reason shall not, after being excused, compete in any class for any award for the balance of the show.
- 3. The show committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of accident, or other misfortune, to either dogs, exhibitors or patrons.
- 4. A Judge or any person participating in any capacity at a Dog Show held under CKC Rules shall not be subjected to any indignity of any kind during the progress of the show and it shall be the duty and obligation of the Club holding the show to see that this rule is effectively carried out. The Show Superintendent shall promptly report to the CKC any infringement of the rules, and the Discipline Committee shall have the power to take such action as it deems fit on receipt of a report indicating that this rule has been violated.
- 5. Exhibitors are solely responsible for the conduct or actions of their animals while they are on the show grounds.
- 6. DOGS MUST BE READY FOR JUDGING. The Club will not be responsible for and is not obligated to provide any service for notifying owners or agents of breed or class judging. No ring shall be held up waiting for exhibitors or handlers. Exhibitors & Handlers with more than one dog shall have substitute handlers available so the judging will not be delayed. All start times are PACIFIC TIME.
- 7. The owner of a dog entered in these shows is entirely responsible for any error in entering his/her dog, regardless of how or by whom the entry was made.
- 8. A dog once disqualified for any reason at a championship show held under these rules cannot again be shown at a show held under these rules until the dog has been examined by an official committee appointed by the CKC and the committee finds the dog is free from the condition which prompted the disqualification. Application for reinstatement must be accompanied by a fee of \$50.00 plus GST which shall be forfeited to the CKC if the examining committee is satisfied that the dog should remain disqualified. All awards earned at a dog show in violation of this rule shall be canceled by the CKC and the owner of the dog is subject to disciplinary action.
- 9. Exhibitors and handlers will be responsible for their dogs and for their equipment left at the Show Grounds.
- 10. For the benefit of the health of animals and the pleasure of the exhibitors and spectators we insist upon keeping our grounds and buildings as clean as possible. Exhibitors are responsible for cleaning up after their dogs. Please exercise your dog BEFORE taking it to the Judging ring. Dogs are to be exercised in the designated areas only, not in the vicinity of the ring areas.
- 11. No entry fee will be refunded if the Show cannot open or be completed by reason of riots, civil disturbances, fire, and Act of God, public emergency, act of public enemy, strikes or any other cause beyond the control of the Club.
- 12. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused by the Veterinarian or Judge, or barred from competition by action of the Show Committee.

## **FIRE SAFETY RULES:**

Extension cords may not be laid across an aisle.

Power bars are not permitted.

Aisles must be kept open at all times to allow everyone easy and speedy exit in case of emergency.

All designate FIRE LANES must be kept clear at all times or vehicles will be towed at owner's expense.

## **ADDITIONAL CLUB RULES:**

Exhibitors will be responsible for cleaning up after their dogs. Violators will be asked to leave the show grounds.

Crates will be allowed at ringside during the judging of your specific breed only and must be removed immediately after. No Exceptions.

Dogs are not allowed in washrooms and must be on leash at all timed on the show grounds or within the show building with the exception of the obedience rings.

The welfare of an exhibitor's child is assumed to be the responsibility of the exhibitor. It is distinctly understood that you will exercise control and restraint over the children in your care on the days of these shows.

The Club is not responsible for lost or stolen property from exhibitors or venders/concessions. The Club will use due care and diligence for the welfare of dogs and exhibitors but will not be responsible for, or assume any liability in the event of accident or misfortune to either dogs, exhibitors, spectators or vendors.

The club reserves the right of restricting exhibitors grooming space.

Plastic sheeting must be under all exercise pens.

Dogs must be exercised in the designated areas. Dogs may not relieve themselves on or near the building. Failure to observe this rule may result in dismissal.

Any tape used in the building has to be easily removable and must be removed after the show is competed. Colored tape is not allowed. You must leave your setup in the same clean condition you found it in when you first arrived at the show.

No liquid waste is to be disposed of in garbage cans.

All RV units must have buckets underneath for their sink drains. Anyone found discharging water on the grounds will be removed by order of the Health Department and may be subject to a fine.

No catering of any kind is permitted.

The club reserves the right of restricting exhibitors grooming space.

Grooming is not allowed in the Obedience benching area.

Any videographer or photographer, other than the official videographer/photographer, that is going to take picture for which they will be remunerated will require written permission from the Nanaimo Kennel Club Show Committee and/or the official show videographer/photographer.

#### CANADIAN KENNEL CLUB SCHEDULE OF CHAMPIONSHIP POINTS

SECTION 2. The schedule to be employed in the determination of the number of points to be allocated to a dog awarded WINNERS shall be as follows: (\*Includes the dog awarded Winners.)

| Dogs Competing*   | 1 | 2 | 3 to 5 | 6 to 9 | 10 to 12 | 13 or more |
|-------------------|---|---|--------|--------|----------|------------|
| Points Allocated* | 0 | 1 | 2      | 3      | 4        | 5          |

To determine the number of championship points earned by a dog awarded Winners, total all the dogs in competition which the dog defeated, directly or indirectly, for the highest of the following official breed awards: Winners, Best of Winners, Best of Breed or Best of Opposite Sex and then consult the schedule set forth above. A dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall not be included in the calculation for championship points. Further section 15.1.12 {C} has been added and states the dog must: "have earned at least one 2 point win either at the breed level or group level."

The system provides for additional points if a dog awarded winners also places in the Group as listed here under.



A class Dog awarded Best In Show at an all-breed championship show will be credited with five points inclusive of any points earned at the breed or group level. In no case may a dog earn more than five (5) points at a single show. To earn a Canadian Championship, a dog must earn at least ten championship points under at least three different judges; and be individually registered with the Canadian Kennel Club, or have a CKC Event Registration Number (ERN).

## **AGREEMENT**

I (we) acknowledge that I (we), all exhibitors, handlers and patrons, know and abide by the "CKC Dog Show Rules", and that I am (we are) familiar with their content. I (we) agree that the Club holding this show has the right to refuse this entry for cause, which the Club shall deem to be sufficient. 
