General Information

- Only those dogs registered with NAMBR (mixed and purebred) REGISTERED WITH NAMBR PRIOR TO THE CLOSING DATE of this test may be entered.
- Bitches in season are permitted to complete the test and will run the last track, rather than participating in the draw. The handler is expected to manage the bitch such that she does not disturb the other dogs participating. When a bitch comes into season after the entry of the bitch has been submitted, a veterinarian's certificate, certifying the bitch was in season within the ten day period preceding the test must reach the Test Secretary on or before the date of the test, whereupon the entry fee will be refunded, if the handler chooses to cancel the entry.
- Entries will not be accepted unless accompanied by the appropriate fees. No post-dated cheques will be accepted. NSF cheques are subject to a \$50 charge. Hand delivered, telephone, fax, email or credit card entries will not be accepted. **Entries will not be accepted in person by Sue Godbehere. To be fair to all entrants, please submit only one entry per envelope. If you are sending your entry by courier, make sure a signature is not required as there is no one home during the day to sign for it.**
- The host will use all reasonable care to ensure safety of dogs and handlers participating in the test, but will not be responsible for loss or injury to any dog, exhibitor or spectator.
- The Trial Secretary will have entire charge and control of the test.
- All dogs must be kept on a leash at all times and under control. Please clean up after your dog.
- A listing fee of \$2.00 per entry will apply for all NAMBR registered POD (Pure-bred Obedience Dog) entries. Listing fees are required to be remitted directly to the trial secretary along with the applicable entry fee.

Test Information

- Catalogue will be provided on date of the test.
- All entries will be acknowledged via email as they are received. As preference will be given to non-CKC registerable dogs if the test limit is exceeded, **entry into the test will be confirmed the day after the closing date** by email. If the test limit is exceeded alternates will be set aside. If you discover that you are unable to participate, please advise the Trial Secretary so that an alternate can be advised. Changes may be made to the levels offered depending on field availability and/or to accommodate entries received, eg a UTDX may be changed to 2 UTDs if the UTDX level does not fill.
- Test will be held rain or shine.
- Participants will be advised of the order of the test events/levels and where and when to meet for the draw(s) in their confirmation. Rosettes may be awarded either after each level is completed, or after all tracks have been completed.

Prizes

- A rosette will be awarded to each dog that passes the test.
