ENTRY ELIGIBILITY

1. Dogs must be permanently registered with UKC, or have a Temporary Listing (TL) number in order to enter. No exceptions will be made. Entries for ineligible dogs will be returned.
2. Dogs must be 6 months of age on the day of the event.
3. An unentered dog may not be substituted for an entered dog.
4. Temporary Listings are not available at the event.

ENTRIES

1. **Pre-Entries:** Licensed Classes: \$25.00 per entry, KSH members: \$22.00 per entry. Pre-trials: \$10.00 per entry, KSH members: \$7.00 per entry. CASH, CHEQUE, OR E-TRANSFER ONLY. Entries must be received by event staff before **May 10, 2018.** Entries received after this date will be charged Day of Show Price – NO EXCEPTIONS!
2. **Day of show entries:** \$28.00 per entry, KSH members \$25.00. CASH or CHEQUE ONLY.

***By submitting an entry into a vehicle trial, the expectation is that your vehicle is available to be used during that trial.**

Alternate crating areas will be made available for competitors whose vehicles are chosen, for the duration of the individual trial.*

SUBMITTING ENTRIES

1. Entries must be submitted on the current Official UKC Nosework Entry Form. Downloaded copies or photocopies of these forms may be used as well.
2. Entries received incomplete, will not be accepted.

3. Pre-entries may be mailed, or hand-delivered to the Event Secretary.
4. **Mailed Entries** must include the entire form and be signed. Mailed entries received without fees shall not be accepted.

PAYMENT

1. Payment may be made by cash or cheque. E-transfers will also be accepted, please contact the club for more information. Fees must be in Canadian funds. No entry will be accepted without payment.
U.S. competitors, please note that we are only able to accept payment via PayPal. Please contact the club for more information.
2. Make cheques payable to "Kootenay Scent Hounds".
3. Returned cheques do not constitute valid entry fees.

REFUNDS

1. Refund of entry fees will not be made for entries cancelled after the Pre-Entry deadline except in cases of extenuating circumstances which are approved by two members of the Kootenay Scent Hounds' Board of Directors on an individual basis.
2. Entry fees shall not be refunded in the event that a dog is absent, disqualified, excused by Judge, or barred from competition by action of Event Committee.
3. In lieu of a refund, Novice A competitors who do not pass their PT1 will be able enter other PT1 runs offered during this event for free until they pass.
4. Please note that entry fees shall not be refunded in the event that a dog does not pass the required PT.
5. If, because of riots, civil disturbances, or other acts beyond the control of the host organization it is impossible to open or to complete a show or trial, no refund of entry fee will be made.
6. Every effort will be made to find all duplicate entries before processing. If a duplicate entry is processed, however, no refund will be made.
7. If, in the opinion of the host club, the wellbeing of dogs, exhibitors or spectators is at risk due to extreme weather conditions, such as, but not limited to snow storms, hurricanes, lightning, or extreme heat, the host club may cancel or stop a show or trial before completion. No refunds will be made in such cases.

Site Information:

Driving Directions: From Castlegar, stay on Columbia Ave and head north, you will cross the Castlegar-Robson Bridge, turn left onto Broadwater Road, and right onto Relkoff Road. From Nelson, take the exit directing you to Robson and Syringa Provincial Park, turn right onto Broadwater Road, and right onto Relkoff Road.

Crating and Set-up:

There will not be indoor crating space available. Dogs may be crated in vehicles or under shade tents in designated area. Owners are expected to pick up after their dogs.

Food will not be available on site, restaurants and grocery stores are within a 5 min drive.

Accommodations:

Hotel Information: Several pet friendly hotels/motels are located within Castlegar. These include the Quality Inn, Sandman Hotel, Super 8 Hotel, Fireside Inn, Flamingo Motel, Cozy Pines Motel, and Twin Rivers Motel.

Camping Information:

Limited camping available at the trial site. All campers MUST be self-contained, \$10 per night.

Other camping is available at:

Pass Creek Regional District Campground, Castlegar RV Park, Syringa Provincial Park, and Kootenay River RV Park.

Awards to be Presented:

Ribbons will be awarded for completed titles (Novice Containers, Novice Vehicles, Novice Nosework, Advanced Containers, Advanced Vehicles, Advanced Nosework, Superior Containers, Superior Vehicles, Superior Nosework, Master Containers, Master Vehicles, Master Nosework), placements (1st through 4th), and for all qualifying runs. High-in-trial ribbons will also be presented to the qualifying team with the fastest time for each level in each trial.

Participants may move up to the next level provided that the level is offered at this event.
