ATTENTION FOREIGN EXHIBITORS: Please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted, however, they are to be payable in Canadian funds. If you send a cheque in US funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor.

Please do not mark cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian funds. Your understanding and cooperation is appreciated.

GENERAL INFORMATION

- The Show/Trial Superintendent will be in full charge of shows.
- The building will close one and one haf hours after the completion of daily judging.
- Children, accompanied by an adult, are welcome at our show, however, please do not allow them to disturb dogs without permission of owner/handler or run through the building or stands
- All exhibitors will be held responsible for clean up on the show grounds and surrounding areas for their own dogs or dogs they are handling and must use the designated areas.
- .- The Maritime Group 7 Club and Halifax Kennel Club will not be held responsible for any equipment left in the building overnight.
- A canteen will be available in the arena.
- A judge officiating at a show held under CKC rules shall not be subjected to indignities of any kind during the progress of the show.
- A judge officiating at a trial shall not be subject to indignities of any kind during the progress of the show and it is the duty and obligation of the show giving club to see that this rule is enforced.
- No person may approach a judge either directly or otherwise, orally or in writing, to favour his
 entry. Disciplinary action will be taken against any person who violates this rule or against
 a judge who fails to report any contravention of this rule to the CKC within 14 days of the
 act.
- The MG7 Club and the Show Committee will use care and diligence for the welfare of the dogs and exhibitors, but will not be responsible for, or assume any liability in the event of an accident, or other misfortune to either the dogs or exhibitors or patrons. If, because of riot or civil disturbance or any other acts beyond the control of the MG7 Club and their Show Committee, it is impossible to open or close the shows, no refund of entries will be made.
