GENERAL INFORMATION AND EVENT RULES

WORKSHOP INFORMATION

Instructor: Jane McLaughlin

This *Introductory Workshop* to the new Sport of *Barn Hunt*. Your dog will start to learn what the quarry smells like, work on climbing the straw bales and tunneling skills. We will focus on marking the quarry and handling techniques.Rat care and safety is paramount in the sport, no rats are harmed during any barn hunt event.

All this helps prepare you for your first trial, by explaining procedures and the Barn Hunt rules.

What can beginner dogs expect in the Workshop?

In a small group, our experienced instructor will lead your dog step by step from the concept of recognizing the rat in the tube to finding the hidden rat tube in the straw bails. Your dog can discover his natural hunting instincts in a safe and constructive way. You will start to recognise your dog's behaviour when it locates the tubed rat. Locating the correct tube takes place off leash in a fully fenced area.

Schedule: 9 am - Noon

Limited to 12 working dog/handler (1 dog per handler) Auditing Workshops is unlimited, but you **must** pre-register.

PRACTICE & GO INFORMATION

Get in, get your rat on, get out!

Practice the skills that you learned in the Workshop or prepare for the next Barn Hunt Trial. Practice & Go is for dogs with a solid understanding of finding a rat and is perfect for dogs that are trialing or very close to trialing in Barn Hunt. This is great for perfecting technique and working on skills!

We presume that the dog has had a rat intro or workshop.

It will be run like a trial, Courses will be set from Instinct thru Master class; no titles will be awarded.

Dogs do NOT need a Barn Hunt registration number to enter.

Dogs may enter any level (class) and enter more than one once to a MAXIMUM of two times. This gives the dog and the competitor lots of opportunities to experience new levels and practice in a trial environment.

Handlers can train their dog in the ring. FOOD will NOT be permitted in the ring, but toys will be allowed. Time in the ring will be limited to the course time for that class.

PRACTICE & GO Fees: Pre Entry \$5 Gate Entry \$10

Day of entry will be taken until 11 am, if limit is not reached.

REGISTRATION: Test Secretary Desk opens at 8:30 am for Workshop.

TENTATIVE RUNNING ORDER:

Instinct begins at 1:00 PM, followed by Novice thru to Master class.

CONFIRMATION OF ENTRY: The receipt of entries will be confirmed for those providing a return e-mail address on their form.

VALIDATION OF ENTRIES: Entries must be complete, with entry fees, and signed Participation Agreement included. Entries submitted without this agreement filled in and signed/box checked will be refused participation in the tests and workshop.

REFUND OF ENTRY FEES: will not be refunded after the closing date except for bitches in heat and for injured dogs with vet proof.

EVENT SITE:

Practice & Go and Workshop will be held outdoors on grass/dirt with an outdoor staging/blind area.

Port-a-Potty will be on site.

Bring water, shade and shelter for you and your dogs (E-z Up tent or X-pen). These events will be run rain or shine.

All dogs must be **under control and on a leash** at all times while on trial grounds except while showing.

No flexi leashes are permitted anywhere on the property.

From Toronto or From the East: Exit the HWY 401 westbound to the HWY 410 and go north. Take the extension that connects to HWY 10 north. Continue until you reach King St. Turn left. Stay on King St. into Terra Cotta. At the stop sign in Terra Cotta go straight through, staying on King St. After the bend in the road to the left you are now on Winston Churchill Blvd. You will cross the bridge over the Credit River and continue up the hill. Just past the top of hill you will see #12900 on your right. If you reach the 80 km speed limit sign you have passed our driveway.

NOTE: the house numbers on the left and right sides of Winston Churchill do not follow numeric order, so look at the numbers on the west side!
