Entries must be **MAILED** to the address of the Test Secretary. Faxed, emailed, couriered or hand delivered entries are not accepted. Each entry must be on an official CKC entry form and must be sent in a separate envelope. Entries received before the Acceptance date will be returned. Once the trial limit has been reached, the trial will be considered full. All remaining entries will be assigned a position on an "Alternate List" in the order received. The Test Secretary will notify all entrants of their acceptance into the test, or of their position on the alternate list.

Entry fees shall not be refunded after the closing date in the event that a dog is absent, disqualified, excused by a veterinarian or judge or barred from competition by action of a Trial Committee or because it has been entered incorrectly. Entry fees will only be refunded if there is a dog from the alternate list able to fill the spot. Entries will be refunded within 10 days from the tracking test to those on the alternate list who did not participate in the test. Bitches in season may compete and will run last

PLEASE NOTE TO NON CKC MEMBERS

Effective January 2011, an annual non-member participation fee for awards & titles will be charged to a Canadian non-member of CKC. The fee will match the ERN fee. In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or pay the non-member participation fee of \$55.00 +HST. Failure to comply within 30 days of notification will cause all awards & titles to be cancelled. If you are a CKC member, this does not apply to you, but your CKC membership number must be included in your entry.

AWARDS: WDOC will award a rosette to the passing teams
