Jeremy Browne, ON, Canada



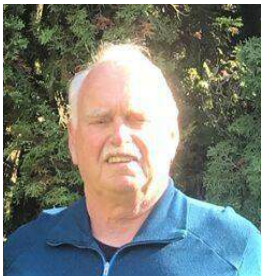
I first became involved with purebred dogs in 1975 when my wife and I began to breed Alaskan Malamutes under the Byeyo Kennel. In 1994 I became involved in Australian Cattle Dogs. We have produced and owned over 100 champions including multiple Best in Show, Reserve Best in Show, Best Puppy in Show, Best Baby Puppy in Show. National Specialty winners, Westminster winner 2X. Top Twenty Winner at the American National Specialty. Top dogs in their breeds for many years.

I have also owned a Sealyham Terrier, Smooth Fox Terrier, and live with a Border Collie and a top winning Whippet.

I started my judging career in 1994 and have just achieved All Breed Judge status in Canada and the USA. I have judged across Canada, in the United States, Italy, Spain, Columbia and England. I have been President of the London Canine Association (the oldest kennel club in Canada) for the past 5 years.

My passion for the past 49 years has been purebred dogs whether it be in the whelping box, show ring or judging.

Robert Terry Gains, BC Canada



As a teenager I wanted a horse, my parents would only go for a dog. The dog of my choice was a black Labrador Retriever, Suzie. This started my association and love with the breed. I became involved with the sport of dog obedience and conformation shortly after. I have trained and competed in Obedience and Conformation for the past fifty-five years. I have been lucky enough to obtain, ten OTCH titles and I'm working on number eleven.

My wife and I have breed Labradors for thirty-five years using the Gainspride prefix. Gainspride Labradors have produced Specialty and Best in Show winners. We have had Miniature Pinschers,

this was a new learning curve. Min Pins were not Labradors. Learning to see things from a small dogs perspective gave me new insight into both conformation and obedience.

I have been judging Obedience for twenty-seven years and Rally-O since its addition to CKC. In conformation I'm approved as an all-breed judge and have been judging for 20 years, I have judged in all 10 provinces and in the United States.

Most recently, I have been working with a fire cracker Papillon who is testing my knowledge every day in the Obedience and Rally Obedience rings. I continue to strive to improve my skills both as a competitor and judge and look forward to many more years in the Obedience and Rally rings.

JUVENILE SWEEPSTAKES

THURSDAY August 21, 2025 @ 6:30 p.m. MOUNTAIN DAYLIGHT TIME

Judge: Karen Brearley

Juvenile Sweepstakes is open to all puppies six months and under eighteen months of age regardless of the place of birth. All puppies must be entered in a regular class in the show on the same day. Dogs will be judged in one of the following six classes (divided by sex)

Junior Puppy Male/Female – 6 months and under 9 months
Senior Puppy Male/Female – 9 months and under 12 months
Yearling Male/Female – 12 months and under 18 months

For final judging, the first place Juvenile in each of the classes will be brought together for Best in Sweepstakes. A rosette will be awarded to Best In Sweepstakes.

Prizes: Best in Sweepstakes 5% of total entries
First in each class 25% of entry fee for the class
Second in each class 20% of entry fee for the class
Third in each class 15% of entry fee for the class
Fourth in each class 10% of entry fee for the class

The remaining 25% of the entry will be retained by Club to defray costs.

GENERAL RULES GOVERNING THESE SHOWS

It is the responsibility of the Exhibitor to be familiar with the rules pertaining to the event in which they are competing. Copies of the Conformation Rule book are available from the CKC, 400 200 Ronson Dr., Etobicoke, ON M9W 5Z9

1. The Club reserves the right to remove any person from the show. The Show Superintendent shall have full control of the above shows and trials, which will be governed by CKC rules.
2. Any dog excused by the Show Superintendent or the Show Veterinarian for any reason shall not, after being excused, compete in any class for any award for the balance of the show.
3. The show committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of accident, or other misfortune, to either dogs, exhibitors or patrons.
4. A Judge or any person participating in any capacity at a Dog Show held under CKC Rules shall not be subjected to any indignity of any kind during the progress of the show and it shall be the duty and obligation of the Club holding the show to see that this rule is effectively carried out. The Show Superintendent shall promptly report to the CKC any infringement of the rules, and the Discipline Committee shall have the power to take such action as it deems fit on receipt of a report indicating that this rule has been violated.
5. Exhibitors are solely responsible for the conduct or actions of their animals while they are on the show grounds.
6. **DOGS MUST BE READY FOR JUDGING.** The Club will not be responsible for and is not obligated to provide any service for notifying owners or agents of breed or class judging. No ring shall be held up waiting for exhibitors or handlers. Exhibitors & Handlers with more than one dog shall have substitute handlers available so the judging will not be delayed. All start times are **MOUNTAIN DAYLIGHT TIME.**
7. The owner of a dog entered in these shows is entirely responsible for any error in entering his/her dog, regardless of how or by whom the entry was made.
8. A dog once disqualified for any reason at a championship show held under these rules cannot again be shown at a show held under these rules until the dog has been examined by an official committee appointed by the CKC and the committee finds the dog is free from the condition which prompted the disqualification. Application for reinstatement must be accompanied by a fee of \$50.00 plus GST which shall be forfeited to the CKC if the examining committee is satisfied that the dog should remain disqualified. All awards earned at a dog show in violation of this rule shall be canceled by the CKC and the owner of the dog is subject to disciplinary action.
9. Exhibitors and handlers will be responsible for their dogs and for their equipment left at the Show Grounds.
10. For the benefit of the health of animals and the pleasure of the exhibitors and spectators we insist upon keeping our grounds and buildings as clean as possible. Exhibitors are responsible for cleaning up after their dogs. Please exercise your dog **BEFORE** taking it to the Judging ring. Dogs are to be exercised in the designated areas only, not in the vicinity of the ring areas.
11. No entry fee will be refunded if the Show cannot open or be completed by reason of riots, civil disturbances, fire, and Act of God, public emergency, act of public enemy, strikes or any other cause beyond the control of the Club.
12. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused by the Veterinarian or Judge, or barred from competition by action of the Show Committee.
13. If you are unable to attend due to COVID or any other ailment, it is your responsibility to find an alternative handler for your dog. No refund will be given.
- 14 **CDKC has a zero tolerance** of abuse of any description involving any person involved with the CDKC shows, including spectators. individuals will be asked to leave the show grounds premises immediately and for the remainder of the event (no refunds).

15. Because of incidents with the RV Camping on the Soccer Field, at the 2024 Dog Shows, and neglect for sprinkler heads and grassed areas the Club will be collecting \$50.00 (refundable after inspection before leaving) for any damages to the facility during your stay.





CLASSIFICATION-CONFORMATION

REGULAR CLASSES

JUNIOR PUPPY - 6 months & under 9 months on the day of the show

SENIOR PUPPY- 9 months & under 12 months on the day of the show

12-18 MONTH CLASS - for dogs 12 months of age and under 18 months of age on the day of the show

CANADIAN BRED - for dogs born in Canada, Champions in any country excluded.

BRED BY EXHIBITOR - shall be for dogs owned and handled in the ring by the breeder.

OPEN CLASS - shall be for all Dogs.

SPECIALS ONLY – Dogs which have a recorded CKC registration, Event Registration Number (ERN) or Miscellaneous Certification Number (MCN) and have attained the required points for Championship status. All awards earned at the show will be cancelled if it is found that a dog is not registered or has not completed the requirements for a CKC Championship

The following classes will be provided, divided by sex. Dogs entered in this class will compete for Best of Breed, Best of Opposite Sex and Best Puppy if eligible.

NON-REGULAR CLASSES

VETERAN CLASS - In this optional class for All Breed Shows, dogs must be 7 years of age and over on the day of the show. Dogs entered in this class may be spayed or neutered. The awards for this class are: Best Male Veteran and Best Female Veteran Best Veteran in Breed Best Veteran in Group Best Veteran in Show. A Veteran awarded Best Veteran in Breed is not required to stay to compete for Best Veteran in Group. A Veteran awarded Best Veteran in Group is not required to stay to compete for Best Veteran in Show.

BABY PUPPY CLASS – Dogs 4 months of age and under 6 months of age on the day of the show. The award for this class are: Best Baby Male and Best Baby Female Best Baby Puppy in Breed Best Baby Puppy in Group Best Baby Puppy in Show

EXHIBITION ONLY - Dogs entered in this class may not compete in the regular breed classes.

OBEDIENCE:

PRE-NOVICE – shall be for any dog which has not earned the title of P.C.D. (Pre-Companion Dog) in Canada. Dogs in this class may be handled by the owner or any other person.

NOVICE “A” - The Novice A class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed that has not earned the title of CD. Only one dog per handler is allowed in this class, and that person must handle the dog in all exercises. The handler of any dog in this class must be the owner, co-owner or a member of their immediate families, and must be eligible to handle under Section No person who has exhibited a dog that has earned a CDX title shall be allowed to handle a dog in this class. When a dog is wrongfully entered in this class, any score awarded will be cancelled

NOVICE “B” - The Novice B class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed that has not earned the title of CD. Dogs in this class may be handled by the owner or any other person. A person may enter more than one dog in this class. The same handler must handle each dog in all seven (7) exercises unless he has two (2) or more dogs entered. In such cases, he must have an additional handler for each extra dog when they are judged together in the group exercises. No dog may be entered in both the Novice A and Novice B class at any one trial.

Novice C class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed that has earned the title CD or any higher obedience titles. Dogs in this class may be handled by the owner or any other person. A person may enter more than one (1) dog in this class. The same handler must handle each dog in all six (6) exercises unless he has two (2) or more dogs entered. In such cases, he must have an additional handler for each extra dog when they are judged together in the group exercises. Dogs may compete in the Novice C class indefinitely. Scores earned by dogs entered in the Novice C class are not eligible for High in Trial and do not qualify a dog for any title. Dogs may be entered in the Novice C class in addition to any other official or unofficial classes for which they are eligible

INTERMEDIATE NOVICE - as per Obedience Trial Rules & Regulation

OPEN “A”- The Open A class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed that has earned the title of CD but has not earned the title of CDX. The handler of any dog in this class must be the owner, co-owner or a member of their immediate families. Only one (1) dog per handler is allowed in this class and that person must handle the dog in all exercises. Any person who has exhibited a dog that has earned an OTCH title may not handle a dog in this class. When a dog is wrongfully entered in this class, any score awarded will be cancelled.

OPEN “B” - The Open B class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed that has earned the title of CD. Dogs that have earned the title of CDX or any higher obedience titles may enter in the Open B class. A dog may also be entered in the Utility class in the same trial. Dogs in this class may be handled by the owner or any other person. A person may enter or handle more than one (1) dog in this class. The same handler must handle each dog in all seven (7) exercises. Prior to the start of judging, the judge will choose which of the six (6) numbered routines is to be performed. These choices will not be disclosed to exhibitors until they are posted at ring side at least 30 minutes before the start of each class and never more than one hour before the start of the trial. In future assignments, judges are required to alternate the six (6) routines so they will be used approximately the same number of times.

UTILITY “A” – The Utility A class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed that has earned the title of CDX but has not earned the title of OTCH. Any person who has exhibited a dog that has earned a MOTCH title may not handle dogs in this class. The handler of any dog in this class must be the owner, co-owner or a member of their immediate families. Owners may enter more than one (1) dog in this class. The same person must handle the dog in all exercises. When a dog is wrongfully entered in this class, any score awarded will be cancelled.

UTILITY “B” – The Utility B class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed that has earned the title of CDX or OTCH. Dogs in this class may be handled by the owner or any other person. Owners may enter more than one (1) dog in this class. The same person must handle the dog in all exercises. No dog may be entered in both the Utility A and Utility B classes at any one trial. Prior to the start of judging, the judge will choose which of the six (6) numbered routines will be performed. This choice will not be disclosed to exhibitors until it is posted at ring side at least 30 minutes before the start of the class and never more than one hour before the start of the trial. In future assignments, judges are required to alternate the six (6) routines so that each will be used approximately the same number of times

Veterans Class- The Veterans class shall be for any dog that has earned the title of CD or higher and is seven (7) years old or older on the day of the trial. 16.5.2 The exercises shall be performed and judged as in the Novice classes. The owner or any other person may handle a dog in this class. A person may enter more than one dog in this class. The same handler must handle each dog in all six (6) exercises unless he has two (2) or more dogs entered. In such case, he must have an additional handler for each extra dog when they are judged together in the group exercises.

RALLY OBEDIENCE

RALLY NOVICE A: Dogs competing in this class may not have earned the R. N. title or any CKC Obedience title other than P.C.D. No handler who has exhibited a dog through its CKC C.D.X. title shall be eligible to enter this class. The handler of any dog in this class must be the owner, co-owner, or a member of their immediate families. A person may enter more than one dog in this class. All exercises are judged on leash, and all dogs must enter and leave the ring on leash.

RALLY NOVICE B: Any dog may compete in this class until a qualifying score in the Rally Advanced Class is earned. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class. All exercises are judged on leash, and all dogs must enter and leave the ring on leash.

RALLY INTERMEDIATE: The Rally Intermediate Class is an elective class and earning the title is not a requirement to enter Rally Advanced Classes.(CKC rules, 10.1.2) This class shall be for dogs that have earned the R.N. title. A dog completing the R.I. or any other obedience or rally titles may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class. This class (performed on leash, no jumps, no A or B division) may be entered indefinitely. Judges would ordinarily use the same course for it as for their Advanced Classes, substituting one other exercise for the jump required in Advanced.

RALLY ADVANCED A: This class shall be for dogs that have won the Rally Novice (R. N.) title but have not won the Rally Advanced (R. A.) title or any CKC Novice Obedience title. The handler of any dog in this class must be the owner, co-owner, or a member of their immediate families. A person may enter more than one dog in this class. A dog may continue to compete in this class after the owner has been notified by at least 2 different judges that the dog has won 3 qualifying scores in this class. However, a dog may not be entered or exhibited in this class in any rally trial after the owner has received official notification from the CKC that the dog has won the title. All dogs must enter and leave the ring on leash.

RALLY ADVANCED B: This class will be for dogs that have earned the R.N. title. A dog completing the R.A. title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class. All exercises are judged off leash. All dogs must enter and leave the ring on leash. No dog may be entered in both Rally Advanced A and Rally Advanced B at any one trial.

RALLY EXCELLENT A: This class shall be for dogs that have earned the R. A. title, but have not earned the R. E. title or any CKC Obedience title other than P.C.D. No handler who has exhibited a dog through its CKC C.D.X. title shall be eligible to enter this class. The handler of any dog in this class must be the owner, co-owner, or a member of their immediate families. A person may enter more than one dog in this class. All exercises are judged off leash. There is also a sit stay exercise after the finish sign. All dogs must enter and leave the ring on leash.

RALLY EXCELLENT B: This class will be for dogs that have earned the R.A. title. A dog completing the R.E. title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class. All exercises are judged off leash. There is a sit stay exercise after the finish sign

RALLY MASTER: This class will be for dogs that have earned the R.E. TITLE . A dog completing the R.M. title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class.. A person may enter more than one dog in this class

*All dogs must enter and leave the ring on leash.

*No dog may be entered in both Rally Excellent A and Rally Excellent B at any one trial.

*No handler who has exhibited a dog through its C.K.C. Obedience CDX title shall be eligible to enter the 'A' class in Rally Novice, Advanced or Excellent.

CHAMPIONSHIP POINTS

15.1.2 The schedule to be employed in the determination of the number of points awarded Winners shall be as follows:

Dogs Competing*	1	2	3 - 5	6 - 9	10 - 12	13 +
Points Awarded	0	1	2	3	4	5

*Includes the dog awarded Winners

In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall not be included in the calculation for championship points.

15.1.8 In addition to championship points allocated at the breed level, a dog awarded Best of Breed which also places in the regular Group competition shall be credited with the following additional points provided that a dog was defeated at the Group level.

15.1.9 A dog may not be credited with more than five (5) championship points in a single show.

15.1.10 Permission shall be granted to a club or clubs to hold shows in such a way that any dog may earn three (3) sets of championship points on the same day, provided that one or more of those sets of points is awarded at a specialty for that breed or group.

15.1.11 A dog awarded Winners that also places Best in Show at an all-breed conformation show shall be credited with five (5) championship points inclusive of any points earned at the breed and group level.

15.1.12 In order for a dog to be recognized as a champion and its owner provided with a championship certificate, the dog must: (a) earn at least 10 championship points under at least three (3) different judges;

(b) be registered in the records of the CKC, have an Event Registration Number (ERN) or Miscellaneous Certification Number (MCN);

(c) have earned at least one 2-point win either at the breed or group level.

15.1.13 The Board interprets the words “earn at least 10 championship points under 3 different judges” to mean: (a) Three (3) or more Winners awards at not less than three (3) different shows, under three (3) different judges at the breed level; (b) each of the three (3) judge’s awards must be one or more championship points won at Winners, Best of Winners, Best of Breed or group placing; (c) all points required for championship status may be earned at Winners, Best of Winners, Best of Opposite Sex, Best of Breed or group placing.

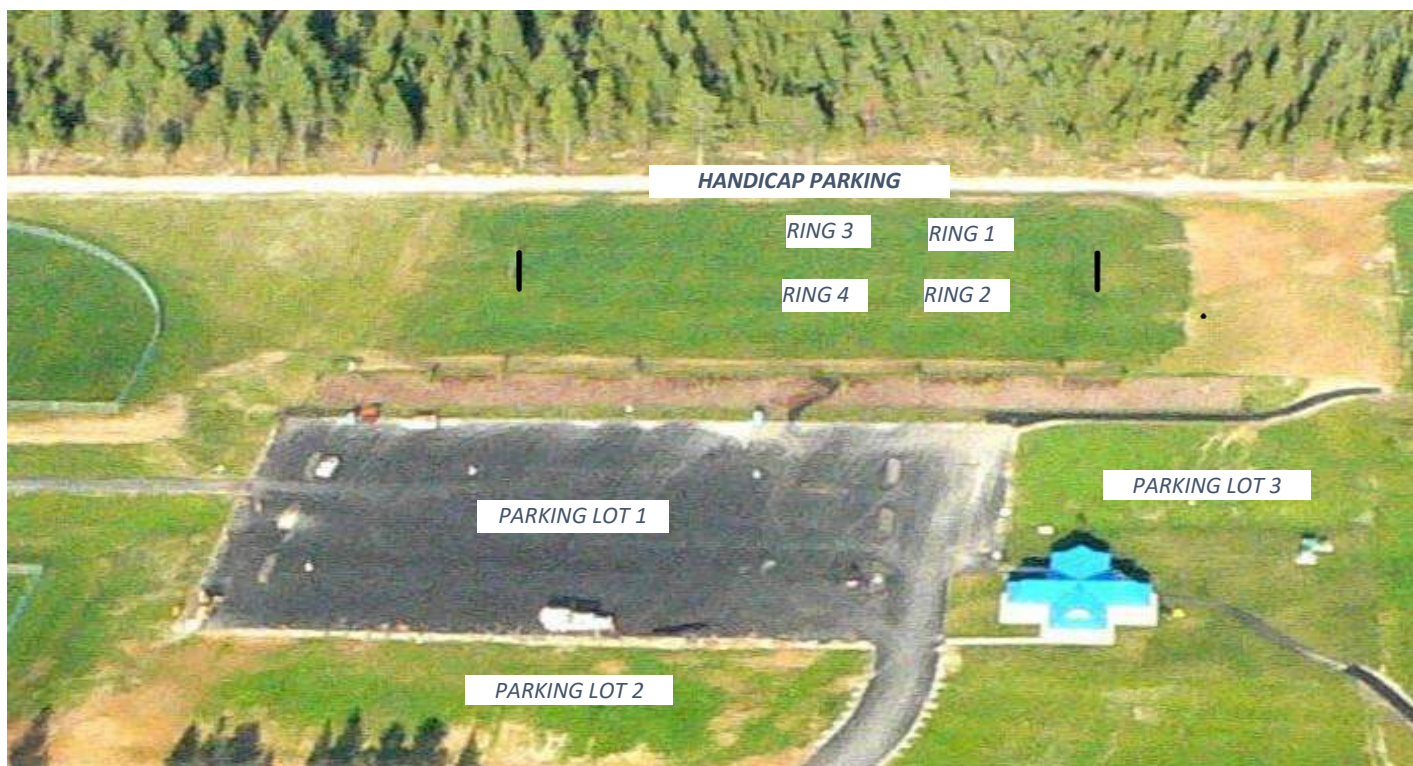

NEW PARKING RULES FOR 2025

It is unfortunate that the Cranbrook & District Kennel Club has to increase camping and tenting fees for 2025. The City of Cranbrook has substantially increased their fees (new By-laws for overnight RV camping) within the City boundaries, at all recreation facilities which includes Moir Park.

Subsequent to the fee structure the City has also implemented new rules for parking at Moir Park, where there will not be overnight RV parking on the upper level soccer areas. There will be several spaces for handicap parking along the west roadway but these exhibitors will have to be escorted on and off the area so that they do not damage any sprinkler heads or water lines.

Overnight RV parking will be restricted to the paved parking lot 1 and two grassed areas, lots 2 & 3. Lot 2 below the parking lot adjacent to the dog park and lot 3 on the grassed area north of the parking lot near the building holding the washrooms and kitchen.
