As per the CKC rules, it shall be the duty and obligation of the test giving club to see that a judge, club official, or any participant at an event held under the CKC rules, is not subject to indignities of any kind.

The Rottweiler Club of Canada will use all reasonable care to guarantee the safety of dogs and persons at the test; however, neither the RCC nor any individual will accept the responsibility for loss or injury however caused to any dog, person, or property.

ENTRY FEES (including HST): UTD Test..... \$75.00

LISTING FEES: A Listing Fee of \$9.80 must accompany the entry form of a dog for which a CKC individual registration number or Event Registration Number (ERN) is not shown on the entry form.

Mail all entries and fees to the Test Secretary. All cheques or money orders should be made payable to the Rottweiler Club of Canada. No post-dated cheques will be accepted.

**CLOSING DATE:** Entries must be received to the Test Secretary by the closing date. The Club cannot accept entries received after this date and time. After the closing date, the Club will send out acceptance letters, advising entrants of the status of their entries.

**LIMIT OF ENTRIES : 4 UTD Tracks**

All entries received prior to the closing date will be acknowledged by mail/email, accompanied by a map, and entered in entry draw. Entries not drawn shall be assigned a position on an "Alternate List" in the order received. Entries from the Alternate List may fill any absentee spaces up until one hour before the start of the Tracking Test. The person making the entry shall be notified of their position on the alternate list. Entries will be refunded within ten (10) days of the Tracking Test to those on the Alternate List who did not participate in the Test.

A dog must have attained a Canadian Tracking Dog title (TD) to be eligible to enter an Urban Tracking Dog Test (UTD).

**ATTENTION USA EXHIBITORS** If the dog is foreign born and foreign owned and enters Canada for the sole purpose of entering CKC events, it may be entered at a tracking test with an Event Registration Number (ERN). Such number must be applied for within 30 days of the test. Failure to do so will result in the cancellation of all awards and prizes. **\*\*NEW\*\*** An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. The fee will match the ERN fee. In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled. These fees apply to dogs wholly owned by non-members
