ENTRIES: Please complete **one entry form per dog, per test** in which you wish to enter your dog(s). All entries must contain complete information as required by the CKC rules. All entries must be accompanied by the entry fee in full, and all listing fees (\$10.50 including GST) where applicable. A listing fee as established by the CKC must accompany the entry of a dog for which a CKC individual registration number is not shown on the entry form or ERN notice. Scratches will be refunded for a bitch totally in season

Kathy has placed Master, Senior and Junior Hunt Titles on many of her dogs. In addition to hunt tests, Kathy has experience in the pet therapy program and conformation ring. Kathy currently owns three Master Hunter dogs, Edge, Siren and Krash, all with multiple performance titles, and Iszie, a two-year-old that is beginning her journey. Kathy spends time between Comox, BC, Swamp Dog Farm, a retriever training property which she co-

owns, and Calgary. In her spare time (ha) she enjoys cycling, gardening, upland hunting, travelling and good wine.

SHELLY CAMPBELL, Saskatoon, SK



Sixteen years ago, Mark and I welcomed a NSDT Retriever into our family. We had researched breeds to find the right fit for an outdoorsy lifestyle at our cabin and decided a Toller would be a great addition. Well, the Toller puppy excelled in his puppy class and we were encouraged to try Competitive Obedience and shortly after added another Toller to the family. Mark and I competed in competitive obedience together for five years and were then convinced to enter our dogs in the conformation ring. After obtaining Championships, the versatility bug bit us and we decided to dip our toes into retriever work. We got more than our toes wet! We now hunt over our Tollers, mostly ducks and grouse while continuing to compete in WC and Hunt Tests, as well as training our dogs to upper levels of Obedience (a recent MOTCh with Ribbon), Rally, Conformation and even a wee bit of Barn Hunt. Four of our Tollers have received the Dobirstein Award for their Versatility.

Sadly, Sully's Hunt Test and hunting career was cut short this spring due to cancer, but I was thrilled to have Qualified with him at the Master Hunt level, last summer. DIRECTIONS TO TEST SITE

The Wild Rose Hunting Retriever Club Grounds are approx. 45 minutes NE of Calgary AB. Signs will be posted.

From the South – Host Hotel Carriage House Inn.


Option 1: Go north on Macleod Trail for 2.9 km. Turn Right onto Glenmore Trail East. Use the middle lane to take the Deerfoot Trail North exit. Continue north on Deerfoot for 27.2km. Take exit 275 for Hwy 566 East towards Kathyrn (Just past Cross Iron Mills, Costco will be on your right). Continue on Hwy 566 east for 17.2km and the test grounds will be on your left.

Option 2: Go north on Macleod Trail for 2.9km. Turn right onto Glenmore Trial East. Continue on Glenmore Trail East for approximately 9.7 km and take the exit to merge onto Stoney Trail North (AB-201). Go North on Stoney Trail for 17.9 km and take exit 68 for Country Hills Blvd (Hwy 564). Keep right at the fork to go east. Continue east for 3.4km and turn left onto Range Road 284. Go North on RR 284 for 6.5km. Turn right onto Hwy 566. Go east for approximately 7.9km and the test grounds will be on your left.

Option 3: (**To avoid rush hour traffic in the City**) Go south on Macleod Trail for approximately 8.5 kms to Hwy 22X-East. Continue on 22X East to Range Road 273 for approximately 28 km signs for Langdon. Turn Left on RR 273 and continue north for 8 km through the Town of Langdon. At the 4-way stop continue north on Hwy 9 for approximately 26 kms to Hwy 566 signs for Kathryn. Turn Left at Hwy 566 and continue west for 5 km. The test grounds will be on your right.

From the North - Airdrie

Go south Hwy 2 to Balzac. Take the exit to Hwy 566 east towards Kathyrn (Cross Iron Mills and Costco will be on your right). Continue east on Hwy 566 for 17.2 km and the test grounds will be on your left.



This will be well signed so don't panic. Please respect the test grounds. Drive and park as directed while on the land. Clean up after yourself and your dogs. Please note that vehicle access is restricted to designated main roads only.

GENERAL INFORMATION

- 1. Copies of the Working Certificate Test Rules and Regulations are available from the Canadian Kennel Club, suite 400, 200 Ronson Drive, Etobicoke, On M9W 5Z9.
- 2. Entries must be typewritten or clearly printed. Owners are responsible for errors on entry forms. The NOVA SCOTIA DUCK TOLLING RETRIEVER CLUB OF CANADA does not assume any responsibility for incorrect information or errors due to illegibility of information on any entry form. Make cheques payable to NOVA SCOTIA DUCK TOLLING RETRIEVER CLUB OF CANADA.
- 3. A separate Entry Form for each dog in each test is required (official CKC Entry Form).
- 4 Entry fees <u>will not</u> be refunded after **11:59 PM MDT July 24, 2019**. If a dog is absent, disqualified, excused by a judge or barred from competition by action of the Test Committee or the Canadian Kennel Club, or because it has been entered incorrectly, or if it is impossible to open or complete the test, no refunds of entry will be made.
- 5 In the event of a mail strike, please courier, complete online, or hand deliver entries, to the Test Secretary prior to the closing date.
- 6 No post-dated cheques will be accepted.
- 7 "Day of Event Entries" will not be accepted
- 8 Running order will be determined by random selection after the close of entries. Running order will be available no later than 8:00 PM MDT on Tuesday, July 30, 2019.
- 9 Bitches in season shall not be eligible for entry and shall not be allowed on the test grounds.
- 10 Ducks will be used in all stakes. Wingers may be used in any stake.
- 11 For the WC, WCI and WCX Tests, all land retrieves for all tests will be run before the water tests.
- 12 All throwers, Judges, competitors and spectators should wear dark or camouflaged clothing.
- 13 Any dog not appearing within 15 minutes of being called to the line by the Marshall may be disqualified.
- 14 Entry and listing fees paid for any dog withdrawn because of estrus, injury, illness or death shall be refunded in full. An appropriate veterinary certificate must be given to the Test Secretary <u>BEFORE</u> the start of the test to qualify for a refund.
- 15 Effective Jan. 1992, all dogs that are foreign born and foreign owned and enter Canada for the sole purpose of entering CKC events no longer require a CKC registration number but will require an event registration number (ERN). Each dog must have its own number. To obtain an ERN number, send a photocopy of the dog's foreign registration certificate with cheques or VISA/MasterCard number. Provide your complete address for return of ERN number. Cost \$62.40 (including GST) ERN numbers must be applied for within 30 days of the FIRST day of entering a CKC event.
- 16 The Nova Scotia Duck Tolling Retriever Club of Canada and its members will use due care and diligence for the welfare of dogs and exhibitors, BUT will not be responsible for, nor assume any liability in the event of an accident, injury or other misfortune to either dogs, exhibitors or patrons.
- 17 Electric Collars (either dummy or live) as well as prong or pinch type collars <u>shall not</u> be worn by any dog on the test grounds at any time during the event.
- 18 There shall be no training of dogs on the test grounds, except for single training bumpers, which are thrown by hand by the trainer, within 24 hours of the commencement of the event or an anytime during the event.
- 19 All qualifying dogs will receive a rosette.

ATTENTION: CANADIAN EXHIBITORS CKC Non-Member Participation Fee

- a) An annual non-member participation fee for awards and titles will be charged to a Canadian nonmember of CKC. The fee is \$62.40 + GST.
- b) In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled.
- c) "these fees apply only to dogs wholly owned by Canadian resident non-CKC members and are not applicable to CKC members"

*Please note that the CKC Membership Application and the Non-Member Participation Fee forms are available on the website, http://www.ckc.ca under CKC Services and then Forms On-line. If submitting a Membership Application, please ensure that you also complete the Non-Member Participation Fee form so that we are aware of the dogs involved. This fee does not have to be paid before entering this event.

RELEASE AND INDEMNIFICATION

By entering this Test (as handler, spectator or in any other capacity) each participant agrees to assume all risks and hazards incidental to these Tests and agrees to release and to save harmless and indemnify the NOVA SCOTIA DUCK TOLLING RETRIEVER CLUB OF CANADA and its members, any volunteer and the owner(s) and/or lease(s) of any property upon which the Test may be held together with their officers, agents, employees and representatives from all claims, actions, costs, expenses and demands in respect to death, injury, loss or damage to the person or property of the participant howsoever caused, arising out of or in connection with the participants use or entry upon the property. It is understood that this agreement is binding upon the participants, his or her heirs, executors and assigns.

NOTICE TO EXHIBITORS

Any person participating in any capacity at a Hunt Test or Working Certificate Test held under the CKC rules and regulations shall not be subjected to any indignity of any kind during the progress of the tests and it shall be the duty and obligation of the NOVA SCOTIA DUCK TOLLING RETRIEVER CLUB OF CANADA to see that this rule is effectively carried out. On report to the NOVA SCOTIA DUCK TOLLING RETRIEVER CLUB OF CANADA of an alleged indignity of any kind the Test Chairman will report the infringement to the CKC and the Test Committee shall forthwith conduct an investigation and shall have the power to take action as it deems fit on receipt of a report indicating that this rule has been violated.
