ENTRY FEES

\$32.00	First class entered in each trial
\$112.00	Entries for all 4 trials with the same dog
\$27.00	Additional class entered with the SAME DOG in the SAME TRIAL i.e., the same dog entered in both Advanced B and Excellent B, or same dog entered in both Excellent B and Master
\$104.00	Entries for all 4 trials in an additional class with the same dog.
\$40.00	Day of Trial Entries – each class entered in each trial – CASH ONLY
\$10.00	Exhibition Only
\$10.50	TCN Fee for EACH TRIAL. This is only paid if the entered dog is eligible for, but does not possess, individual registration with the Canadian Kennel Club. A Temporary Competition Number is also required for entry. See CKC.ca for details and application form

The entry of a dog at a trial must be accompanied by the entry fee. Conditional entries or entries accompanied by post-dated cheques will not be accepted.

CKC Rule 6.16...no dog may be entered in any class for which it is not eligible at the time entries for the trial close

The club must reject an incomplete entry form and promptly return it to whoever submitted it, be it the owner, lessee, or authorized agent.

Tendering of a dishonoured cheque in payment of entry fees shall be considered non-payment and is an offence punishable by disciplinary action and cancellation of awards by the Canadian Kennel Club.

CKC Rule 4.42...Once a limited entry trial has closed, entry fee will not be refunded for any reason other than a bitch being in season.

CKC Rule 6.5.2. Entry fees will be refunded for a bitch in season providing the Trial Secretary receives, on or before the date of the trial, a veterinarian's certificate declaring that the bitch was in season within the 10 days period preceding the trial.

CKC Rule 4.1.7.. Day of trial entries must be IN PERSON at least 1 hour before the start of the trial

Attention Foreign Exhibitors Please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted; however, they are to be payable in Canadian funds. If you send a cheque in US funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please do not mark cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks. To simplify the process, we urge that you purchase bank drafts or money orders payable to Forbidden Plateau Obedience & Tracking Club in Canadian funds

Rules & Regulations

It is the responsibility of each competitor to be familiar with and abide by the Canadian Kennel Club Obedience Trial Rules and Regulations, effective January 1, 2025 which can be found on the CKC website, WWW.CKC.ca

Discipline: Forbidden Plateau Obedience & Tracking Club reserves the right to remove any person from these trials. The Trial Chair shall have full control of this event which will be governed by the Canadian Kennel Club rules. It shall be the duty and obligation of the trial-giving club to see that a judge, club official, ring steward, volunteer or competitor at a trial held under the CKC Rally Obedience Trial Rules and Regulations, is not subject to indignities of any kind. The Rally Obedience Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

Females in Season: When a bitch comes into season after entry of the bitch has been submitted to the trial secretary, a veterinarian's certificate, certifying that the bitch was in season within the 10-day period preceding the trial must reach the Trial Secretary on or before the date of the Trial. The entry fee, service charge and listing fee will be refunded.

Non-Member Participation Fee: Canadian Resident non-CKC members competing with a wholly owned dog cannot win an award or title unless they pay a non-member participation fee or a membership fee to the CKC. The Canadian Resident Non-member Participation Fee is \$59.40 plus GST. These fees apply only to dogs wholly owned by non-CKC members and are not applicable to CKC members.

Change of Entry: A dog may be moved from one official class to another within the same trial. A dog that has fulfilled the requirements for a title in accordance with the CKC Obedience Trial Rules, may be moved to the next level of competition. The transfer must be submitted to the Trial Secretary on the appropriate form by the owner or handler AT LEAST THIRTY MINUTES PRIOR TO THE COMMENCEMENT OF THE TRIAL, schedule permitting.

PLEASE NOTE THAT SMOKING IS PROHIBITED WITHIN THE TRIAL PRECINCTS.

Rules Governing These Trials

- 1. Dogs must be always kept under control and on leash except for within the judging ring.
- 2. Dogs are not allowed in the building.
- 3. Collars other than those specified in CKC Obedience and Rally rules are not allowed within the venue. Violation of this rule may result in removal of the dog from further competition at the trial.
- 4. Forbidden Plateau Obedience & Tracking Club will use all reasonable care to ensure the safety of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of accident, loss or other misfortune to dogs, exhibitors, or patrons. It is distinctly understood that the welfare and conduct of an exhibitor's child is to be the sole responsibility of the exhibitor.
- 5. If for any reason beyond the control of the Club, it is impossible to open or complete the trials no refund of entry fees will be made.
- 6. Judges are not required to wait for dogs. It is the responsibility of each handler to be ready with their dog at ringside when required, without waiting to be called.
- 7. Eligibility to enter specific rally obedience classes is detailed in the Obedience and Rally Obedience Trial Rules and Regulations. Entrants should ensure they are entered in the correct class. FPO&TC will not be held responsible for incorrect entries.
- 8. Every dog entered in an approved rally obedience trial must be one of the following: registered with the CKC; have an Event Registration, Performance Event, Canine Companion, or Temporary Competition number; or, have a Miscellaneous Certification number if it belongs to a CKC listed breed.
- 9. Please keep the building and grounds clean. Please pick up after your dog.

RALLY OBEDIENCE CLASSES

No dog may be entered in both the "A" and "B" Class at the same level in any one trial.

Rally Novice A

Dogs competing in this class may not have earned the R.N. title or any CKC Obedience title other than P.C.D. No handler who has exhibited a dog through it CKC C.D.X. or CKC RA title shall be eligible to enter this class. The handler of any dog in this class must be the owner, co-owner, or a member of their immediate families. A person may enter more than one dog in this class.

Rally Novice B

Any dog may compete in this class until a qualifying score in the Rally Advanced Class is earned. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class.

Rally Intermediate

This class shall be for dogs that have earned the R.N. title. A dog completing the R.I., or any other obedience or rally titles may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class.

Rally Advanced A

This class shall be for dogs that have earned the R.N. title but have not earned the R.A. title or any CKC Obedience title other than P.C.D. No handler who has exhibited a dog through its CKC C.D.X or CKC RE title shall be eligible to enter this class. The handler of any dog in this class must be the owner, coowner, or a member of their immediate families. A person may enter more than one dog in this class.

Rally Advanced B

This class will be for dogs that have earned the R.N. title. A dog completing the R.A. title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class.

Rally Excellent A

This class shall be for dogs that have earned the R.A. title, but have not earned the R.E. title or any CKC Obedience title other than P.C.D. No handler who has exhibited a dog through its CKC C.D.X. title, CKC RM title, or CKC RAE title shall be eligible to enter this class. The handler of any dog in this class must be the owner, co-owner, or a member of their immediate families. A person may enter more than one dog in this class.

Rally Excellent B

This class will be for dogs that have earned the R.A. title. A dog completing the R.E. title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class.

Rally Master

This class will be for dogs that have earned the RE title. A dog completing the RM title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class.

In consideration of the acceptance of this entry and of the holding of the trials and of the opportunity to have the dog judged and to win ribbons, I (we) agree to hold the Forbidden Plateau Obedience and Tracking Club, their members, directors, governors, officers, agents, superintendents or trial secretary and the owner or lessor of the premises and any employees of the aforementioned parties, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of a dog while in or upon the trial premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim, and I (we) further agree to hold the aforementioned parties harmless from any claim for loss of a dog by disappearance, theft, death or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, theft, damage or injury be caused or alleged to be caused by the negligence of the Club or any of the parties aforementioned, or by the negligence of any other person, or any other cause or causes.

I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in these trials, howsoever such injuries, death or damage to property may be caused and whether or not the same may have been caused and whether or not the same may have alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other person.
