#### NOTICE TO EXHIBITORS

This trial shall be held under the Agility Association of Canada Rules and Regulations. All equipment used in this trial is within standards set out by the Agility Association of Canada guidelines. All dogs over two years must have a card and be measured twice, each time by a different judge, or three times in the case of dogs that are within one inch (over or under) of a height that means a change of jump height.

Exhibitors, through submission of entry, acknowledge that they are knowledgeable of AAC Rules and Regulations, including but not limited to the following:

- This trial is open to all dogs being at least 18 months of age, including purebred and non-purebred, except bitches in season, dogs suffering from any deformity, injury or illness which may affect the dog's physical or mental performance, or dogs exhibiting signs of aggression.
- No leads, collars, food, toys, or other aids or devices shall be permitted on the course at any time, this includes during familiarization.
- It is expressly understood that exhibitors alone are responsible for the behavior of their dog(s) and/or children. Any exhibitor whose dog(s) and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may be asked to leave the show grounds and no refund of fees paid will be made.

# DisciplinaryProcedure

Any handler who is found to abuse a dog in any way at any AAC sanctioned event will be required to leave the site.
