50 Qualifying scores in the Master Excellent Standard Class  
50 Qualifying scores in the Master Excellent Jumpers with Weaves Class  
25 Qualifying scores in the Master Excellent Points and Distance Class  
25 Qualifying scores in the Steeplechase Class

### Selected and Veteran Titles

Titles for Selected include an 'S' at the end of the title e.g. AG.N.S. Titles for Veterans include a 'V' at the end of the title.

## CKC CLASSES

---

**Agility Novice (Standard, Jumpers with Weaves, Points and Distance):** Open to any dog that has not earned a qualifying score in the CKC Agility Intermediate Class. Novice Standard and Novice Jumpers with Weaves will have one set of 6 weave poles, used once.

**Agility Intermediate (Standard, Jumpers with Weaves, Points and Distance):** Open to dogs that have acquired the Agility Novice title but have not yet acquired a qualifying score towards the Agility Excellent title.

**Agility Excellent (Standard, Jumpers with Weaves, Points and Distance):** For dogs that have acquired the Agility Intermediate title but have not yet earned the Agility Excellent title.

**Agility Master Excellent (Standard, Jumpers with Weaves, Points and Distance):** For dogs that have acquired the Agility Excellent title or the Agility Master Excellent title.

**Steeplechase:** One-level, jumpers-style speed course with weave poles and A-Frame. Scoring - time plus faults.

**Jumps & Tunnels:** Entry-level class. One-level jumpers course with no weave poles or contacts. Scoring – time plus faults; refusals and wrong courses are not faulted.

**Divisions – Regular, Selected, Veterans:** A dog may only be entered in one of these divisions in the same trial.

### Selected Classes

Any dog eligible to participate in a CKC agility trial may enter the Selected Class, with the exception of dogs who have run in the Veteran class. In the Selected Classes, dogs jump one height lower than their regular jump height and the Standard Course Time is increased by 10%. Dogs may be entered in the Selected division instead of the Regular division in any trial. For complete details, please see section 8.2. Selected Division in the 2020-01 Agility Rules & Regulations Handbook.

### Veteran Classes

Dogs 7 years or older may be entered into the Veterans division at one OR two heights lower than their Regular jump height and the Standard Course Time is increased by 20%. Dogs entered in Veterans may NOT move back into Regular or Selected. The dog will retain titles and/or qualifying scores accumulated towards titles. Dogs entered in the Veteran division run the same courses as in the Regular division.

## Senior Handlers & Handlers with Disabilities

Senior handlers (65 years and over) and handlers with disability may request a modified course time or a modified points requirement (PAD). See section 2.12 of the 2020 rule book.

## JUMP HEIGHTS

The height of the tire will be 4 inches lower than the other jump heights, except for the 4-inch jump height. For example, if a dog jumps 20 inches, the tire jump will be 16 inches.

Owners are responsible for entering the correct height division. Dogs that run in a height division lower than their correct division will be eliminated. Judges may require any dog to be measured.

## ENTRIES

- 🐾 All dogs must be individually registered with the CKC or eligible for CKC registration.
- 🐾 The entry form must be completed in every respect and exhibitors must abide by any errors made in entering their dogs regardless of how, or by whom, the entry was made.
- 🐾 No entry will be accepted unless accompanied by the entry fee.
- 🐾 Incomplete entries will be returned.
- 🐾 The tendering of a dishonoured (NSF) cheque in payment of entry fees shall be considered non-payment of entry fees and is an offence subject to disciplinary action and cancellation of awards

**MOVE UPS**

A dog earning a title after the closing date may advance to a higher level providing the Trial Secretary is notified one week prior to the trial. Move-ups will be permitted between the Saturday and Sunday trials (not the same day). The move-up form must be completed and handed to the Trial Secretary by the end of the day on Saturday for the Sunday.

**NOTICE TO EXHIBITORS**

- 🐾 The precinct of the trials shall be the ring enclosure and 10 feet surrounding.
- 🐾 Only dogs entered for competition will be permitted in the precinct of the trials.
- 🐾 No provisions have been made for rain or sun. Bring your chair and protection from the weather for yourself and your dog.
- 🐾 Space for tents and crates is limited.
- 🐾 Please do not litter. Please ensure you clean up after your dog.
- 🐾 Dogs must be under control at all times and kept on a leash except in the warm-up area and on the course.
- 🐾 No food or other device will be allowed on the course. The dog may wear a buckle collar, a quick-release collar or no collar on the course. Tags on the collar are not permitted.
- 🐾 Competitors participate at this event at their own risk. The release form must be signed.
- 🐾 All obstacles will conform to CKC specifications.
- 🐾 Club Agilité Canin de St-Lazare reserves the right to refuse entries, subject to CKC rules.
- 🐾 Electronic timing will be used.
- 🐾 Please refer to the covid protocols at the end of this document. The protocols may evolve as the trial dates approach and competitors will be advised. Everyone on the site must adhere to the covid protocols in place on the date of the trial.

**ALTERNATE LIST & REFUNDS**

- 🐾 No entries may be accepted, altered, cancelled or substituted after the closing date, except those cases detailed below.
- 🐾 In the event that the entry limit is reached before the official closing date, an Alternate List will be compiled in the order received. Alternate dogs will be allowed to run in the place of any absent dogs. The owners of alternate dogs which are not able to run shall have the entry fees refunded.
- 🐾 There shall be no refunds in the event that the dog is absent on the day of the trial, or if the dog/handler is dismissed from competition, regardless of the reason for such dismissal, or in the event of inclement weather, other than as provided for below.
- 🐾 Bitches in season are not permitted to compete. When a bitch comes in season after the entry has been submitted, a refund will be made on submission of a veterinary certificate prior to the day of the trial, certifying that the bitch was in season within the 10-day period preceding the trial.
- 🐾 When a dog has become injured after the closing date, a refund will be made on submission of a veterinary certificate prior to the day of the trial, certifying that the dog has sustained injury.

## AWARDS

- 🐾 Rosettes/ribbons from 1<sup>st</sup> to 4<sup>th</sup> place for dogs with qualifying scores in each division and height category.
- 🐾 All dogs with a qualifying score will be awarded a flat qualifying ribbon.
- 🐾 A Club Agilité Canin de St-Lazare special rosette will be awarded for a CKC title achieved at these trials.

## CKC RULES & REGULATIONS – CONDUCT

Section 3.9.1 in the 2020 rule book: It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities of any kind. The Agility Trial Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report that this has occurred.

## DIRECTIONS TO THE TRIAL

**From Montreal** - Hwy 40 West to Hwy 30. Take Exit 2 (first exit). Left on Route 340 for 4 km. Right at traffic lights onto Ste-Angélique for 3 km to St-Lazare Airport on the left.

**From Ottawa** - Hwy 40 East, Exit 26, Right on Bédard/Daoust for 3 km to Ste-Angélique. Turn left on Ste-Angélique for approximately 1 km to St-Lazare Airport on the right.

**From Toronto** - Hwy 20 East, Exit 17 (St. Clet, 201 North) to chemin Ste-Angélique. (13.5 km). Right on Ste- Angélique for approximately 8 km to St-Lazare Airport on the right.

## COVID PROTOCOLS

Adherence to the covid protocols is a condition of participating at the trial.

- Please stay home if you are feeling sick or are exhibiting any potential covid symptoms.
- Maintain social distancing.
- Masks must be worn during the walk-through and/or during the judge's briefing if you are on the field or in proximity to others.
- Please use hand sanitizer before touching ribbons, course maps, result binders etc.; hand sanitizer will be available at any 'communal station'.
- Tenting will be limited and must be set up at appropriate distancing. Competitors should be prepared to crate from their car and/or have their tent further away from the ring (the ring would not be visible).
