All dogs that are foreign born and owned and enter Canada for the sole purpose of entering CKC events will require an TCN. An TCN must be obtained before applying for entry to the show.

15.1.2 The schedule to be employed in the determination of the number of points awarded Winners shall be as follows:

In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall not be included in the calculation for championship points.

15.1.8 In addition to championship points allocated at the breed level, a dog awarded Best of Breed which also places in the regular Group competition shall be credited with the following additional points provided that a dog was defeated at the Group level.

- 15.1.9 A dog may not be credited with more than five (5) championship points in a single show.
 - 15.1.10 Permission shall be granted a club or clubs to hold shows in such a way that any dog may earn three (3) sets of championship points on the same day, provided that one or more of those sets of points is awarded at a specialty for that breed or group.
- 15.1.11 A dog awarded Winners that also places Best in Show at an all-breed conformation show shall be credited with five (5) championship points inclusive of any points earned at the breed and group level.
- 15.1.12 In order for a dog to be recognized as a champion and its owner provided with a championship certificate, the dog must: (a) earn at least 10 championship points under at least three (3) different judges; (b) be registered in the records of the CKC, have an Event Registration Number (ERN) or have a Miscellaneous Certification Number (MCN); (c) have earned at least one 2-point win either at the breed or group level.
- 15.1.13 The Board interprets the words "earn at least 10 championship points under 3 different judges" to mean: (a) Three (3) or more Winners awards at not less than three (3) different shows, under three (3) different judges at the breed level; (b) each of the three (3) judge's awards must be one or more championship points won at Winners, Best of Winners, Best of Breed or group placing; (c) all points required for championship status may be earned at Winners, Best of Winners, Best of Opposite Sex, Best of Breed or group placing.

As Of July 2021, The Rules For Awarding Of Grand Champion And Grand Champion Excellent Have Changed. Please See The CKC Conformation Rule Book 15.2 Grand Champion (Gch) & 15.3 Grand Champion Excellent (Gchex) Rules

<u>CONFORMATION</u> The following classes will be provided, divided by sex. REGULAR CLASSES

JUNIOR PUPPY - 6 months & under 9 months on the day of the show

SENIOR PUPPY- 9 months & under 12 months on the day of the show

12-18 MONTH CLASS - for dogs 12 months of age and under 18 months of age on the day of the show.

BRED BY EXHIBITOR - shall be for dogs owned and handled in the ring by the breeder. Breeder need not be handler for any further class judging.

Foreign Bred – open to all foreign bred dogs.

OPEN CLASS - shall be for all Dogs.

SPECIALS ONLY - A dog may be entered for "Specials Only" and such dog shall compete for Best of Breed award. If eligible it must compete for the award of Best of Opposite Sex. All awards the dog earned at the show will be cancelled if, at the time of closing of entries for the show, the dog was not registered individually in the records of the Canadian Kennel Club or if the dog has not earned all the championship points required for championship status. The entry of a Listed Dog in this class is NOT allowed.

VETRERAN-Veterans will be divided Males and Females with the following age categories: 7 up to 9 years, 9 years up to 11 and 11 years+.

Unofficial Classes

BABY PUPPY CLASS DOGS 4 months of age and under 6 months of age on the day of the show.

BRACE- At an all-breed or specialty show a club may, but is not required to, offer a Brace Class. This class shall be for 2 dogs of the same breed (not necessarily of the same sex). A Brace should be judged as an identical pair – same colour, size, gait, and same stride. When viewed from the side they should appear as one dog and its shadow. A brace must be handled by 1 person on 1 lead

TEAM - The same requirements as the Brace except that 4 dogs must be entered.

STUD DOG & GET -shall be comprised of the stud dog and 2 or more of his get. Ownership in this class need not be identical. The stud dog may be spayed/neutered and must be entered in a Regular class or in Exhibition Only. Get must be entered in a Regular class.

BROOD BITCH & PROGENY- This class shall have the same requirements as Stud dog and get

ALTERED: Altered will be divided Males and Females with a Best of Breed judged for each. All dogs must be surgically altered to enter this show.

PARADE OF VETERANS- Dogs entered must be 7 years or older and entered in a regular class or in Exhibition Only.

EXHIBITION ONLY - Dogs entered in this class may not compete in the regular breed classes CANADIAN BRED - for dogs born in Canada – This award will automatically be awarded for the top winning Canadian Bred Dog.

All Breed Entry information

<u>The Leonberger Club of Canada</u> will be offering a booster in the Skaha Kennel Club Association Show on Saturday, Sept 4th, 2021. Prizes will be given for BOB, BOS, BOW, Winners Male & Female, Best Puppy and Best Baby Puppy. Rosettes will be awarded for all classes.

The LCC will also offer prizes and rosettes to all qualifying Leonbergers competing in Obedience Trial #3 and Rally Trial #1 on Saturday, Sept 4nd, 2021, and an additional rosette and prize for Highest Obedience and Rally Scoring Leonbergers.

The person handling the dog in the ring shall be recognized as the Agent for the owner of the dog. Delivery in the ring of any prizes won shall constitute full delivery of the prize to the rightful owner. No prizes will be mailed.

Non-member participation fee

- a) An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. The fee will match the ERN fee.
- b) In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled.
- c) These fees apply only to dogs wholly owned by non-CKC members and are not applicable to CKC members."

EXTRACTS FROM CONFORMATION SHOW RULES & REGULATIONS

JUDGES - SECTION 4.1.3

A judge officiating at a show held under these rules shall not be subjected to any indignities of any kind during the progress of the show. It shall be the duty and obligation of the club holding the show to see this rule is effectively carried out.

SHOW OFFICIALS – SECTION 5.1.5

A show-giving club will be held responsible during the show for the conduct of exhibitors and spectators. Any person acting in an abusive or objectionable manner must be removed from the show on complaint to the Show Superintendent.

ENTRY FORMS - SECTION 8.2.3

Entry forms received by the CKC, which are incomplete and/or contain incorrect information may result in awards being cancelled.

ENTRY FORMS - SECTION 8.2.5

An error in an age-specified class, the class, date of birth or sex may be amended on the entry form up to one hour before the start of the show.

ENTRIES - SECTION 8.3.1

Every dog entered in a conformation show must be one of the following:

- a. registered with the CKC
- b. have an Event Registration Number
- c. eligible for registration with the CKC, or
- d. if it belongs to a listed breed, it must have a Miscellaneous

Certification Number (MCN)

REFUSAL OF ENTRIES – SECTION 8.6.2

A Club may refuse any entry form from an exhibitor known to have tendered a dishonoured cheque or declined credit card unless entries are accompanied by cash, money order or certified cheque.

DISQUALIFICATIONS – SECTION 14.1.4

Once a dog has been disqualified for any reason at a conformation show, it may not be entered or shown at another show until the dog has been reinstated by the CKC. All awards earned by the dog shown in violation of this section will be cancelled by the CKC and the owner of the dog is subject to disciplinary action.



GENERAL RULES GOVERNING THESE SHOWS

It is the responsibility of the Exhibitor to be familiar with the rules pertaining to the event in which they are competing. Copies of the Conformation Rule book are available from the CKC, 400 200 Ronson Dr., Etobicoke, ON M9W 5Z9

- 1. The Club reserves the right to remove any person from the show. The Show Superintendent shall have full control of the above shows and trials, which will be governed by CKC rules.
- 2. Any dog excused by the Show Superintendent or the Show Veterinarian for any reason shall not, after being excused, compete in any class for any award for the balance of the show.
- 3. The show committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of accident, or other misfortune, to either dogs, exhibitors or patrons.
- 4. A Judge or any person participating in any capacity at a Dog Show held under CKC Rules shall not be subjected to any indignity of any kind during the progress of the show and it shall be the duty and obligation of the Club holding the show to see that this rule is effectively carried out. The Show Superintendentshall promptly report to the CKC any infringement of the rules, and the Discipline Committee shall have the power to take such action as it deems fit on receipt of a report indicating that this rule has been violated.
- 5. Exhibitors are solely responsible for the conduct or actions of their animals while they are on the show grounds.
- 6. DOGS MUST BE READY FOR JUDGING. The Club will not be responsible for and is not obligated to provide any service for notifying owners or agents of breed or class judging. No ring shall be held up waiting for exhibitors or handlers. Exhibitors & Handlers with more than one dog shall have substitute handlers available so the judging will not be delayed. All start times are **PDT**
- 7. The owner of a dog entered in these shows is entirely responsible for any error in entering his/her dog, regardless of how or by whom the entry was made.
- 8. A dog once disqualified for any reason at a championship show held under these rules cannot again be shown at a show held under these rules until the dog has been examined by an official committee appointed by the CKC and the committee finds the dog is free from the condition which prompted the disqualification. Application for reinstatement must be accompanied by a fee of \$50.00 plus GST which shall be forfeited to the CKC if the examining committee is satisfied that the dog should remain disqualified. All awards earned at a dog show in violation of this rule shall be canceled by the CKC and the owner of the dog is subject to disciplinary action.
- 9. Exhibitors and handlers will be responsible for their dogs and for their equipment left at the Show Grounds.
- 10. For the benefit of the health of animals and the pleasure of the exhibitors and spectators we insist upon keeping our grounds and buildings as clean as possible. Exhibitors are responsible for cleaning up after their dogs. Please exercise your dog BEFORE taking it to the Judging ring. Dogs are to be exercised in the designated areas only, not in the vicinity of the ring areas.
- 11. No entry fee will be refunded if the Show cannot open or be completed by reason of riots, civil disturbances, fire, and Act of God, public emergency, act of public enemy, strikes or any other cause beyond the control of the Club.
- 12. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused by the Veterinarian or Judge, or barred from competition by action of the Show Committee.
- 13. The Club has a zero tolerance of abuse of any description involving any person involved with these shows, including spectators.

Crates will be allowed at ringside during the judging of your specific breed only and must be removed immediately after. No Exceptions.

Dogs are not allowed in washrooms.

The welfare of an exhibitor's child is assumed to be the responsibility of the exhibitor. It is distinctly understood that you will exercise control and restraint over the children in your care on the days of these shows.

The Club is not responsible for lost or stolen property from exhibitors or venders/concessions.

The Club will use due care and diligence for the welfare of dogs and exhibitors but will not be responsible for, or assume any liability in the event of accident or misfortune to either dogs, exhibitors, spectators or vendors.

Delays waiting for dogs are not possible and handlers with several breeds must arrange for alternate handlers if judging times for their dogs "conflict".

The club reserves the right of restricting exhibitors grooming space.

You must leave your setup in the same clean condition you found it in when you first arrived at the show.

AGREEMENT

I (we) acknowledge that I (we), all exhibitors, handlers and patrons, know and abide by the "CKC Dog Show Rules", and that I am (we are) familiar with their content. I (we) agree that the Club holding this show has the right to refuse this entry for cause, which the Club shall deem to be sufficient. In consideration of the acceptance of this entry and of the holding of the Show and of the opportunity to have the dog judged and to win prize money, ribbons or trophies, I (we) agree to hold the Skaha Kennel Club the Leonberger Club of Canada, their members, directors, governors, officers, agents, superintendents or show secretary and the owner or lessor of the premises and any employees of the aforementioned parties, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of a dog while in or upon the show premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim, and I (we) further agree to hold the aforementioned parties harmless from any claim for loss of a dog by

disappearance, theft, death or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, theft, damage or injury be caused or alleged to be caused by the negligence of the Club or any of the parties aforementioned, or by the negligence of any other person, or any other cause or causes.

I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this show, howsoever such injuries, death or damage to property may be caused and whether or not the same may have been caused and whether or not the same may have alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other person.
