#### **Run Order**

#### Move-ups

Forms will be available at the Secretary's table. Previous trial move-ups must be submitted no later than 6:00 pm MDT Sept 1, 2022, via email to the Trial Secretary. Same day move-ups must be submitted no later than 30 minutes prior to the start of the trial you choose to move-up in. Next day move-ups must be submitted to the Trial Secretary no later than 30 minutes by the end of trials on Saturday.

Dogs may move UP (A stream) or DOWN (B stream) once completing a title.

Dogs may choose to Move DOWN to a B stream class for the next trial day if there is room/ at secretaries' discretion.

#### **Day of Show Entries**

All competitors will have to have a valid BHA registration number prior to submitting their entry form.

Day of Show Entries will be received during check-in each day.

Day of Show entries are not a guaranteed entry and will be accepted only up to Judging limits.

Confirmations will not be sent for Day of Show entries.

#### Awards

SAWHDA Barn Hunt Club. reserves the right to change the run order based Qualifying ribbons will be awarded for all qualifiers in all classes, including on entries and will send final class run order and judging schedule Instinct. Placement ribbons will be awarded for 1<sup>st</sup> through 4<sup>th</sup> in each height confirmation one week prior to the start of the trial. Dogs being handled by division for all classes except Instinct. New title ribbons and High in Class the same person <u>must</u> be separated into different staged groups. Judge of Record and Event Official dogs may be judged prior to Event start of the Event. Sate first dogs of the Event.

Saturday/ Sunday-

AM Instinct, Novice, Open, Senior, Masters PM- Master, Senior, Open, Instinct, Novice B Classes will receive 1<sup>st</sup> through 4<sup>th</sup>, with one HIC for all height divisions combined. Master B placements will be awarded 1<sup>st</sup> to 4<sup>th</sup> in each height class and a HIC overall. A special prize will be awarded to those who earn a RATCH. Additional awards may be given at the discretion of the Trial Officials.

## **EXHIBITOR INFORMATION**

SAWHDA Barn Hunt Club reserves the right to refuse any entry. Facility is handicapped/wheelchair accessible.

Facility is an enclosed, indoor heated space with cement floor. Ring are 4' X 8' lattice panels

Indoor Blind is a 20'X10' room with chairs located a minimum of 15' away from the rings

Dogs may be entered in any class that they are eligible to enter.

Dogs have the option to be entered in a different class each day throughout the weekend, <u>BUT they must commit to ONE class per</u> day unless a title is achieved. (Example Master A Friday, Open B Saturday, Senior B Sunday)

**Note:** Gerbils are used in place of rats in Alberta.

It is expressly understood that participants alone are responsible for the behavior of their dogs. Any participant whose dog(s) create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the event site. In such case, no refund of any fees paid will be made. SAWHDA Barn Hunt Club and all persons associated with running this event will assume no responsibilities for any loss damage or injury sustained by participants or spectators, or to any of their dog's or property.

- Barn Hunt Registration Number and Barn Hunt Rules and Regulations may be obtained on the website, www.barnhunt.com.
- Entries made without fees or signature and a completed Waiver and Indemnity Form will not be accepted.
- If you provide your email address, we will acknowledge receipt of your entry via email within a few days. If you do not receive an initial confirmation within one week of submitting your entry, contact the Trial Secretary. Any errors must be reported to the Trial Secretary prior to the commencement of the trial.
- All dogs must be on a short leash (6') and under control at all times, while on trial grounds, except when in the ring for judging. Approved collars include flat snap or buckle collars of solid construction and leather or nylon leads. Limited slip martingale collars are allowed. Single piece slip collars/leads are allowed. Harnesses, with the exception of head-halter types, are allowed.

- Dog must run "naked," without a collar/harness. The actual course area will be securely enclosed. No flexi-leads or head halters allowed within the facility. Per BHA rules, electronic collars/devices are not allowed anywhere on the site this includes electronic bark collars. Concealed Prong collars may be used on the site while walking dogs for getting to and from the blind and ring.
- Bitches in season may compete. They will run at the end of each class. They must wear "pants" at all times when not being pottied, including on the course. Owners of bitches in season should confine their dog(s) away from the trial area and other dogs, post "dog in season" signs in their area, and potty their dog(s) away from other competitors. Owners should make their condition known to the Trial Secretary prior to the start of the trials and inform all exhibitors at the judge's briefing.
- The judge need not wait for any dog holding up a class because the exhibitor is not ready. It is the exhibitor's responsibility to be ready for their runs. SAWHDA Barn Hunt Club has no obligation or responsibility for calling or locating dogs that are not brought to the ring when required.
- There may be a short lunch break at the Trial Officials' discretion.
- **BHA rules and common courtesy:** Exhibitors are responsible to clean up after their dogs. Dispose of waste in appropriate containers provided around the facility.
- Possessing or training with personal, live quarry is not permitted on trial grounds at any time. Food and toys are **not** permitted in the ring. Squeaky toys are **not** permitted in the facility.
- Show courtesy to all competitors. Manage loud or disruptive dogs. Treat every dog as if they were reactive or spatially challenged and remain aware of what your dog is doing at all times. Every dog and exhibitor deserves to have a pleasant experience.
- These trials are held indoors.
- You MUST park where directed.
- There is NO SMOKING/VAPING in this facility. If you must smoke/vape please do so inside your vehicle and dispose of the butts in the vehicle. Anyone found smoking around the facility will be asked to leave the event grounds. In such case, no refund of any fees paid will be made.
