- Retriever Field Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred".

Any entry scratched after the catalogue has been printed, will require a veterinary certificate for any refund. A \$5.00 administration fee will be deducted from all refunds.

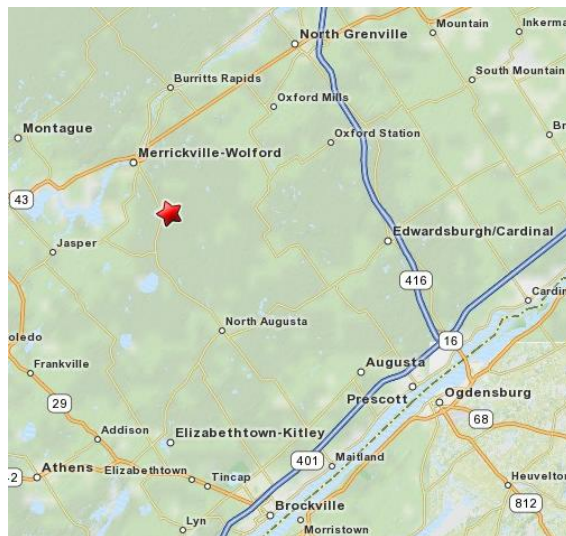
RELEASE AND INDEMNIFICATION OF LANDOWNERS AND OTTAWA RETRIEVER CLUB
