## GENERAL INFORMATION:

Entry fee per dog, per class.....	\$35.00 HST inc
TCN Fee .....	\$11.30 HST inc
Exhibition only fee per dog per trial.....	\$10.00 HST inc

If the entry has no CKC individual registration number, an E.R.N. or a P.E.N. is required and must appear on the entry form. A listing fee of \$11.30 per entry is also required.

**CKC Non-Member Participation Fee / Non-member participation fee** - An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. The fee will match the ERN fee. In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be canceled. The Premium List must carry a note stating that “these fees apply only to dogs wholly owned by non-CKC members and are not applicable to CKC members.

**Eligibility to Compete** - To be eligible to compete in these trials, the dog must be:

- a) Registered with the CKC or;
- b) Have an Event Registration Number (ERN) or;
- c) Have a Temporary Competition Number (TCN), and must be eligible for registration with the CKC.

The entry of a dog that is improperly entered in a class for which it is not eligible cannot be altered to another class after entries close except as outlined here:

- a) Exhibitors incorrectly entered in the A class are permitted to move the dog to the corresponding B or C class up to one hour before the start of the trial.
- b) Exhibitors incorrectly entered in the Novice B class are permitted to move the dog to the Novice C class up to one hour before the start of the trial.
- c) Exhibitor entered in the Open H classes are permitted to move to the Open 18 classes and vice versa up to one hour before the start of the trial.
- 6.9.8 d) Exhibitors incorrectly entered in the Novice B class are permitted to move the dog to the Novice C class up to one hour before the start of the trial.

**Bitches in season** - Bitches in season are not permitted to compete under CKC Rules. NGDC may refund entry and listing fees if a bitch comes into season after the closing date; upon presentation of a valid veterinarian’s certificate confirming that the bitch was in season within the 24 hour period preceding the trials. This certificate must be delivered to or reach the Trial Secretary before the trial commences.

**Rally Obedience Classes offered** - All regular classes only.

**Rally Obedience Prize List** - Flat ribbons will be awarded for all qualifying scores. Rosettes will be awarded for qualifying 1st placement for Novice A and Novice B, Intermediate, Advanced A and Advanced B and Excellent A and Excellent B, and Master Level.

### **RALLY OBEDIENCE TRIAL RULES AND REGULATIONS**

The Exhibitor is responsible for knowing and complying with the Rally Obedience Rules and Regulations of the Canadian Kennel Club.

**Section 17.7** of the Rally Obedience Rules and Regulations states: It shall be the duty and obligation of the trial-giving club to see that a judge, club official, ring steward, volunteer or competitor at a Rally Obedience Trial held under these regulations, is not subject to indignities of any kind. The Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

### **RALLY CHAMPION (RCH)**

**Section 16.1** The CKC will permit the use of the letters RCH to be used as a prefix of the name of any dog that has met the requirements for that title as hereinafter provided.

**Section 16.2** A dog may begin earning points toward the RCH title as soon as the Rally Master (RM) title requirements have been completed.

**Section 16.3** The RCH title will be awarded to dogs that have successfully earned a minimum of 100 points total from competing in both the Excellent B and Master classes in the same trial.

1. (a) 50 points must come from the Rally Excellent B class, including a minimum of five (5) scores of 95 or higher
2. (b) 50 points must come from the Rally Master class, including a minimum of five (5) scores of 95 or higher

**Section 16.4** A qualifying score must be earned in both the Excellent B class and the Master class on five different occasions under five different judges
