NOTE: No entry shall be made under a judge, of any dog which the judge or any member of her immediate family or household instructed regularly within 6 months prior to the date of the trial. This applies to judges who train dogs in class or with their handlers.

ALSO NOTE: Handlers may not exhibit under a judge who has participated regularly in training class with them within 6 months prior to the trial

A dog can only be entered once in any one class at a trial

It is the responsibility of the exhibitor to be familiar with the rules pertaining to the event in which they are competing. Rules and Regulations Books are available for \$6.00 plus GST from the CKC. Exhibitors, through submission of entry, acknowledge that they are knowledgeable of and will comply with the CKC Rules and Regulations. At the option of the handler, a dog may wear either a well-fitting plain buckle collar, a quick-release collar. No fancy collars, choke collars, pinch collars, or other training collars are prohibited. Food and toys are not permitted in the course area and handlers are not permitted to use whistles or other training devices in the ring or within 10 feet of the course.

Trial precincts:

The precincts of the trial are all areas reserved for the sole use of the WCOBC. Only Dogs entered in official classes are permitted within the precincts of the trial.

The precincts of these trials are the outside and inside rings, the entire barn, and the immediate area behind the barn.

Rules and Regulations:

It shall be the duty and obligation of the trial giving club to see that a judge, club official, ring steward, volunteer, or competitor, at a rally obedience trial held under these regulations, is not subject to indignities of any kind. The Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred

NOTE: SAME DAY MOVE UPS WILL BE ALLOWED

Moving Up: A dog that has received 3 qualifying scores from at least 2 different judges, may be transferred to the next level provided that request is received at check in. Please see the trial secretary for a move up form.

Entries open February 13, 2013.

Close of Entries - April 3rd, 2013 - 10 days prior to each event Please do not send an entry that requires our trail secretary to travel to the post office to sign for receipt as this does not ensure that your entry will be received on time. No entries will be accepted by the Show Secretary after closing time and date. This complies with the instructions issued by the Canadian Kennel Club.

There are no refunds on overpayment. Confirmations will be emailed after closing date.

All courses will have clearly designated start and finish lines with all obstacles/jumps clearly and sequentially numbered. The course layout for each class will be posted in an easily accessible area at least 1/2 hour before the start of the class.

List of Awards and Prizes:

- Rosettes will be provided for $1^{st} 4^{th}$ in each class.
- Qualifying Rosettes will be awarded for all dogs receiving a qualifying score.
- High in Class rosette shall be provided for each class.
