LIMITED ENTRY

When Judge assignments have reached 7 hours, entries will close automatically even if official closing date has not arrived. The 7 hours is based on the formula of 9 Pre-Novice, 8 Novice/Novice Int, 7 Open, 6 Utility dogs/hour, and 20 dogs/hour for Rally.

When the advertised limit has been reached, all remaining entries may be assigned a position (by class) on the reserve list. The person making the entry shall be notified of his/her position on the list. In the event that the entry of a bitch in season is pulled after the closing date, it may be substituted with one from the reserve list up to and including the day of the trial. Entry fees will be refunded within ten days following the trial for those on the reserve list who did not participate in the trial.

VETERANS OBEDIENCE

ATTENTION ALL FOREIGN EXHIBITORS

US checks will be accepted at par. You may also purchase bank drafts or money orders payable in CANADIAN FUNDS or charge your fees to a MC or Visa account. MC and Visa charges will be processed in Canadian dollars with an additional 10% added to the total cost for this service. Please do not send personal cheques marked "Payable in Canadian Funds" or "At Par". Your cooperation is appreciated. THANK YOU.

A dog which has earned its CD title in the US is not eligible for entry in the Novice A class and a dog which has earned its CDX title in the US is not eligible for the Open A class. Such dogs must be entered in the B class respectively. Dogs with an American ILP number are NOT eligible for entry at CKC Licensed Obedience Trials. Spayed and neutered dogs are eligible for entry at CKC Licensed Obedience Trials.

Effective January 1, 1992, all dogs that are foreign born and foreign owned and enter Canada for the sole purpose of entering CKC events will no longer require a CKC registration number but will require an **Event Registration Number (ERN)**. This ERN number does not register a dog with the CKC for breeding purposes as defined in the Animal Pedigree Act but rather enables a foreign born and foreign owned dog to be awarded titles by the Canadian Kennel Club. Each dog must have its own number. This ERN number **MUST** be applied for within 30 days of the first day of entering a CKC event. Dogs may be entered as "listed", however, failure to apply for an ERN number within 30 days of the first event **WILL** result in the cancellation of any wins, awards, or scores. Any points or scores earned prior to January 1, 1992, are not subject to cancellation due to the lack of an ERN number. All dogs that finished prior to January 1, 1992, must be CKC registered to have a title confirmed. Please forward your request to:

ATTENTION ALL CANADIANS WHO ARE NOT CKC MEMBERS

As of January 1, 2011, the CKC has instituted an annual Non-Member Participation Fee for awards and titles for a CANADIAN non-member of the CKC. These fees apply only to dogs wholly owned by a non-CKC member and are not applicable to CKC members. Non CKC member participants must either purchase a CKC membership or pay the non-member participation fee within 30 days of notification or the CKC will cancel any awards and titles.

ENTRY INFORMATION

No entry will be accepted unless all particulars called for on the entry form are completed in full. Handlers please note the full name and address of all owners must be filled in. Incomplete entries will be returned. No entry will be accepted unless accompanied by the Entry Fee. Telephone entries cannot be accepted, except in the event of a postal disruption. Exhibitors must abide by errors made in entering their dogs regardless of how or by whom the entries were made. Change or cancellation of any entry after the closing date is prohibited. Only dogs which are already registered in the Canadian Kennel Club Stud Book, or are eligible for such registration, can be entered. The committee reserves the right to refuse any entry subject to CKC rules. Judging Schedules will be emailed as soon as possible after entries close. Any NSF cheques/MC/Visa will be subject to a **\$20.00** service charge. Entry fee plus service charge must be paid in cash prior to competing.

GENERAL INFORMATION

Show precincts shall be the interior of the CLE trial building. The Trial Chair will be in full charge of the trial, which will be governed by CKC rules. The Thunder Bay Kennel & Training Club and the Trial Committee will use care and diligence for the welfare of all dogs, exhibitors, and spectators, but will not be responsible for, nor assume any liability in the event of an accident or misfortune, however caused. If, because of riot, civil disturbance or other acts beyond the control of management, it is not possible to open or to complete the show, no refund of entry will be made. Refunds will be made when a bitch entered in Obedience comes into season after entries close if a Veterinarian's certificate is delivered to the Trial Secretary before the date of the trial. It is the responsibility of the exhibitors to have the dog at ringside when the dog's class is scheduled for judging. Waiting for dogs will not be possible. The Exhibitor is responsible for knowing and complying with the Dog Show rules of the CKC. Dogs cannot be kenneled overnight in the Trial building. It shall be the duty and obligation of the trial-giving club to see that a judge, club official, ring steward, volunteer, or competitor at an Obedience Trial held under these regulations is not subject to indignities of any kind.
