**KENNELING:**

- kenneling space available

**PARKING:**

- You may park in the parking lot, close to the front door.
- Back door entrance, off of 7th Ave, which is the most direct access to the indoor kenneling space
- Street parking on Ottawa Street or 7th Ave.

**FRONT DOOR ACCESS INTO TRAINING FLOOR SPACE:**

- Please pick up after your dog. Bags and clean up supplies will be available at the door.
- Please do not let your dogs mark/urinate on or near the building, door entrances/exits or car tires.
