## Introduction to Scent Work & Foundations Review & Coaching

## With Teresa Zurberg

Date: January 26, 2020

Location: Pacific Riding for Developing Abilities, 1088 208 St, Langley

**Instructor:** Teresa Zurberg has been a professional detection handler since 2010, starting with narcotics and explosives detection. She currently handles Angus, the first canine trained to identify the bacteria, C. difficile for Vancouver Coastal Health. Teresa is also a judge for both the CKC and the National Association of Canine Scent Work (NACSW) in the US. She has instructed and participated in sport canine scent detection activities with her own dogs. She brings her expertise as a professional handler along with her enjoyment of working with companion dogs to this seminar.

There will be two sessions, structured as follows:

#### Session 1: Introduction to Scent Detection

This session is intended for dogs that have had no prior experience with scent detection. Dogs will be introduced to exercises that involve searching for food in boxes. These exercises are intended to:

- begin to stimulate the dogs' hunting drive
- identify what motivates each og
- begin to develop observation skills in handler
- develop and understanding of the box game

Registration is limited to 8 teams

<u>Time</u>: 9 AM – 12 AM

#### Session 2: Foundation Skills Review

This session is intended for dogs that are currently proficient in at least one odour (birch or wintergreen). Teresa will test the teams' skills and suggest exercises to help work on weaknesses in their foundation. Handlers will be asked to provide information on their experience and possible weaknesses prior to the session.

Registration is limited to 6 teams

<u>Time</u>: 1 PM – 4 PM

#### Cost:

- \$50 per working team per session (\$45 for WGC members). Handlers may only register for one working spot for the day but may register for an audit spot in the other session.
- \$30 per audit spot per session. There are unlimited audit spots.

**Entry method**: First come basis with full payment. Registration and signed waiver must be accompanied by payment (e-transfer, check or money order). A wait list will be kept.
