## AAC Policy Pilot Program July 1st, 2022 – July 1st 2023

Under the AAC pilot project, bitches in season (BIS) may participate but **we must be notified ahead of time**. Handlers must limit movement of the BIS and only the designated relief area. A (BIS) must wear panties at all times on the property except while in the relief area and during their run, unless the trial is forced for some reason to move inside the building. Panties must be worn at all times, when in the building. The BIS will run at the end of each class and the handler must provide a mat for the start line. Competitors who chose not to compete because there is a BIS will be offered a credit for the next trial.

### NOTICE TO EXHIBITORS

Exhibitors, through submission of entry, acknowledge that they are familiar with AAC rules and regulations, including but not limited to the following:

This event is open to all dogs at least 18 months of age, purebred or mixed breed, except aggressive dogs, or dogs suffering from any deformity, injury or illness which may affect the dog's physical or mental performance.

Obstacles shall be chosen from those described in the current edition of the rules and regulations of the MC. No leads, collars, except flat collars, food, toys or other aids or devices shall be permitted on the course at any time. No toys or food on course during familiarization. It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may be asked to leave the show grounds and no refund of fees paid will be made. Exhibitors must keep crating and exercise areas clean. Please pick up after yourself and your dogs.

There will be no refund after the closing date for dogs that are withdrawn except for sick/injured dogs if we are provided with a vet's certificate.
