### Classes

- **Gamblers:** Consists of 2 parts. Part 1 Dogs earn points for each obstacle performed correctly (obstacles may be performed twice successfully). Part 2 Bonus points can be earned by working away from handler through a series of obstacles, while handler stands behind a designated line.

- **Standard:** All obstacles must be performed in order & in the time set by the judge

- **Jumpers:** Course consists of only jumps & tunnels. Tunnels is a numbered course consisting of tunnels only. Last event of the day - No refusals will be called just time and off courses.

- **Snooker:** 2 part course, opening consists of 3-4 red jump and obstacle combos, closing is numbered sequence of obstacles, 60 seconds.

- **Team:** Each dog does 1/2 course & scores combined; relay style but not together.
