DAY OF TRIAL ENTRIES: Day of trial entries will be accepted as space allows and must be submitted prior to the judges briefing. Day of entries shall be \$40.00 per component and only cash will be accepted on the day of the trial. Move ups within the same trial ex: Novice to Open is not permitted. A prize and ribbon are not guaranteed for day of entries, however any ribbons earned will be sent out post-trial if required

Bitches in Season will be permitted: Please see new rules: 6.5.1 and 6.5.2

VENUE: No indoor benching available. These tests will be run rain or shine. All dogs must be under control, on a leash except during the test (where off leash searches are permitted).

Remember that this is a public facility and a place of business. Clean up after yourself and your dog, failure to do so will be immediate expulsion from the event. Stairs may need to be used to access the search areas. If you need assistance, please let one of our stewards know!
