- 2) Not all dogs love other dogs. Please keep your dog under control and out of other dogs' faces, even if your dog is not dog aggressive.
- 3) Please pick up your dog's waste.
- 4) Please clean up after yourself. There are waste containers for your trash.
- 5) Be kind to our judges and volunteers. Remember if you want to be treated with respect, give others the same respect

**Refunds**

There are NO CREDITS nor refunds for anyone wishing to pull their entries after the closing date. Females in season or lame dogs will be excused. If dog is not present for assessment, a note signed by a veterinarian will be required for any refund or credit consideration.

**Bitches in season**

Females in season may not enter and are not allowed on the event grounds. When a bitch comes into season after the entry has closed, a Veterinarian’s note certifying the bitch was in season within the 10-day period preceding the event must reach the secretary on or before the start of the event. A full refund of entry fees and listing fees will be given.

**Eligibility**

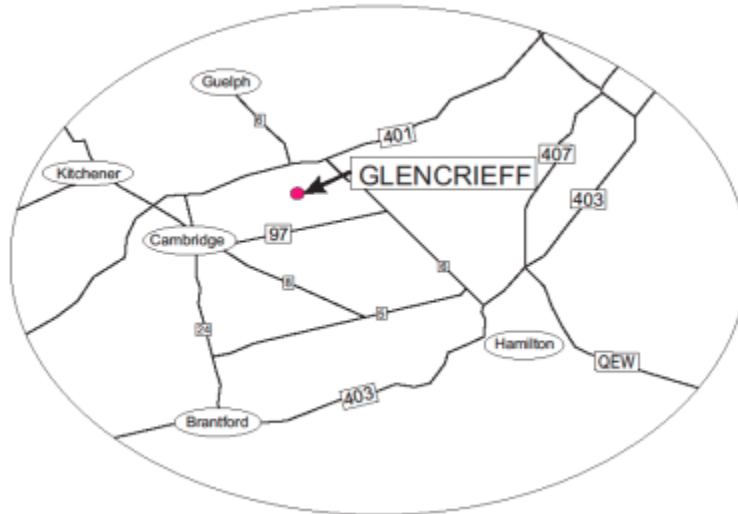
Scent participation is open to all purebred and mixed breed dogs at least 6 months of age that are individually registered with the CKC, or have an Event Registration Number (ERN) or a Performance Event Number (PEN) or eligible for the registration with the CKC or have a Miscellaneous Certificate Number (MCN) if it belongs to a CKC listed breed, or have a Canine Companion Number (CCN) if it’s a mixed breed.

**EVENT**

Verification that your entries have been received will be emailed to you no later than three days before the event date. PLEASE contact us prior to the event date if you have not received an emailed confirmation from us.
