ALBERTA KENNEL CLUB Booth Space Contract

The undersigned business (or individual), hereinafter called LESSEE, does hereby make application to participate as a vendor at the Alberta Kennel Club Dog Show being held at the Big Four Building in Calgary, Alberta on **February 3, 4 & 5^m, 2012**. Vendor space rental is for three (3) days; no one-day rental space is available. It is further understood that specific booth space(s) will be available based on a first-come, first-served system.

In consideration of the acceptance of this reservation, LESSEE hereby agrees to the following conditions:

- **Deadline** – Contracts must be received, with payment in full, no later than **January 6, 2012**. Potential vendors are strongly encouraged to submit application and payment well in advance of the deadline. Applications received after the deadline require payment by cashier’s cheque or money order.
- **Refunds** – Fees will be refunded only (1) in the event a LESSEE application is rejected, or, (2) in the event a LESSEE notifies Alberta Kennel Club in writing on or before **January 6, 2012** that they are unable to attend. After **January 6, 2012**, fees may be refunded at the sole discretion of Alberta Kennel Club.
- **Resale License** – Any licensing requirements are the sole responsibility of the LESSEE.
- **Assignment Prohibited** – LESSEE will not assign, sublet, or apportion the whole or any part of the space allotted to any individual, partnership, corporation, company, firm or entity, without the prior written consent of Alberta Kennel Club’s Show Chairman.
- **Aisle Ways** – LESSEE must stay within contracted frontage. There will be no allowance for aisle ways between booth spaces. **No dogs are permitted within the confines of booth spaces, please make arrangements to house your dogs in the benching area. Only dogs entered in the Alberta Kennel Club shows are permitted on the premises as per CKC rules.**
- **Loudspeakers** – No loudspeaker systems may be used by any LESSEE.
- **Indemnification** – Alberta Kennel Club assumes no liability for bodily injury or property damage incurred by LESSEE, its employees or agents while on the Calgary Stampede Grounds. LESSEE shall defend, indemnify and hold harmless Alberta Kennel Club, and their designated agents, employees and/or contractors, from and against any and all claims, losses, damages, injuries, penalties, governmental charges or fines in any amount arising out of, or caused by LESSEE’S use of the premises, the conduct of LESSEE’S business or from any activity or work done, permitted or suffered by vendor in or around the premises, including but not limited to, the installation, operation, maintenance or removal of concessions and/or merchandise.
- **Set-up** – The show grounds will be open for set up on Thursday, **February 2, 2012** from 12:00 until 10:00 PM. Absolutely no vehicles in the building from Friday until the end of the show on Sunday are permitted.
- **Clean-up** - LESSEE is responsible for cleaning and maintaining their assigned booth space for the duration of the Show, and for cleaning and clearing their area(s) at the conclusion of the event.

The Alberta Kennel Club reserves the right to reject any application, and to demand the release of any rented booth space at any time before or during the Show for failure to meet any of the requirement contained herein, for violating any applicable Provincial, City and/or County law(s) and/or regulation(s), and/or for **display conduct that is dangerous, destructive, or in any way prejudicial to the welfare of the sport of purebred dogs.**

This is a binding contract when accepted by the Alberta Kennel Club. (Acceptance is reflected by payment for booth space) Confirmation will be mailed upon receipt of payment and completed contract.

Contracts received without payment will be deemed incomplete and will not be processed.
