It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities of any kind. The Agility Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit, on receipt of a report indicating that this has occurred.

CKC has a Non-Member Participation Fee of \$62.40 + HST. This fee only applies to dogs wholly owned by non-member residents of Canada and is not applicable to CKC members.

Entries open Wednesday February 22, 2019 at 9:00 am and close Friday April 12, 2019 at 9:00 pm. All entries received after closing will have an extra \$3.00 per run applied. Day of entries will be taken until the courses for the day are released (at the end of the fun run).

Entry Fees:

Early Bird cost is \$23.00 per run or all 4 runs for \$84.00 for entries received and paid by March 22, 2019. Entries received between March 23 and April 12, 2019 will be \$27.00 per run or \$98.00 for all 4 runs. Entries received any time after April 12, 2019 (including day of show entries) will be \$30.00 per run all 4 runs \$108.00. Fun run cost \$10.

Listing fee, per dog per trial \$10.00 + HST (payable ONLY if no CKC registration #, ERN or PEN is available for the dog). Please note: each agility entry includes a \$4.70 + HST CKC Recording Fee

****NEW**** Effective November 12, 2018 for all SPD trials all exhibitors entering electronically (online or by email) for any entry will be charged 10% electronic entry fee. This fee applies to entries that are not mailed in hard copy with enclosed cheque payment in advance of the closing date. Cash will be accepted with hard copy in sealed envelope at the Red Barn

The Trial Secretary, Dara Murphy, is in full charge of the Trials. Trial precincts consist of the trial building. Whistles, clickers, "squeaky" toys, flexis and prong collars are NOT permitted in the building and no food or toys within 10' of the ring gates. Bitches in season are NOT permitted anywhere on the trial precincts. Ring is Top Dog rubber agility flooring with underlay. Ring dimensions are 100 ft x 90 ft. NO OUTDOOR SHOES ARE ALLOWED IN THE BUILDING. Handlers in all classes may walk the course without their dog prior to the start of their class. There will be NO obstacle familiarization. Obstacles shall meet the specifications in the CKC Agility Rules & Regulations effective January 1st, 2017. Move ups will be accepted for Standard #2.

To be eligible to compete in these trials, a dog must be 18 months of age and eligible for a registration with the CKC, have an ERN or CKC Misc. Certificate or a CKC Performance Event Number. Spayed bitches, debarked dogs and neutered males are eligible to compete. Mixed breed dogs may enter these trials with a CKC Canine Companion Number.

Bitches in season may not compete. When a bitch comes into season after the entry has closed, a Vet's certificate certifying the bitch was in season within a 10-day period preceding the trials must reach the trial secretary on or before the start of the first trial. A full refund of entry & listing fees will be given; however, the 10% online entry fee will not be refunded (if applicable).

Unfortunately, we can NOT refund entries after closing for any other reason. Anyone wishing to pull their entries after closing may upon request receive a 50% credit (excluding the additional 10% online entry fee if applicable) toward future SPD entry fees for another trial held within twelve (12) months of this trial.

No entries will be accepted, altered, cancelled or substituted after the official closing date and time for entries, except as provided in the rules. Exhibitors must abide by errors made in entering their dogs regardless of how and by whom the errors were made.

Entries will be accepted only if accompanied by the correct fees. Courier entries will be accepted if no signature required. Tendering of an NSF cheque is considered non-payment of fees and is punishable by disciplinary action. A \$30 NSF service charge will be applied.

Flat carded & stringed ribbons will be awarded for qualifying scores & 1st through 4th placements. New title rosettes are available for purchase at our cost of \$8.00 each.

Foreign Exhibitors please note that fees are due and payable in Canadian dollars. Due to fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted, in US funds. Please do not mark personal cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian funds. Your understanding and cooperation are appreciated. Thank you.

****HELPER POLICY**** - All competitors are required to help out at the trials or will be charged an "opt-out" fee which goes to our volunteer fund. We simply cannot host trials without everyone pitching in to help out. As always, helpers get snacks, beverages and lunch.
