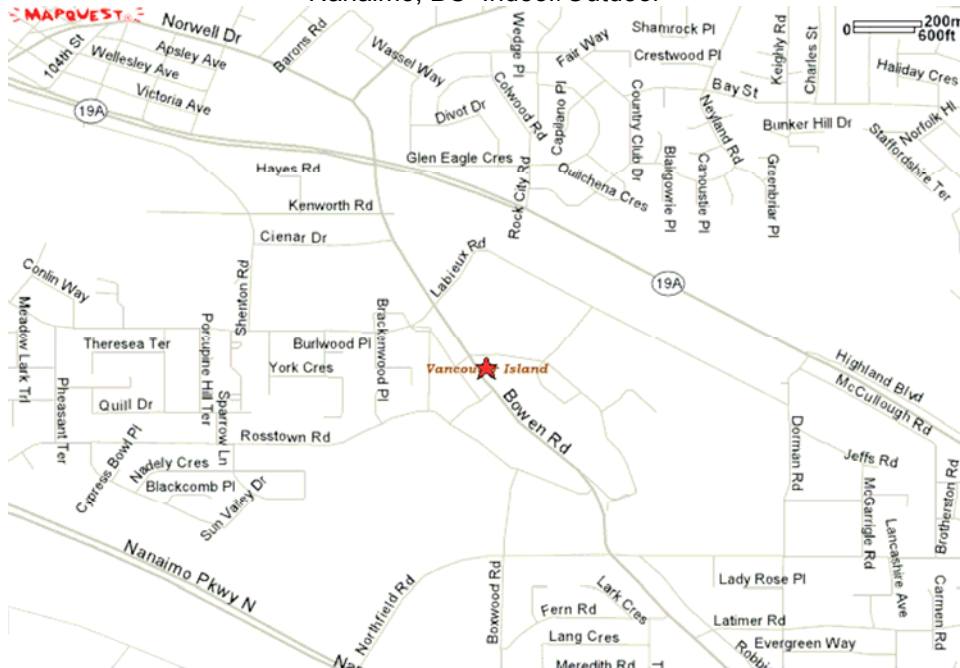

For the purpose of entering CKC events to obtain Championship status and Obedience Titles and Degrees, individual registration is no longer required for foreign born, foreign owned dogs. Foreign exhibitors may apply for an ERN (Event Registration Number). This number MUST be applied for within 30 days of entering first CKC event to avoid cancellation. Exhibitors may submit a photocopy of dogs' foreign Registration Certificate and the appropriate fee (\$55.85 Canadian Funds) along with a letter of request to the CKC. (This ERN number replaces a CKC Individual Registration Number for entering CKC events ONLY.)

I exhibited a Boxer at my first show in 1963 when I was a youngster.

Later, competing in Junior Handling I became the top Senior Boy Handler in 1966.

In 1967 I purchased a Bedlington Terrier and finished his American and Canadian championship myself.

I have bred Bedlingtons for several years now and am fortunate to have bred the only 2 Canadian bred Bedlingtons ever to win an all breed BIS in the U.S.A.

I am also very pleased to have bred the #1 Bedlington Terrier in the U.S.A. for 2013 and the #1 Bedlington Terrier in Canada for 2013.

They are both littermates and were owner-handled.

Afghan Hounds and Doberman Pinschers were two other breeds I bred and I also showed a BIS winning Doberman bitch.

Dogs have been a passion all of my life.

Grant Townsend



My involvement in the dog world began with the showing of Shetland Sheepdogs in the early 1980's. They were shown in both the conformation and obedience rings. My first toy dog was a Papillion - she had such an exuberant personality, that over the next few years my house grew to accommodate many more of the lovely dogs from Betty Kenworthy (Kenrennie Kennels). I showed my pap's also in conformation and obedience. I was given a lovely Yorkshire Terrier in the early 1990's. After showing for a few years, I realized that the Yorkie coats were more than I could manage so I continued with just the Pap's. I have also co-owned Cavalier King Charles Spaniels. I have held numerous positions in both all-breed and specialty clubs. This sport has given me the privilege of having wonderful dogs in my life and has allowed me to develop so many wonderful friendships. I am a licensed all-breed conformation judge. In addition to judging in Canada, I have judged in Australia, Serbia, and the USA. I am a retired high school teacher.

Travelling, gardening, and cooking are a few of my hobbies. I volunteer as a docent at Craigdarroch Castle, a museum in Victoria, BC.

"Mike" MacBeth



"Mike" Macbeth is a life member of the CKC and founder and President of the Dandie Dinmont Terrier Club of Canada. She has been involved in the world of dogs since the age of seven.

As a second generation breeder of Dandie Dinmont Terriers since 1968, Mike has bred more Best in Show winning Dandies than any kennel in history and has produced three World Champions. Her dedication to the preservation of one of the world's most endangered breeds has generated international accomplishments. When quarantine was lifted in Great Britain in 2003, her Dandie "Dawson" was the first North American dog of any breed to win a breed show. He returned the following year to win his UK championship in three straight shows (almost unheard of!) culminating with Best Terrier at Windsor, Britain's most prestigious outdoor show. He also won the Terrier group and BIS 3 in Turin, Italy in 2004 and the Terrier Group and BIS 4 on the first day of the World Show, Argentina, 2005.

Mike's cooperation with other breeders world wide has been responsible for significant showdogs such as "Harry", the USA's Top Dog All Breeds, 2006. She has bred the top Dandie Sire in Britain since 2006. One stud dog achieved top Terrier sire and # 6 All Breeds in the UK, inspiring Britain's renowned magazine Dog World Annual 2008 to choose her as its "Kennel of International Influence".

Introducing Our Distinguished Panel Of Judges cont'd

Mike was first approved by the Canadian Kennel Club to judge Terriers in 1979 and was granted all breed status in 1992. As an international dog show judge, she has adjudicated at prestigious events in 25 countries on 5 Continents.

Mike has lectured at Guelph University's Veterinary College, and have conducted seminars for dozens of dog related events, the most recent being a featured presenter at the Canadian Dog Judges Association Annual Conference, 2013.

As a professional writer, she is a frequent contributor to several international canine publications, including Dogs in Canada; Canine Review; Dogs in Review (US); Dog World (US); National Dog (Australia), Dogs South Africa, and is the Canadian correspondent for Dog World Annual (UK.) In a survey of Canadian dog people Mike was voted one of Canada's top 5 judges.

Her expertise in Terriers has seen her retained as an expert witness by Ontario lawyers defending individual "pit bull" cases. She has been responsible for saving many innocent dogs falsely accused of being banned "pit bulls" from certain death.

Professionally, Mike is a writer, broadcaster and journalist. As Senior Writer of Canadian Business Magazine, she won 6 national writing awards. Credits also include host of the television show, Money\$worth, author of the bestseller, "Silver Threads Among the Gold" (Trans Canada Press, 1987) and the biography, "Quiet Achiever" published by Times Media.

But Mike's primary hobby and great passion is purebred dogs, particularly her cherished Dandie Dinmont Terriers. Dramatic moments have dogged her international canine activities. During apartheid in South Africa, her host nonchalantly shot a trespasser. She was kidnapped briefly by a drunken Australian. In Buenos Aires, Argentina she luckily avoided the bombing incident that disrupted the 2005 World Dog Show. Worst of all, her luggage was lost when she judged in Milan, fashion capital of the World! Oh, the humanity!

Robert Rowbotham



Dogs have been a large part of my life for over 38 years. Like many dog lovers I owned mixed breeds as a child, mostly sporting dog wannabes. My first experience with structured dog involvement came in the early 60's. I attended obedience classes in the basement of an Ottawa church with my sister's miniature poodle. I became the family's official dog trainer and the only one the dog would obey.

Once married and with a new home, the search was on for a purebred. Hours were spent researching the Afghan Hound and our first was bought from Bob Whitney of Cabaret Kennels. Another afghan was soon added from the Telharesha Kennels and the rest is history.

I was encouraged to show and the bug bit hard. For over 20 years I handled professionally, campaigning and exhibiting several breeds in all seven groups. I won over 100 best in shows with dogs I've owned or handled. Many of the dogs placed high in their breed or group standings.

I'm a broadcast journalist by trade, involved in the broadcast industry for over 45 years. All the while I was handling, I was juggling the two jobs, which made for some hectic weeks, especially during the summer months. I recently retired as manager of a radio station in Trenton, Ontario.

During the past years my house dogs have included afghans, salukis, bassets, mini dachshunds, labs, goldens and a Lakeland Terrier. My wife Margot and myself are currently owned by a Cairn Terrier.

I have judged in all but two of our Canadian provinces, the USA and New Zealand.

I am currently the CKC director for Eastern Ontario and the board representative on Apex, the Event Officiating Committee and the Conformation Council.

Jack Ireland

Purchased his first show dog in 1963, he has exhibited Boxers under "Pinepath" prefix. Has owned or bred over 100 Can. and or Am. Ch.'s. Other breeds he has owned are Pekingese, Brussels Griffons, St. Bernard's & Scottish Deerhounds. He started judging in 1987 and as an all breed judge his assignments have taken him to Australia, Argentina, Brazil, Chile, Columbia, England, Hong Kong, India, Japan, Mexico, New Zealand, Norway, Philippines, Russia, South Africa, Thailand, Taiwan, United States, Uruguay and Venezuela. Judged over 20 Boxer Specialties including the American Boxer Club futurity in 1989, also had the honour of judging the American Boxer Club National show three times. Has judged Specialties for Rottweilers, Siberian Huskies, Bernese Mountain Dogs, Akitas. Past President of all breed club, show Chairman for all breed & specialty club and presently holds membership in four dog clubs. Is a member of Canadian Dog Judges Association and the Dog Judges Association of America.

Bruce Fraser



Bruce began training Miniature Schnauzers for conformation with his 1st Miniature Schnauzer in 1986. His showing, obedience training and breeding and program have all focused on Miniature Schnauzers. There have been many CKC and AKC champions and obedience trial champions produced by AAdvocate@.

Bruce, a lawyer by profession, became a CKC licensed obedience trial judge in 2003 and an all class Rally judge in 2008. In conformation, Bruce is licensed for all terriers (Group 4), all toys (Group 5), and can judge all breeds in working (Group 3).

Obedience judging has spanned most provinces, including Newfoundland, and as far south as Palm Springs to judge the National Obedience Invitational at the country's largest outdoor show.

Bruce also devotes considerable time to dog club activities: current Treasurer & Obedience Director of the BC All Terrier Club, member of the Miniature Schnauzer Club of Canada and Secretary - Treasurer of Richmond Dog Fanciers for many years. Having previously been a member of the CKC Discipline Committee, Bruce was appointed to the CKC Appeal Committee in 2013.

David Denis



David has bred and or owned Bernese Mountain Dog, Greater Swiss Mountain Dog, Entlebucher Mountain Dog for many years. He is a CKC conformation judge, licensed for groups 1 through 3 and a permit for group 7 as well as Best in Show. He is also licensed for all Levels of obedience, both levels of drafting, and all breeds in lure coursing.

IN addition to Canada, he has judged in Denmark, England, Finland, Scotland, and USA.

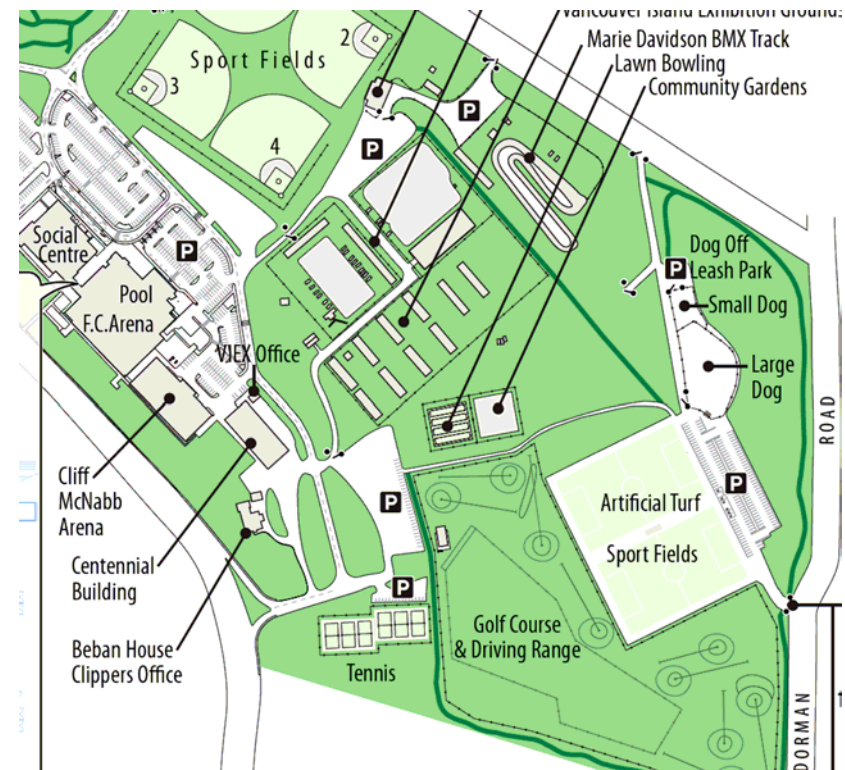
NEW FIELD LOCATION ADJACENT TO THE PARKING LOT!!!!

Points towards a Grand Championship cannot be gained until a dog completes its Canadian Championship. The accumulation of points began January 1, 2013. The dog must compete in the Specials Only class. Twenty points are needed for the title (the forms are available for download from the CKC website

and it is the responsibility of the owner to keep track and when they reach the 20 points, submit the form to CKC who will verify the wins, and if correct will issue a certificate). In the 20 points there needs to be a minimum of 1 Best of Breed and at least 2 – 2 point wins. The scale of points is the same as for regular championships. A judge will select Best of Breed, Best of Opposite Sex, Select Dog, Select Bitch (the latter 2 will be chosen from the remaining Specials dogs competing, if any in competition). The points are based on the total number of dogs defeated

Rally Novice A Class: Dogs competing in this class may not have won a CKC Rally Novice (R. N.) title or any CKC Novice Obedience title. No handler who has exhibited a dog through its CKC CDX (Companion Dog Excellent) title or instructed dog training classes shall be eligible to enter this class. The handler of any dog in this class must be the owner, co-owner, or a member of their immediate families. A person may enter more than one dog in this class. A dog may continue to compete in this class after the owner has been notified by at least 2 different judges that the dog has won 3 qualifying scores in this class. However, a dog may not be entered or exhibited in this class in any rally trial after the owner has received official notification from the CKC that the dog has won the title.

Rally Novice B Class: Any dog may compete in this class until a qualifying score in the Rally Advanced Class is earned. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class. All exercises are judged on leash, and all dogs must enter and leave the ring on leash.

Rally Advanced A Class: This class shall be for dogs that have won the Rally Novice (R. N.) title but have not won the Rally Advanced (R. A.) title or any CKC Novice Obedience title. No handler who has exhibited a dog through its CKC CDX (Companion Dog Excellent) title or instructed dog training classes shall be eligible to enter this class. The handler of any dog in this class must be the owner, co-owner, or a member of their immediate families. A person may enter more than one dog in this class. A dog may continue to compete in this class after the owner has been notified by at least 2 different judges that the dog has won 3 qualifying scores in this class. However, a dog may not be entered or exhibited in this class in any rally trial after the owner has received official notification from the CKC that the dog has won the title.

Rally Advanced B Class: This class will be for dogs that have won the Rally Novice (R.N.) title. A dog completing the Rally Advanced (R.A.) title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class. All exercises are judged off leash. All dogs must enter and leave the ring on leash.

Rally Excellent A Class: This class shall be for dogs that have won the Rally Advanced (R. A.) title, but have not won the Rally Excellent (R. E.) title or any CKC Novice Obedience title. No handler who has exhibited a dog through its CKC CDX (Companion Dog Excellent) title or instructed dog training classes shall be eligible to enter this class. The handler of any dog in this class must be the owner, co-owner, or a member of their immediate families. A person may enter more than one dog in this class. A dog may continue to compete in this class after the owner has been notified by at least 2 different judges that the dog has won 3 qualifying scores in this class. However, a dog may not be entered or exhibited in this class in any rally trial after the owner has received official notification from the CKC that the dog has won the title.

Rally Excellent B Class: This class will be for dogs that have won the Rally Advanced (R.A.) title. A dog completing the Rally Excellent (R.E.) title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class. All exercises are judged off leash except the Honour Exercise. All dogs must enter and leave the ring on leash.

TRANSITION OBEDIENCE CLASSES

PRE-NOVICE – This class shall be for all purebred dogs and those breeds as designated on the list of miscellaneous breeds and of either sex, which have not earned the title of P.C.D. (Pre-Companion Dog) in Canada. Dogs being entered in this class may be handled or exhibited by the owner or any other person. A person may enter more than one dog in this class and must have an additional handler for each dog when they are judged together on the Group exercise. A dog may be entered in the Pre-Novice that has not earned the title of C.D. in Canada or a comparable title in any other country. The Pre-Novice class is an elective class and earning a title is not a requirement to advance to the Novice Classes. The P.C.D. is an elective class which is offered for those people who feel the dog requires ring experience and acclimation to the trial situation or would like to earn additional titles.

NOVICE “C” - This class is open to any dog of either sex that has gained the title Companion Dog, Companion Dog Excellent, Utility Dog or any other advanced Obedience title in Canada prior to the closing date of the trial in which it is to be entered. Exhibitors may enter more than one dog in this class but must have a separate handler for each dog in the Long Sit and the Long Down Exercises when they are judged in the same group. The Novice ‘C’ exercises will be performed and judged as described in the official Novice Class except that exhibitors may compete in the Novice ‘C’ Class indefinitely. Scores earned by dogs entered in the Novice ‘C’ Class are not eligible for High In Trial. The P.C.D. and C.D.I. and Novice ‘C’ are elective classes which are offered for those people who feel the dog requires ring experience and acclimation to the trial situation or would like to earn additional titles. Dogs may be entered in the Novice – Intermediate (C.D.I.) and/or Novice ‘C’ class in addition to any of the Official Classes or Unofficial Classes.

NOVICE INTERMEDIATE CLASS - This class shall be for all purebred dogs and those breeds as designated on the list of miscellaneous breeds and of either sex, which have earned the title of (C.D.) Companion Dog, Companion Dog Excellent, Utility Dog or any other advanced Obedience title in Canada. A dog eligible for entry in the Open A or B Class at any obedience trial held under these rules is also eligible for entry in the Novice ‘C’ and Novice Intermediate Class at the same trial. The Novice Intermediate class (C.D.I.) is an elective class and earning a title is not a requirement to advance to a Companion Dog Excellent title. Scores earned by dogs competing in this class are not eligible for High In Trial. Dogs are eligible to compete in this class indefinitely. Dogs in this class may be handled or exhibited by the owner or any other person. A person may enter more than one dog in this class.

PLEASE NOTE: The word ‘trainer’ means any person who conducts or has conducted a dog obedience training class or who regularly assists with the training of dogs in said class or who regularly trains dogs belonging to any person outside his/her immediate family

NO DOG MAY BE ENTERED IN BOTH NOVICE “A” & NOVICE “B” AT SAME TRIAL

NO DOG MAY BE ENTERED IN BOTH OPEN “A” & OPEN “B” AT SAME TRIAL

NOVICE “A” - This class is open to all dogs, providing the dog has not earned the title of “CD” in ANY COUNTRY. The dog does not have to be CKC or ERN Reg’d to compete in this class. **One dog ONLY may be entered in this class by any one exhibitor.** The exhibitor **MUST BE THE OWNER** or **A MEMBER OF HIS/HER IMMEDIATE FAMILY** and **MUST SHOW THE DOG IN ALL EXERCISES.** No licensed handler, trainer or any person who has previously exhibited a dog through its “UD” title in Canada or Elsewhere shall be allowed to compete in this class, but **MUST COMPETE IN THE NOVICE “B” CLASS**

NOVICE “B” - This class is open to all dogs that have not earned the title of “CD” in Canada. Dogs in this class may be shown by the owner or any other person. The dog does not have to be CKC or ERN Reg’d to compete in this class

OPEN “A” - This class is open to all dogs which have earned the title of “CD” IN CANADA, but have not earned the title of “CDX” in any country. **One dog ONLY may be entered in this class by any one exhibitor.** The exhibitor **MUST BE THE OWNER** or **A MEMBER OF HIS/HER IMMEDIATE FAMILY** and **MUST SHOW THE DOG IN ALL EXERCISES.** No licensed handler, trainer or any person who has previously exhibited a dog through its “UD” title in Canada or Elsewhere shall be allowed to compete, but **MUST COMPETE IN THE OPEN “B” CLASS.** A CKC or ERN Reg’d number must be provided on the entry form at time of closing of entries to be eligible to compete in this class

OPEN “B” - This class is open to all dogs that have earned the title of “CD” in CANADA, and may be shown by the owner or any other person. This dog **MAY ALSO COMPETE IN THE UTILITY CLASS.** A CKC or ERN Reg’d number must be provided on the entry form at time of closing of entries to be eligible to compete in this class

UTILITY CLASS ‘A’ - This class is open to any dog of any recognized or listed breed which has earned the title of “CDX” but has not earned the title of U.D. Any person who has trained or exhibited a dog that has earned a M.O.T.Ch title may not handle dogs in this class. This dog must be shown by the owner or a member of their immediate families. A CKC or ERN Reg’d number must be provided on the entry form at time of closing of entries to be eligible to compete in this class. Owners may enter More than one dog in this class. The same

person must handle the dog in all exercises. When a dog is wrongfully entered in this class, any score will be cancelled.

UTILITY CLASS 'B' - This class is open to any dog of any recognized or listed breed which has earned the title of "CDX" or U.D. Dogs in this class may be handled by the owner or any other person. A CKC or ERN Reg'd number must be provided on the entry form at time of closing of entries to be eligible to compete in this class. Owners may enter more than one dog in this class. The same person must handle the dog in all exercises. No dog may be entered in both the Utility A and Utility B classes at any one trial. Prior to the start of judging, the judge will decide the order of exercises to be performed. This order will not be disclosed to exhibitors until it is posted at ringside, approx. 30 mins. Prior to the start of the class.

CONFORMATION CLASSES

JUNIOR PUPPY CLASS - This class shall be for any dog **6 months of age and under 9 months of age** on the day of the show

12 to 18 MONTH CLASS- This class shall be for any dog **12 months but under 18 months of age** on the day of the show

CANADIAN BRED CLASS - This class shall be for any dog born in Canada. (Champions of any country excluded)

BRED BY EXHIBITOR CLASS - This class shall be for any dog owned and handled in the ring by owner/breeder. The handler **MUST** be the owner/co-owner **AND** breeder/co-breeder of the dog. The owner/breeder must handle the dog at the class level, but need not handle the dog for further awards

OPEN CLASS - This class shall be for all dogs

SPECIALS ONLY CLASS - This class shall be for any dog that has a recorded CKC Registration or Event Registration Number and has attained the required points for Championship status. **Note: A Listed dog MAY be moved to the Specials Only Class after the closing of entries, provided the CKC Individual or Event Registration Number was received prior to the first day of the show. The request to move a class dog to the Specials Only Class MUST be received by the Show Secretary ONE HOUR PRIOR TO THE OPENING OF THE SHOW ON THE DAY CONCERNED. Listing Fees WILL NOT be refunded**

EXHIBITION ONLY - All dogs entered in this class shall be listed in the catalogue with the same particulars as dogs entered in regular competition. Dogs entered in this class **MAY NOT COMPETE** in any Regular class but may enter and compete in Non-Regular classes and/or Parades ONLY

I have exported many dogs to numerous countries and they have dominated the breed scene for many years in Australia where they have been the foundation behind many successful kennels. In recent years my keen and enthusiastic friend joined the Kennel Name and we have continued to have great success, the most noteworthy being that of breeding Canada's **Top Dog All Breeds** one year.*

RULES GOVERNING THESE SHOWS AND TRIALS

1. THE CLUB RESERVES THE RIGHT TO REMOVE ANY PERSON FROM THE SHOW. THE SHOW SUPERINTENDENT SHALL HAVE FULL CONTROL OF THESE SHOWS AND TRIALS, WHICH WILL BE GOVERNED BY CKC RULES.
2. ANY DOG EXCUSED BY THE SHOW SUPERINTENDENT OR VETERINARIAN FOR ANY REASON SHALL NOT, COMPETE IN ANY CLASS FOR ANY AWARDS FOR THE BALANCE OF THE SHOW.
3. THE SHOW COMMITTEE WILL USE DUE CARE AND DILIGENCE FOR THE WELFARE OF DOGS AND EXHIBITORS, BUT WILL NOT BE RESPONSIBLE FOR, OR ASSUME ANY LIABILITY IN THE EVENT OF ACCIDENT OR MISFORTUNE TO EITHER DOGS, EXHIBITORS, SPECTATORS OR VENDORS.
4. DOGS MUST BE ON THE GROUNDS 1 HOUR PRIOR TO THE JUDGING OF THEIR BREED.
5. THE OWNER OF A DOG ENTERED IN THESE SHOWS IS ENTIRELY RESPONSIBLE FOR ANY ERROR IN ENTERING HIS/HER DOG REGARDLESS OF HOW OR BY WHOM ENTRY WAS MADE.
6. EXHIBITORS AND HANDLERS WILL BE RESPONSIBLE FOR THEIR DOGS AND EQUIPMENT LEFT AT THE SHOW GROUNDS.
7. DOGS ARE TO BE EXERCISED IN DESIGNATED AREAS ONLY, NOT IN VICINITY OF SHOW RINGS
8. ALL RECREATIONAL UNITS WILL HAVE BUCKETS UNDERNEATH FOR THEIR SINK DRAINS. ANYONE FOUND DISCHARGING WATER ON THE GROUNDS WILL BE REMOVED BY ORDER OF THE HEALTH DEPARTMENT, AND MAY BE SUBJECT TO A FINE.
9. IF, BECAUSE OF CIVIL DISTURBANCE OR OTHER ACTS BEYOND THE CONTROL OF THE CLUB, IT IS IMPOSSIBLE TO OPEN OR COMPLETE THE SHOW, NO REFUND OF ENTRY.
10. DOGS MUST BE ON LEASH AT ALL TIMES ON THE SHOW GROUNDS OR WITHIN THE SHOW BUILDING WITH THE EXCEPTION OF THE OBEDIENCE RINGS.

ALL EXHIBITORS, HANDLERS AND PATRONS ARE EXPECTED TO KNOW AND ABIDE BY THE CKC DOG SHOW RULES

CHAMPIONS AND CHAMPIONSHIP POINTS

SECTION #1. A dog awarded WINNERS at a Championship show held under these Dog Show Rules shall be credited with a number of championship points (ranging from 0 to 5), and the determination of the number of championship points to be credited to a dog awarded WINNERS shall be as provided hereunder.

SECTION #2. The schedule to be employed in the determination of the number of points to be allocated a dog awarded WINNERS shall be as follows;

DOGS COMPETING*	1	2	3 to 5	6 to 9	10 to 12	13 or more
POINTS AWARDED	0	1	2	3	4	5

*includes the dog awarded Winners

To determine the number of points earned by a dog awarded Winners, total all dogs in competition which were defeated, directly or indirectly, for the highest of the following official breed awards: Winners, Best of Winners, Best of Breed or Best Opposite Sex and then consult the schedule set forth above. The point system provides for additional points if a class dog awarded Best of Breed also places in the group as listed below;

A class dog awarded Best in Show at an all-breed Championship show will be credited with 5 points inclusive of any points earned at the breed or group level. In counting the number of eligible dogs in competition, a dog that is disqualified or that is dismissed, excused or ordered from the ring by the judge, shall NOT be included (*effective immediately*) in the calculation for championship points (Absentees are not to be included). In order for a dog to be recognized as a Canadian Champion it must: (1) earn at least ten championship points under at least three different judges; and (2) be individually registered in the records of the CKC or have a CKC Event Registration Number (ERN)

EXTRACTS FROM CKC DOG SHOW RULES

CHAPTER 4.1.3 - JUDGES

A judge officiating at a show held under these rules shall not be subjected to any indignities of any kind during the progress of the show, and it shall be the duty and obligation of the club holding the show to see this rule is effectively enforced.

8 - ENTRIES and ENTRY FEES

Section 3.1

Every dog entered in Championship Shows held under these rules must be registered, have an Event Registration Number, eligible for registration with the CKC or have a CKC Miscellaneous Class Certification number issued by the CKC Chief Registrar. If a dog is not registered individually in the CKC it may be entered at a show, held under these rules, as a "listed" dog, provided

(a) it is not a Miscellaneous breed

(b) if born in Canada, is eligible for individual registration

(c) if foreign born and owned, an Event Registration Number or CKC registration number is obtained from the CKC within 30 days of the first show entered.

A listing fee of \$8.822 must accompany the entry of a "listed" dog at a show held under these rules.

Section 2.3:

INCOMPLETE ENTRIES

Entry forms which are incomplete or those that contain incorrect information after the closing date of entries will be void and under no circumstances can changes be made. Any dog taking a win resulting from such an entry will result in the wins being canceled, and persons making such changes will be subject to disciplinary action.

Section 8.2:

DISHONORED CHEQUES

Tendering of a dishonored cheque or credit card in payment of entry fees shall be considered non-payment of entry fees and is an offense punishable by disciplinary action and cancellation of awards. Clubs may refuse to accept entries from any exhibitors who have been known to tender dishonored cheques in payment of entry fees unless such entries are accompanied by a money order or certified cheque.

CHAPTER 14 - DISQUALIFICATION

Section 1.4

A dog once disqualified for any reason at a Championship show held under these rules cannot again be shown or entered at a show held under these rules unless and until said dog has been reinstated by the CKC. All awards earned by a dog shown in violation of this section will be canceled by the CKC and the owner of said dog is subject to disciplinary action. Note: for any further information on reinstatement refer to Chapter 16, Section 3 of the CKC Dog Show Rules

CHAPTER 9 - EXHIBITORS and THEIR DOGS

A show-giving club will be held responsible during the show for the conduct of exhibitors and spectators. Any person acting in an abusive or objectionable manner must be removed from the show on complaint to the Show Superintendent.
