RUNNING ORDER: Will be determined by draw, and if necessary adjustments will made to the running order by the judges to accommodate handlers who are running more than one dog in any one stake.

TCN FEE: \$11.50 (including GST) per dog is required for a dog not listed with the CKC.

BITCHES: Bitches in season may not run. Entry fees will be refunded.

CKC ROSETTES: Rosettes will be awarded to all qualifiers

It shall be the duty and obligation of the event giving club to see that a judge, club official, volunteer, or any participant at the hunt test held under these regulations, is not subject to any indignities. The Hunt Test Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.
