Introducing Our Judges

RICK GSCHWENDER

Rick Gschwender has been active in the dog show world since 1979, first with Rombo Bouviers and later under Rendezvous Bouviers when he married Debra in 1989. He has produced National Specialty winners and multiple Group winners.

Mr. Gschwender is retired. He was employed with Ford Motor Company for over 39 years.

Mr. Gschwender is approved to judge the Herding Group, the Working Group, the Sporting Group, Non-Sporting Group, and Best in Show. He has had the honor of judging the Bouvier des Flandres National Specialty, Best of Breed at the Australian Shepherd National Specialty and Westminster Kennel Club, judging both Herding and Working breeds and the Herding Group in 2006.

Mr. Gschwender lives in Nampa, Idaho with his wife Debbie, one Bouvier des Flandres, one German

Shorthair Pointer, one Anatolian Shepherd and two horses. (Rick Gschwender is also judging the Bouvier des Flandres Club of Alberta Specialty at this show).

DIANNE IVEY

"I have been involved in breeding and showing dogs since 1982. I have bred, along with my husband Ray, under the Maralinga prefix which is permanently registered with the CKC. We have bred or owned a number of Australian Terrier Champions, one of which was BIS Ch. Maralinga's Magic in Motion. Magic holds the record in Canada for 5 all-breed Bests in Show for an Australian Terrier. Magic was the top Australian Terrier in Canada for 1986, 1987, 1988 and 1989. During the period of time we bred Australian Terriers they placed consistently in the top five in Canada."

In 1990 we became interested in the Norwich Terrier. Our very first Norwich came from Denmark and that was the beginning of our love affair with the Norwich. Since then, we have bred or owned numerous Norwich Champions and have been in the top five Norwich in Canada consistently.

We have put a Tracking Dog Excellent title on one of our male Norwich Terriers. That was a great thrill for us. We also did obedience for a short while and put a CDX on an Australian Terrier.

I was a founding member of the Southwest Saskatchewan Kennel Club; a past member of the Alberta Kennel Club; a past member of the Australian Terrier Club of America; a past member of the Southern Alberta Canine Judges Study Group; a past member of the Norwich Club of England; and a past member of the B.C. Okanagan Canine Judges Study Group (a regional CDJA Study Group which now no longer operates in our area); a past member of the Vernon and District Kennel Club; and a past member and treasurer of the North Okanagan Tracking Club. Currently I am a member of the Canadian Dog Judges Association and a lifetime member of the Canadian Kennel Club.

I have judged in Scandinavia, Canada and the USA. I am licensed to judge all breeds and I'm on permit for the Hound Group.

We always bred to satisfy the challenges of both breed type and health while keeping the original purpose of the breed in the forefront of our breeding decisions. We retired from breeding in 2014. I concentrate solely on Conformation judging since 2014."

(Dianne Ivey is also judging the separate All-Terrier event as this show).

MARGARET JONES

I am a retired Health Care Administrator who has been showing and training dogs since 1965, when I obtained my first Irish Setter. Since then my husband and I have shared our home with Irish Setters, Cairn Terriers, Boxers and a number of different breeds including Doberman Pinschers, a Great Dane, Afghan Hound and a Tibetan Mastiff.

We raised and bred Irish Setters, Boxers and Cairn Terriers under the Kian Prefix and exhibited them to Group, Specialty and Best in Show wins. I have also gained many Obedience titles with our Irish Setters, Boxers and Cairns.

I am an All breed Judge and have been privileged to judge at All Breed and Specialty shows in Asia, Australia, Europe, South Africa, South America, U.K., Canada and USA.

I am a Life member of the Canadian Kennel Club and served as a Director of the Canadian Kennel Club Board from 2003-2011. During that time I served on several Committees and Co-Chaired the CKC Charity Dog Show for several years.

I am Past President of the Canadian Dog Judges Association.

I am still actively involved with local and National Breed Clubs. (Margaret Jones is also judging the American Cocker Spaniel Club of Canada Regional Specialty and the Toy Dog Club of Alberta 40th Anniversary Specialty at this show).

JANICE LEACH

We have been so lucky to have had German Shepherd Dogs in our lives since 1977. They are our constant companions and have been everywhere with us. In 1978 I showed our first GSD in Conformation and was introduced to the "dog world". In 1986 I bred my first of four litters under my CKC reg'd kennel name "Longpine", producing my first Champion. I had great fun showing her to her championship and by that time I was "addicted". I then decided to try my hand at Obedience with her and was "hooked".

There have been many highs and lows along the way but one of the most exciting things for me was showing my homebred bitch Ch/OTCh Longpine's Goin'a Different Road (Can/Am Ch DeBrut's Different Drummer UDX, NA x Ch/OTCh Longpine's K.O. Cody) to a Best in Show under the late Quentin LaHam.

On the Obedience side, Sabre (MOTCh DeBrut Longpine OnTheWarpath, AKC UD, RA) has given me the greatest thrills, winning multi High in Trials from the Novice, Open & Utility classes as well as two "Dog World" awards". In consecutive years, along the way to his AKC UD, Sabre managed to win the Open A & Utility A classes at the German Shepherd Dog Club of America National Specialty. That same year he won the UA class he was the only GSD to qualify in Novice A Jumpers Agility - in spite of his handler. In 2005 he was number two GSD and one of the top ten Herding dogs in Canada.

My latest OTCh was Jinks (Ch DeBrut n'Longpine's Hat Trick UD, RE, AKC GO and RE) She was so special !!!

I am currently training Mica (Longpine's Mica z Sotto for the Obedience ring. I could not have had all this fun with my dogs without the unending support of my husband, Wayne and his love for the dogs.

I belong to the Fort Garry Kennel Club, am a founding member of the Kenora & District Dog Club and have belonged to the German Shepherd Dog Club of America for the past 44 years as well as a life member of the CKC.

I am licensed to judge CKC, AKC & ASCA Obedience & CKC & AKC Rally. I love judging and try very hard to make the obedience and rally rings a very comfortable place for the exhibitor to be! (Jan Leach is also judging the Doberman Pinscher Club of Canada Obedience & Rally Trials at this show).

LESLIE MARSHALL

Leslie has been training dogs since 1986. She started in obedience, and then branched out to other dog sports as well. She competes with her Miniature Schnauzers in conformation, obedience, rally, agility, Barn Hunt and Scent Detection.

Her dogs have won numerous regional agility championships, and placed in a number of National championships as well, over the years. They have ranked nationally in obedience as well as rally.

An obedience and rally judge since 2008, Leslie has also judged in the USA as well as Bermuda.

Leslie maintains her status as Registered Veterinary Technician, working on occasion in clinical practice. As The Puppy Tutor, she offers virtual training to families with young dogs. At Agility World in Acton, she teaches classes in both agility and obedience, with a focus on skills for all performance sports.

DIANA MacKENZIE

All of my life I can remember having a dog in the house. In 1978 I got my first German Shepherd Dog, Max, and fell in love with the breed and discovered dog training. Even though he was not registered I trained him through to the Utility level within the club I trained with. Since Max, all my dogs have been registered purebred German Shepherd Dogs.

I joined the Hamilton Dog Obedience Club in 1979, became a life member in 1999, and continue to train and teach with them. I was fortunate to belong to a club with many obedience judges as members; the late Howard Ward and Freda Walls among them, who became good friends and mentors that encouraged and helped me to become an obedience trial judge. I earned my CKC obedience trial judges license in 2002 and started judging in the U.S. in 2008. I am a Long Service CKC member having joined in 1994 and currently serve the club as the Zone 7 Obedience Representative.

My first official OTCH was Icicle's Kieferhaus Falco. My next was MOTCH Eves This One's For You "Stryder". Over his career Stryder earned #1 GSD in obedience in Canada in both 2008 and 2009, was the GSDCC Inc. National Specialty Obedience Victor both those years and in 2009 also earned #7 on the top 10 all-breed obedience dogs in Canada.

My current dog is Azka's Dreams of Greatness "Ranger"; he has already earned multiple high in trials while earning his CD, in 2021 in rally obedience he also attained #2 GSD, #5 in the herding group and #12 all breed. We hope to earn his Rally Champion title shortly.

I reside in Hamilton Ontario with my husband Ken.

After acquiring my first Siberian Husky in 1972, the first litter of Atim Perm Reg'd was whelped in 1975. My direction in this breed became sled dog racing and the education in structure and commitment to form and function followed. I continued in the conformation ring and finished many champions that also competed in competitive racing teams.

In 1985 I added a Belgian Tervuren bitch to our household. Over the next 10 years the beauty, trainability and loyalty of the Belgian Shepherd became my focus. My breeding program with a small Tervuren kennel has produced National Specialty winners in the US and Canada, all-breed BIS winners, numerous Canadian and American conformation champions, HIT obedience dogs, agility title holders and Herding Trial winners.

Not to be forgotten was my interest in Pomeranians and I have had several that completed their championships and lived out their lives as my valued companions.

While not breeding I am still active with my current Belgian in tracking and mentoring my breed. (Susan Quesnel is also judging the Belgian Shepherd Specialty at this show).

NANCY SIMMONS

Nancy Simmons has exhibited her dogs in both conformation and obedience over the years with Great Danes, a Golden Retriever, and more recently Doberman Pinschers. She applied for AKC approval in 1993 to judge Great Danes and Junior Showmanship. Currently, she is approved to judge the Working group, Herding group, Sporting group, Non-Sporting group, Toy group, and two Hounds. I grew up surrounded by horses and dogs in a family very much dedicated to the careful and sound breeding of beautiful, healthy animals, the example of which has become an integral part of my life as a Borzoi breeder.

My first Borzoi arrived in 1976 and Jantar Borzoi perm regd was established in 1980. Through the years, there have been many significant winning and top-producing Jantar Borzoi and now, as I look through pedigrees world-wide, it is both humbling and awe-inspiring to see the impact these Borzoi have had on the breed. It is the responsibility of the exhibitor to be familiar with the Conformation, Obedience & Rally rules as set out by the Canadian Kennel Club

CONFORMATION

The following CKC conformation classes (divided by sex) will be offered:

Junior Puppy: for dogs 6 mths of age but under 9 mths of age.

Senior Puppy: for dogs 9 mths of age but under 12 mths of age

12-18 Months: for dogs 12 mths of age and under 18 mths of age

Canadian Bred: for dogs born in Canada; champions in any country excluded.

Bred by Exhibitor: for dogs owned and handled in the ring by the breeder.

Open: for all dogs.

Specials Only: dogs which are registered individually in the records of the Canadian Kennel Club and have attained championship status may be entered in the 'Specials Only' class. Exhibition Only: for all dogs over 6 mths of age and eligible for registration with the CKC (non-competitive class). **Veterans:** offered Saturday only. Veterans will be divided Males and Females with a Best of Breed judged for each. The Best of Breed winner will go on to Best Veteran in Group and Best Veteran in Show. Dogs must be 7 years or older on the day of the show.

Baby Puppy (4-6 Mths): offered Friday, Saturday, Sunday only. For dogs 4 mths of age & under 6 mths of age – dogs will compete in this unofficial class for Best Male/Best Female, Best Baby Puppy in Breed, Group & Show. They do not compete for Winners.

OBEDIENCE

Pre-Novice: for any dog of any recognized or listed breed, mixed breed or unrecognized breed that has not earned the title PCD (Pre Companion Dog) title in Canada. Only dogs that have NOT earned the CD title may enter Pre-Novice.

Novice A: for any dog of any recognized or listed breed, mixed breed or unrecognized breed that has not won the title of CD. Only one dog may be entered in this class by any one exhibitor. The handler in this class must be the owner, co-owner or a member of their immediate families. Novice B: for any dog of any recognized or listed breed, mixed breed or unrecognized breed has not won the title of CD. Dogs in this class may be handled by any person. More than one dog may be entered by any handler, but each dog must have a separate handler for the 'sit' and 'down' exercise. Novice C: for any dog of any recognized or listed breed, mixed breed or unrecognized breed has gained a CD or any higher obedience titles. Novice Novice Intermediate: for any dog of any recognized or listed breed, mixed breed or unrecognized breed that has earned a CD or higher obedience title. Dogs may compete in the Novice Intermediate class indefinitely. Scores earned by dogs competing in this class are NOT eligible for High in Trial. Open HA & 18A: for any dog of any recognized or listed breed, mixed breed or unrecognized breed that has won the title of CD but has not won the title of CDX. The handler of any dog in these classes must be the owner, co-owner or a member of their immediate families. Only one dog may be entered in this class by any one exhibitor.

Open HB & 18É: for any dog of any recognized or listed breed, mixed breed or unrecognized breed that has won the title of CD and any dog that has earned the CDX or any higher obedience titles may enter either of the Open B classes. A dog may also be entered in the Utility class in the same trial. Dogs in this class may be handled by any person.

Utility A: for any dog of any recognized or listed breed, mixed breed or unrecognized breed that has won the title of CDX but not the UD. The handler of any dog in this class must be the owner, co-owner or a member of their immediate families. Handlers may enter more than one dog in this class. The same person must handle the dog in all exercises.

Utility B: for any dog of any recognized or listed breed, mixed breed or unrecognized breed that has earned the title of CDX or UD. Dogs in this class may be handled by the owner or any other person. Owners may enter more than one dog in this class but the same person must handle the dog in all exercises. No dog may be entered in both the Utility A and Utility B classes at any one trial.

RALLY

Rally Novice A: dogs entered in this class may not have earned a CKC Rally Novice title or any CKC Novice Obedience title other than PCD. **Rally Novice B**: Any dog may compete in this class until a qualifying score in the Rally Advanced Class is earned. No dog may be entered in Rally Novice A and Rally Novice B at any one trial.

Rally Intermediate: for dogs that have earned the RN title. A dog completing the RI or any other obedience or rally titles may continue to compete in this class indefinitely. Dog handled by owner or any other person. A person may enter more than one dog in this class.

Rally Advanced A: for dogs that have earned the RN title but have not won the Rally Advanced title or any CKC Obedience title other than PCD. The handler of any dog in this class must be the owner, co-owner or a member of their immediate families. No handler who has exhibited a dog through its CKC CDX title shall be eligible to enter this class.

Rally Advanced B: for dogs that have earned the RN title. A dog completing the RA title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class.

Rally Excellent A: for dogs that have earned the RA title but have not won the RE title or any CKC Obedience title other than PCD.

Rally Excellent B: for dogs that have earned the RA title. A dog completing the RE title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class.

Rally Master: for dogs that have earned the RE title. A dog completing the RM title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class.

Entry fees will be refunded when a bitch entered in Rally/Obedience comes into season (CKC Rule 6.5) after the close of entries if a

Veterinarian's Certificate (certifying that the bitch was in season within the 10 day period preceding the trial) is delivered to the Show Secretary before the starting date and the time of the trial. The Club will refund entry, recording and listing fees if the above conditions are met. No Refunds will be given for the service fees provided by the dogshow.ca A 50% refund of entry fees only will be made for a bitch in season without a Veterinarian's certificate with written notification presented to the Show Secretary at least ONE HOUR before the start of the Trials for performance events ONLY. The bitch must be available to be examined by the Show Superintendent to verify she is in season.

RULES GOVERNING THESE SHOWS

- 4.1.5 No person may approach a judge either directly or otherwise, orally, in writing or electronically, to favour his entry. Disciplinary action will be taken against any person who violates this rule, or against a judge who fails to report any contravention of this rule to the CKC within 14 days of the action.
- 19.7 It shall be the duty and obligation of the show-giving club to see that a judge, club official, volunteer or any participant at an event held under these rules is not subject to indignities. The Conformation Show Committee Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.
 - Dogs must be kept on a leash at all times on the show grounds or within the show building.
 - The Club reserves the right to remove any person from the show. The Show Superintendent shall have full control of these shows and trials, which will be governed by CKC rules.
 - ANYONE PARKING IN THE FIRE LANES OR OTHER AREAS DESIGNATED AS "OFF LIMITS" WILL BE REMOVED FROM THE SHOW.
 - All recreational units must have buckets underneath for their drains. Those discharging of any water on the grounds will be removed by
 order of the health department and subject to a fine.
 - A judge officiating at this show held under CKC rules shall not be subjected to any indignities of any kind during the progress of the show. (4.7.1)
 - A show-giving club will be held responsible during the show for the conduct of exhibitors and spectators. Any person acting in an abusive or objectionable manner must be removed from the show on complaint to the Show Superintendent (5.1.6)
 - There is to be NO SMOKING in the large show tent, nor entrances to it, and NO SMOKING is allowed in the show building.
 - Dogs must be on the show grounds 1 hour prior to judging of their breed.
 - All vehicles are left on the show grounds at your own risk. No security is provided.
 - No abuse of parking personnel, NACA members or volunteers will be tolerated!!
 - RV's will not be allowed to travel on the show grounds when judging is occurring. Under special circumstances (in case of emergency) the show superintendent will stop the show and parking personnel will assist in the safe removal of vehicle.

In order for a dog to be recognized as a Champion and its owner provided with a Championship certificate, the dog must:

(a) earn at least ten (10) championship points under at least three different judges and.

(b) be individually registered in the records of the CKC or have an Event Registration Number or a Miscellaneous Certification Number.

(c) have earned at least one 2-point win either at the breed or group level.

15.2 GRAND CHAMPION

The title of Grand Champion may be earned after the completion of the CKC conformation championship. Points earned in completing the conformation championship are not included in the Grand Championship.

Section 15.2.3

To be awarded a Grand Champion title, a dog must attain a minimum of 20 points, which must include a minimum of two (2) wins of at least two (2) points each. Points may be gained at breed, group or Best in Show/Specialty level. Only the highest points earned at a single show are carried forward.

a. Grand Champion Point System

Points towards the Grand Champion title are attained at breed level and are awarded to BB, BOS, Select Dog & Select Bitch. Points are

calculated based on the number of animals competing at the breed level for the Best of Breed winner and the number of similar-sex dogs competing for the other three (Best of Opposite, Select Dog, Select Bitch). The following schedule shall be employed in the determination of points awarded at breed level for all levels of GCh.:

b. In order to obtain a Grand Champion title, a dog must obtain at least two (2) points after 12 months of age.

c. In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall not be included in the calculation for Grand Champion points.

15.2.4 GRAND CHAMPION BRONZE (GChB)

The title of Grand Champion Bronze may only be earned after the completion of the CKC conformation title Grand Champion is attained.

- a. Points for this title are only accumulated after the completion of the Grand Championship and do not include the points earned in attaining the Grand championship.
- b. To be awarded a Grand Champion Bronze title, a dog must attain a minimum of 50 points, which must include a minimum of two wins of at least two (2) points each. Points must be gained at breed, group or Best in Show/Specialty level. Only the highest points earned at a single show are carried forward.
- c. Points accumulated prior to July 1, 2021 may be used to attain the GChB title, however, a minimum of five (5) points must be earned after July 1, 2021.

15.2.5 GRAND CHAMPION SILVER (GChS)

- a. The title of Grand Champion Silver may only be earned after the completion of the CKC conformation title Grand Champion Bronze is attained and do not include the points earned in attaining the Grand Championship Bronze.
- b. To be awarded a Grand Champion Silver title, a dog must attain a minimum of 100 points, which must include a minimum of two wins of at least two (2) points each. Points must be gained at breed, group or Best in Show/Specialty level. Only the highest points earned at a single show are carried forward.

15.2.6 GRAND CHAMPION GOLD (GChG)

- a. The title of Grand Champion Gold may only be earned after the completion of the CKC conformation title Grand Champion Silver is attained and do not include the points earned in attaining the Grand Championship Silver.
- To be awarded a Grand Champion Gold title, a dog must attain a minimum of 200 points, which must include a minimum of two wins of at least two (2) points each.
 Points must be gained at breed, group or Best in Show/Specialty level. Only the highest points earned at a single show are carried forward.

15.3 GRAND CHAMPION EXCELLENT (GCh.Ex)

15.3.1 The title of Grand Champion Excellent may only be earned after the completion of the CKC Grand Champion Silver title. Exhibitors will be required to submit to Shows & Trials the Grand Champion Excellent Record Sheet documenting the additional requirements. The Grand Champion Excellent Record Sheet Form is located on the CKC website. the points earned in attaining the Grand Championship Silver.

15.3.2 To earn the title a dog must have earned the following during their career as a Special:

- a. one (1) Best in Show or a Best of Breed at a breed National specialty (where a minimum of 10 dogs have competed).
- b. three (3) Group 1st, or three (3) breed specialty Best of Breed wins.
- c. a CKC performance title from any CKC event. Titles excluded are: CGN, Herding Novice Tested Certificate, all Instinct titles from all events, as well as all Sprinter titles and all Chase Ability Program titles.

15.3.3 Best in Show, Best of Breed at a National Specialty, 3 Group wins, or 3 Specialty Best of Breed wins, must be attained after the completion of a regular championship. The performance Title may be attained at any time in the dog's career.

NOTE:

- 1. Exhibitors are required to complete the Grand Champion Excellent Record Sheet form located on the CKC website and forward it to CKC upon completion of requirements above.
- 2. Grandfathering of the previous version of the Grand Champion Excellent title will be honored up until July 1, 2022.

ENTRY AGREEMENT

I (we) acknowledge that I (we), all exhibitors, handlers and patrons, know and abide by the "CKC Dog Show Rules" and that I am (we are) familiar with their content. I (we) agree that the Northern Alberta Canine Association has the right to refuse this entry for just cause, which the Club shall deem to be sufficient. In consideration of the acceptance of entries made in these all-breed shows, obedience trials, agility trials or any of the associated Specialties, and of the holding of these shows and of the opportunity to have the dog judged and to win prize money, ribbons or trophies, I (we) agree to hold the Northern Alberta Canine Association, associated Specialty Clubs, their members, directors, governors, officers, agents, superintendents, or show secretaries, and the owner or lessor of the premises and any employees of the aforementioned parties, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of a dog while in or upon the show premises or grounds or near any entrance thereto, and I (we) further agree to hold the aforementioned parties harmless from any claim for loss of a dog by disappearance, theft, death or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, theft, damage or injury be caused or alleged to be caused by the negligence of the Club(s) or any of the parties aforementioned, or by the negligence of any other person, or any other cause or causes.

I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves) or on account of damage to property, arising out of or in consequence of my (our) participation in these shows and trials, howsoever such injuries, death or damage to property may be caused and whether or not the same may have been caused and whether or not the same may have alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other person.
