DIRECTIONS TO THE SHOW

From East/Moncton/NS/PEI – Stay on Hwy 1 West through Saint John. Take exit 114 (approx) 8 km after bridge) Grand Bay-Westfield, Fredericton to Highway 7. Drive approximately 6 km and take exit 90. Drive another 7 km – the arena is on the right.

From Fredericton – Take Hwy 7 South towards Saint John. Take exit 80 Grand Bay-Westfield. Turn Left at the end of the ramp, drive to intersection (Flashing amber light) and turn right. Drive approx 6 km – the arena is on the right.

From USA (Calais, ME – St Stephen – Take Hwy 1 East toward Saint John. Take Exit 114 to Hwy 7. Drive approx 6 km and take Exit 90 Grand Bay-Westfield. Drive approx 7 km and the arena is on the left.
